
1995 December 26 "Twin Valley School Burns in 1995 –

An accidental fire destroyed the old portion (south building) for the high school in Twin Valley, December 26, 1995.

Fire fighters worked through the night to control the fire in the 1923 gymnasium, former elementary wing, and the new school addition under construction on the north side of the school, and surrounding homes. People on scene could only watch as flames consumed valuable school property and materials and the home of many memories for the people of Twin Valley.

Fire departments from five local communities assisted with fighting the fire, including Ada. Water was hauled from Ada to Twin Valley as the level in the community's water tower dropped from firefighting efforts.

The following morning the school and surrounding buildings were a mass of ice. Through the day a steady stream of current and past students and the curious, walked and drove past the school to see the destruction and mourn the loss of the old school." "They Came to Watch it Burn -

Citizens of Ada on Saturday, April 14th gathered around what was described as the 'neighborhood eyesore' to bid their final respects to a derelict house that should have been, as one eyewitness stated, 'demolished years ago.' The old home had been vacant for about a year after serving as a temporary residence for many, many migrant laborers.

Neighbor residents claimed that long before the house was unoccupied, it was unfit to live in and posed serious safety risks for the inhabitants. 'We've been trying to get rid of that place for years now,' stated one resident. 'I'm here to watch it lit up!'

Firefighters from Ada, Halstad and Twin Valley set fire to the house for training purposes. Varying degrees of fires were started and later extinguished to simulate the

experience and allow firemen to witness multiple firefighting scenarios. Firemen from the Fargo and Moorhead Fire Departments were present to conduct the training and help oversee the burn.

The finale of the training exercise involved a blitz designed to tackle a total house fire. After many successful extinguishments, the house was finally set fully ablaze. 'I won't miss it,' stated one observer as an entire wall crumbled under the flames. 'Letting the firemen train and all... it's a good way to get rid of it.' Story by Michael Thompson, Writer. 2001 November 12 "Perley-Lee Township Fire & Rescue Squad purchase new defibrillator –

Perley-Lee Township Fire & Rescue Squad has been accepted into the Prudential Helping Hearts Program and has completed its fund drive to purchase a defibrillator unit. The effects of the members of the squad and generosity of individuals and businesses in the community and the Prudential check for \$1,000 have made it possible for the Perley-Lee Township Fire & Rescue Squad to purchase a defibrillator. The cost of the defibrillator was over \$2,000.

The Prudential Helping Hearts Program provides monetary grants to help volunteer emergency medical service (EMS) squads purchase semi-automatic cardiac defibrillators. The purpose, very simply, to save lives. More than 250,000 Americans die from sudden cardiac arrest each year, according to the American Heart Association. Studies indicate that most of the people could be saved if they received prompt treatment from a defibrillator.

Unfortunately, many volunteer EMS squads operate on tight budgets and have not been able to purchase portable defibrillators. The Prudential Helping Hearts Program has helped to address this need.

During a sudden cardiac arrest, abnormal electrical signals can throw the normal heartbeat so far off that the main pumping chamber, the left ventricle, goes into spasmodic contractions called fibrillation. During fibrillation, plenty of electric activity is present in

the heart, but it's totally disorganized. Without organized rhythmic electrical signals, the heart cannot pump blood. A victim of cardiac arrest has little chance of survival after 6 to 8 minutes of fibrillation. The portable defibrillator determines when to jolt the heart with a brief but strong electric current, a process called defibrillation which can shock a chaotically beating heart back into a normal rhythm.

The Prudential Helping Heart Program works by making grants of \$1,000 available to volunteer EMS squads to cover the cost of a new portable defibrillator. Squads must raise the rest of the purchase price themselves, typically through community fund-raising efforts." (Halstad's Valley Journal, November 12, 2001)



The Ada and Borup fire departments, as well as a number of students from Northwest Technical College of Moorhead took advantage of the unseasonable weather to get a little firefighting practice in this past Saturday as a practice burn just north of Borup.

The Ada Fire Department hosted the practice burn, and Chief Steve Petry said the day went real well at the house provided by Kevin Anderson. "We had four instructors here from Northwest Technical College and they brought 17 students along to get in some practice," he said.

The group practiced extinguishing a number of fires upstairs in the homes, with the students practicing Level I, or one room fires upstairs in the house.

Local volunteer firemen practiced on extinguishing Level II burns, which involves fires in numerous rooms in a house.

At the end of the day, the house was set ablaze and Steve said a number of "Blitz Attacks" were practiced in controlling fires from when a building is consumed by fire. The Ada Department had 15 volunteers taking part in the exercise and fire volunteers took part from the Borup Department.

"Three people survive plane crash in Rockwell Township on

2003 January 7 Saturday –

Three local people survived a plane crash in Rockwell Township on Saturday (January 4<sup>th</sup>) evening.

The pilot of the Cessna aircraft, David Resnick, 48, of Twin Valley and his two passengers, Zepher Resnick, age five, and Lowell Miller, 26, of Mentor, were transported to Bridges Medical Center Saturday night for treatment of injuries received in the accident. David Resnick was later transferred to MeritCare Medical Center in Fargo.

The Norman County Sheriff's Department reports a cellular 911 transfer call from the Minnesota State Patrol was received at 8:45 p.m. Saturday reporting the downed plane, with the message that the plane was one mile south of the Ada-Twin Valley airport and that there were three injured people who were walking around at the site.

An off-duty Norman County Deputy responded and located the crash site, which was three miles southeast of the airport, in Section 3 of Rockwell Township.

The Sheriff's office notes the aircraft was traveling north and came in contact with the tops of trees to the south of Norman County Road #33, slid across the county road, and came to rest upside down in a field to the north.

The Federal Aviation Administration arrived on the scene Sunday, January 5, and is continuing their investigation into the cause of the crash. There was light freezing rain at the time of the accident.

The Norman County Ambulance, Twin Valley Rescue Squad, Twin Valley Fire Department, Twin Valley Police, Minnesota State Patrol and Norman Sheriff's Department all responded to the accident scene." (Norman County Index, January 7, 2003)

The court stayed imposition of sentence for 10 years, and placed Johnson on supervised probation. 2003 July 15 "Emergency exercise will be held in Ada July 21 –

Don't be alarmed by the scream of sirens, flashing lights, and smoke in the air in Ada on Monday afternoon, July 21. Emergency vehicles and personnel from around the county will be converging on Ada to take part in an emergency exercise.

Environmental and Emergency Services Officer Kevin Ruud said the Sheriff's Department, Ada Police, Twin Valley Police, and fire departments from Ada, Borup, Halstad, Perley and Twin Valley, as well as the ambulance service and a number of rescue squads will take part in the exercise.

Ruud said the purpose of the emergency exercise is to judge where there may be weak areas in the county's ability to respond to an emergency, as well as strengths. 'An exercise like this is to show what kind of shape you are in. And to learn that, you either have an exercise or a real event. Knock on wood. We haven't had an incident here since the Twin Valley school burned down where we had a large need for mutual aid,' he said.

Kevin said it also provides the individual fire departments, law enforcement and rescue personnel information about where there may be crucial equipment needs.

The cost of the exercise is being covered in part by a state grant.

The equipment and vehicles will stage at the fairgrounds, and will likely begin between 4:00 and 5:00 p.m. on Monday. The emergency exercise will be at the Ada-Borup School, with victims transported to Bridges Medical Services for treatment. The scenario for the upcoming July 21<sup>st</sup> exercise will go like follows: The Ada-Borup School fire alarm goes off and at the same time the sheriff's dispatch center starts receiving calls from people in the school reporting that shots have been fired and there has been an explosion in the school.

Someone has broken into the school in an attempt to steal chemicals from the lab. But the person is caught in the act by a worker in the school. The intruder starts shooting, wounding two people.

The shots result in an explosion in the lab, but the intruder escapes harm. While trying to escape, his route is cut off due to the quick response time from local law enforcement and the intruder has holed up somewhere in the school. Law enforcement goes in after the intruder and an officer is wounded.

The explosion and fire in the chemical lab injured 30 people who were attending an adult education class in an adjoining classroom.

A call also comes to the dispatch that a vehicle has rolled over west of town. It is unknown at this time whether this accident is connected to the events going on in the school.

A debriefing will be held in the 4-H building at the fairgrounds following the exercise with food served to all of those who participated in the exercise." (Norman County Index, July 15, 2003)

2003 July 19 "Emergency exercise was a good learning experience –

Good cooperation between local law enforcement and emergency services were evident in the emergency exercise held this past week in Ada, with local fire departments, rescue squads, ambulance, police and the sheriff's department taking part.

'Everyone thought it was an excellent exercise,' said Environmental and Emergency Services Officer Kevin Ruud. 'We found out areas where things went real well, and also some weaknesses.'

The scenario went like this: The Ada-Borup school fire alarms sounds at the same time the sheriff's dispatch center receives reports of shots fired at the school, as well as an explosion. Someone has broken into the school in an attempt to steal chemicals, but is caught in the act. The intruder starts shooting, injuring people. The shots cause an explosion in the lab, resulting in over 30 people attending a class being hurt by the fire and explosion.

Some of the problems noted were with communication. Ruud said of the need to develop a command post faster, as well as a need to keep better communications between the different agencies. 'The problem was, not everyone knew what was everyone else was doing,' he said.

There were also compliments. Department of Emergency Management program coordinator Mary Hillibrand was impressed with the volunteer fire fighters, who took on the exercise in full turnout gear, including self-contained breathing apparatus. 'She noted that not many of the volunteers always wear full turnout gear during exercises like this,' Ruud said.


The firefighters not only wore the gear, but also really worked, carrying out volunteer victims from the smoke-filled school during a hot afternoon. Many of the victims looked pretty ghastly, thanks to make-up and work by t he ambulance department personnel to create a number of different medical emergencies.

A new machine purchased created billowing smoke (pina colada scented) inside the school. Thermal imagining machines were also used to help find people in the building.

Rescue and ambulance personnel directed to wounded to a triage center in front of the school where they were treated or quickly taken to the hospital emergency room, depending on the seriousness of their injuries.




'It was interesting and a good learning experience,' Ruud said. 'All the feedback I've had has been positive about the exercise.'" (Norman County Index, July 29, 2003)





Halstad firemen carry a victim from the school on a back board during the exercise.




Different colored flags signify the severity of trauma and other conditions at the triage area before victims were transported

I will continue to support and work for grants like these that help support Minnesota's brave firefighters.

2005 July 26 "New fire truck arrives in Perley –

There was a picnic outside the Perley-Lee Township Fire Hall this past Wednesday evening as the local volunteer firemen and first responders celebrated the arrival of their new fire truck.

The Perley-Lee Township Fire Department was awarded a Homeland Security Grant for a new pumper truck approximately a year ago. The grant application was written by Jeff Loe.

'We're really happy to see it arrive,' said Chief Doug Olson last Wednesday, as people were stopping to get a look at the new pumper.

The grant awarded the fire department totaled \$133,000, which left 10%, or about \$8,000 for the City of Perley and Lee Township to come up with to meet the \$148,00 price tag.

Assistant Chief Wayne Radke explained that the grant was specific on the requirements of a Class A Pumper. The new truck can pump 1,250 gallons of water per minute and has 1,000-gallon water capacity. The fire department does have to add some hose and other minor equipment to have the new pumper ready to roll. An add on was a deck gun which will come in handy for fighting grass and other fires.

Bid letting for the new pumper was held back on December 31, 2004. The Department purchased a T-300 Kenworth chassis from Wallworks Truck Center in Fargo, which was then delivered to Elite Power Products in Wisconsin for outfitting.

Doug said they were happy to get the new truck, noting he knew that there are a number of local towns working on similar grants. 'We hope things go as well for them. People were very supportive on our efforts.'

The firemen will be sponsoring their third annual Pancake and Sausage fundraiser on September 11, which Doug noted has been a well-supported event to help raise money to make the new truck a reality." (Norman County Index, July 26, 2005)

He noted that some of the major features will include a pumping capacity of 1,500 gallons a minute, a 1,000-gallon capacity tank, high sides with storage capabilities that would include the department's emergency extraction equipment, operation center, and a five-man enclosed cab.

Petry noted that the cost of the new pumper will likely be in the \$190,000 to \$225,000 range, and will likely take about nine months for preparation and delivery after a bid is awarded. Bids will be opened November 3 at 12:00 noon at City Hall.

Petry noted the need for the additional pumper, besides the city's current aging equipment, is to have the pumping capability to keep a good Insurance Services Office (ISO) rating in the City.

The Ada Fire Department is rated by the ISO. The ISO makes an independent evaluation of many Departments every 10 years or when major changes have occurred. Many fire insurance companies use the ISO rating as one factor in setting the amount of premium that is paid on commercial and public property. Ratings of departments go from a Class I (the best) to Class 10 (unprotected).

Due to insufficient pumping capacity, the ISO indicated that Ada's rating would increase to a seven without making improvements. "With a new pumper we should get back down to a six, and hopefully a five," Petry said of the ISO.

However, a new truck will also mean the need for a building to house it, and Petry requested permission to make a request for proposals for a lease/ purchase arrangement on a new building that could house the fire department, and possibly also the police department. City council members decided that they would like to look at proposed building scenarios first, and are planning later in the month to look at what would be considered."

"New fire truck in Ada should come in the fall of 2006 -2006 January 3

It will be a while before it arrives, but the community of Ada and surrounding townships will have increased fire protection with the purchase of a new pumper truck that has been ordered by the city.

Fire Chief Steve Petry reports that the new pumper truck will be able to pump 1,500 gallons of water per minute and will be equipped with a 1,000-gallon tank. He current truck has the capacity to pump 1,000 gallons of water per minute and is equipped with a 1,250-gallon tank.

The new pumper will also feature a deck or deluge gun and have a foam to every outlet. 'By using foam, we can theoretically cut water use by a third, or use one gallon of water with foam it acts as three gallons of water. And once you put foam on a fire, the chances of a fire rekindling are much, much less,' Steve explained.

The truck will feature a five-man cab, with the SCBAs (air packs) integrated into the seats. Petry explained that this will be a real time-saver when fighting fires. It means the fire fighters can put on gear and be ready to go when they jump out of the truck, instead of having to pull the air packs out of a side compartment.

The five-man command cab is fully enclosed. The pump operator will be inside and it will be quieter so they can hear what's going on. 'The guys will also have a place to get inside and warm up when fighting fires in cold weather. In the summer, the cab is air conditioned, so it will also be a spot to cool off,' he said.

The intention is also to have sufficient storage room to carry the fire department's 'Jaws of Life' extraction equipment, which will replace the older van which currently carries this equipment.

The truck also has an 8,000-kw hydraulic generator to operate power tools, lights and other electrical equipment.

It will also arrive with a ladder hydraulic ladder rack, which allows having a larger water tank on the truck. There will also be room for other firefighting equipment to go with the extraction gear.

The additional pumper provides Ada the added benefit of lowering the Insurance Services Organization (ISO) rating in the community, which should mean lower insurance costs for commercial and business coverage. This rating for firefighting ability in a community is based on the department's pump capacity, training, and other factors, Steve explained.

The new \$236,000 fire truck was purchased from Central States Fire Apparatus of Lyons, South Dakota. 'It will likely be a couple of months before they get the chassis, and hopefully they will get the truck built and we'll have a delivery date around November of 2006,' the Chief said. 

The truck will feature a five-man cab, with the SCBAs (air packs) integrated into the seats. Petry explained that this will be a real time-saver when fighting fires. It means the fire fighters can put on gear and be ready to go when they jump out of the truck, instead of having to pull the air packs out of a side compartment.

The five-man command cab is fully enclosed. The pump operator will be inside and it will be quieter so they can hear what's going on. 'The guys will also have a place to get inside and warm up when fighting fires in cold weather. In the summer, the cab is air conditioned, so it will also be a spot to cool off,' he said.

The new machine has sufficient storage room to carry the fire department's "Jaws of Life" extraction equipment, which will replace the older van which currently carries this equipment.

The truck also has an 8,000-kw hydraulic generator to operate power tools, lights and other electrical equipment.

The truck has lots of compartment space in the firefighting module, thanks to a hydraulic ladder rack, which allows having a larger water tank on the truck and additional space on the sides. The ladders are carried above the tank, and can be lowered by the hydraulic ram when needed. This provides a lot of additional room for other firefighting equipment to go with the extraction gear, with doors that slide up and some gear mounted to roll out shelves.

The additional pumper provides Ada the added benefit of lowering the Insurance Services Organization (ISO) rating in the community, which should mean lower insurance costs for commercial and business coverage. This rating for fire fighting ability in a community is based on the department's pump capacity, training, and other factors, Steve explained. 'The City had to have at least a pump capacity of 3,000 gallons per minute, and with the new truck, and our other two trucks, we will be able to meet that now,' he said. 'We will have to resubmit with ISO and now that we meet the requirements, they will reclassify us.'

The new \$236,000 fire truck was purchased from Central States Fire Apparatus of Lyons, South Dakota.

The new truck is too high to fit in the current fire house, so for the time being, it is being housed out at Public Works. The city is currently looking at the potential of building a new fire hall/ police station adjacent to the current fire house.

Assistant Chief Bruce Visser said that trucks would have to be special ordered to fit into a conventional 10-foot door. However, it wouldn't come with the pumping capacity and options desired.

Petry said the equipment on the new truck is fairly common when fire departments like Ada's are updating equipment. 'They are putting the foamers on, bigger pumps, the enclosed cab, and a 1,000-gallon tank is pretty common. The enclosed command cab is

getting more and more common. The enclosed area also meets the legal requirements,' he said.

In the next few weeks, the decals and Ada Fire Department lettering will be put on the new truck.

The new truck is not is service at this time, but Steve and Bruce said this will happen after they get a chance to do some training with the local fire fighters using the new equipment. They also have to get some new hose for the truck. 'I'd guess sometime in January it will officially be put into service. If we need it now to pump water, it's available,' Steve said.

"City Council awards new emergency services building -

After trimming a few costs, the Ada City Council agreed to award bids for a new emergency-services building last Wednesday. The total cost of bids awarded, with the alternatives approved, totals \$548,022. This was the amount of the bid package after the Council made net cuts of \$10,500 at Wednesday's meeting.

Chief Steve Petry reported that everything appears settled with the townships in the aid association. One township he had not heard from was Spring Creek.

City Council members agreed that it was time to move on the project which will create an improved home for the fire department and new home for the police department. 'I don't think we will ever get a bid package that is better than what we've got,' Councilman Darin Ramey commented. Some of the bigger ticket items the Council removed from the project included two doors and openers, which will result in one door on the south side of the new building and three doors on the north side. The Council also approved removing plans to place matching steel on the exterior of the present fire hall. It was also decided to put a galvanized roof on the new building instead of a colored roof. A fill system was also cut, with fire department personnel noting they can build their own piping system to fill the trucks.

Petry said one item the building committee would like to add back was interior sheeting on the walls, which he noted will make it easier to clean along with improving the appearance.

With the project awarded for construction, the Council will also have to purchase the land east of the present fire hall form the railroad. The Council moved to go forward with the previous offer from the railroad to sell the 26,000 square feet for the asking price of \$26,000." (Norman County Index, April 3, 2007)

2007 May 29 Council approves land an services building –

Council approves land and financing agreement for new emergency

Work should soon begin on the new emergency services building with land and the Cenex building issues addressed last week by the Ada City Council.

'Everyone involved is chomping at the bit to get started.' Mayor Jim Ellefson noted. It was commented that if the start date for contractors extends past the beginning of June, it will likely mean additional costs for the city.

The Labor and Finance Committee met with members of the Cenex board of directors before the Council's special meeting last Wednesday and came up with the deal for Cenex's building on the property where the emergency services building will be built.


Attorney Tom Opheim noted that as a part of the purchase agreement with Burlington Northern, it is required that the City reach an agreement with Cenex, who leased the railroad property where the storage building sets.

The Council agreed to purchase the building from Cenex for \$10,000. Under the agreement, the north 35 feet (approximately) of the building will be demolished. The city then agreed to make the rest of the building suitable for use, and lease it back to Cenex for \$1 per year for two years. After that time, the city will likely demolish the remainder of the building. The Council also agreed to provide space in the northwest industrial park to Cenex (although they did not specify where) for construction of a new storage building. The Council also approved signing the purchase agreement with Burlington Northern for the land, which will total \$26,000 for the 25,000 square feet, plus a \$1,000 fee charged by BN.

Council members also heard that it is not necessary to call for bids for financing the project. The Council moved to go forward with the recommendation of the Finance and Labor Committee to go forward with a \$700,000 lease/ purchase agreement with the Bank of the West to finance the project. The lease/ finance agreement is over 20 years at a fixed interest rate of 4.65%.

The Council also went into closed session to conduct employee evaluations. (Norman County Index, May 29, 2007)
