A Final Offer was presented and approved by candidate Ben Burgener. The contract was presented to council as written by Pemberton Law Office and approved by candidate Ben Burgener.

3. Review a mud jacking proposal for curb and gutter in the City of Ada as recommended by the Public Works committee.

A proposal from the City's Public Works Committee was presented to council for approval. The proposal was to have Mud Jackers LLC do 2,000 feet of work at \$9.00 a foot to improve sunken curb and gutter in the City of Ada. Member Rosenberger stated that there was more than the proposed 2000 feet, but was the amount that was thought necessary to get the main areas taken care of. This topic had been brought up in the past and was thought to be unsuccessful. It was stated by Member Rosenberger that that was done about 15 years ago and that things have improved since that time. Member Opheim asked if a second quote was sought after. Member Rosenberger stated that this company was one of a select group that did this kind of work. Member Opheim recommended that the City approve 500 feet and see how successful it is. This work was to be done by November 10th, 2018.

Motion by Member Opheim, second by Member Rosenberger to approve a 500 foot contract with Mud Jackers LLC at \$9.00 a foot for mud jackling curb and gutter in the City of ada to be completed by November 10, 2018.
