



The Campgrounds are on the Fairgrounds property but are outside of the Event fencing. State Fair Admission tickets will be required of all exhibitors, vendors, concessionaires, and public at all entrance gates of the Fair.

All campers are required to check in at the Campground office, pay any additional camping charges, and receive a final lot location assignment. At check in, campground stickers will be furnished for cars. All vehicles without a sticker will be required to pay a \$5.00 per night charge. The Campground area is fenced with a permanent fence, and a Campground Manager is on duty at all times. The Manager will assign camping locations and will maintain a Campground directory.
