REQUEST FOR PROPOSAL

Official Livestock Photographer – AKSARBEN STOCK SHOW

Aksarben Stock Show (AKSS) is seeking a qualified Livestock Photographer to provide all necessary labor, photo equipment and place for exhibitors to purchase photos for the Aksarben Stock Show.

About the Aksarben Stock Show: The Aksarben Stock Show, is a 14 state, regional, semi-major stock show. Exhibitors aging from 9-19 years of age from Arkansas, Colorado, Illinois, Indiana, Iowa, Kansas, Minnesota, Missouri, Montana, Nebraska, North Dakota, South Dakota, Wisconsin, and Wyoming are eligible to exhibit beef, swine, sheep, goats, and/or broilers. Additionally, we hold a national youth and collegiate livestock judging contest, fitting demonstrations, and a fitting challenge. In 2023, the Aksarben Stock Show will be celebrating its 96th annual event on September 21st – 24th. This 4-day event is jam packed with people and excitement, as these exhibitors compete at the premiere junior stock show in the Midwest.

2.0 OVERALL SCOPE

- 2.1 **Term:** The contract will become effective upon signing through the conclusion of the 2025 Aksarben Stock Show.
- 2.2 **Other Agencies:** Any other agency facilitating business with AKSS, including Fonner Park and its partners, Nebraska State Fair, or the Grand Island Livestock Complex Authority and its partners, shall not be bound by any agreement made as the result of this request for proposal.
- 2.3 **Agreements Made:** AKSS may accept a proposal as written by issuing a written Agreement with the selected production agency. This agreement will be signed by both parties.
- 2.4 **Exceptions:** Any exceptions to any piece of this RFP shall be noted on the Proposal Addendum, Attachment A, and submitted.
- 2.5 **Contracts:** To be executed between AKSS and Photography Agency. All contracts shall be executed by the Aksarben Stock Show Manager.

- 2.6 **Responsible Parties:** AKSS final decisions on all Livestock Photography decisions will remain with the AKSS Manager, Agriculture Director and in cooperation with the Executive Director and upon consultation with Photography Agency.
- 2.7 **Onsite:** This contract will require the chosen agency to have an onsite lead.

3.0 CONDITIONS

- 3.1 Laws: Terms and provisions of this solicitation and any agreement resulting from this shall follow any governing law applicable to this process. Any litigation or actions in connection with this proposal and subsequent award shall be instituted in the appropriate Nebraska courts.
- 3.2 **Assignment:** Any contract resulting from this solicitation may not be assigned, transferred, or delegated in whole or in part by the photographer, without the prior written consent of AKSS.
- 3.3 **Termination:** AKSS may terminate any agreement made as a result of this process at any time that the agency fails to carry out the provisions under the agreed-upon terms.
 - 3.3.1 Upon termination, AKSS shall provide written notice within 10 days of termination. Any monies owed to AKSS shall be due within 30 days of written notice, and vice versa.
- 3.4 **Indemnification:** *AKSS* hereby agrees to indemnify and hold harmless *Awardee*, as well as their agents, representatives, and directors from and against any loss, damage or expense associated with a claim arising out of the negligence of AKSS. *Awardee* hereby agrees to indemnify and hold harmless *AKSS* for any loss, damage or expense associated with a claim arising out of the negligence of the *Awardee*.
- 3.5 **Retention of Rights:** The Awardee shall not have any rights to use the name, logos, trademarks, or copyrights of AKSS outside of the purposes of promotion related to AKSS, without written permission.
 - 3.5.1 AKSS reserves the right to not award this offer to any photography agency based on any reason.

4.0 SCOPE OF WORK

- 4.1 Agency will provide AKSS with staff, equipment, and services for taking Livestock photos during all specified shows and/or events.
- 4.2 Agency shall provide a website to offer photos for Exhibitors to purchase in a timely manner
 - 4.2.1 Provide digital copy at the end of each day of events determined by both parties.
 - 4.2.2 Photos will consist of Backdrop, in ring and hot shot photos inside barn areas.
- 4.3 Agency shall provide photos at no cost to the Aksarben Stock Show for promotional purposes only.
- 4.4 Agency shall provide social media coverage of the event on multiple popular platforms.
- 4.5 Agency will assist AKSS with submitting results to trade publications.
- 4.6 Agency will be responsible for travel for their staff. AKSS will cooperate with making lodging arrangements.
- 4.7 Meals within a reasonable allotment, two meals per day per photography staff member, will be provided for the duration of the livestock shows.
- 4.8 Aksarben Stock Show will provide a room to set up equipment and operate out of.

4.9 Aksarben Stock Show will provide three (3) official photo backdrops for use during the Aksarben Stock Show; two in the Five Points Bank Arena, one in the Aurora Cooperative Pavilion Arena. Included will be shavings, tables, and chairs at each site.
