# **RULES AND REGULATIONS**

#### **Schedule of Events**

The 2021 Aksarben Stock Show<sup>SM</sup> 4-H/FFA Livestock Judging Contest will be held Sunday, September 26, beginning promptly at 8:00 a.m. in the Thompson Arena, Fonner Park, home of the Nebraska State Fair, Grand Island, NE. All contestants are requested to be in the Arena by 7:30 a.m. At the conclusion of viewing/evaluating the classes, reasons will take place at the Heartland Events Center, Fonner Park. The awards presentation will be held in the Bosselman Conference Center following the official's critique on Sunday afternoon.

A coaches meeting will be held Saturday, September 25, at 8:00 p.m. at the Ramada (2503 South Locust St), Grand Island, NE.

# **ENTRY**

Each state is invited to enter up to three (3) 4-H and three (3) FFA livestock judging teams in the youth division of the AKSARBEN livestock judging contest. Teams may consist of three or four members each. The three members with the highest overall scores will make up the team total. However, the contestant with the low score is eligible for individual awards.

Selection of 4-H teams and team members shall be conducted by each individual state extension service in a manner that is consistent with their selection of teams from that state for other national competitions. All contestants must have their selection and eligibility certified by the State 4-H Club or Program Leader. FFA teams must have placed in the Top 3 of their 2021 state's contest that determined the qualifying team for the 2021 National FFA Livestock Evaluation CDE to be held in conjunction with the National FFA Convention this fall. Names and contact information of the State 4-H Leader and/or State FFA leader must accompany online entries for verification of eligibility.

Youth may judge for only one team. Even if a youth has qualified for national competition with a 4-H and with an FFA team, he/she may only be entered as a member of only one team.

If more than three 4-H teams or more than three FFA teams are entered from any state, the contest superintendent will contact the state 4-H extension leader/state FFA organization to determine which teams will be eligible to compete in the Aksarben Livestock Judging Contest.

An entry fee of \$160.00 will be charged for each team (3 or 4 youth) entered. Up to 2 additional alternates per team may be entered to judge (\$40/alternate) as individuals. A fee of \$160.00 per team and \$40 per individual (maximum of two additional indviduals per team) must accompany entry forms. Money received from entry fees is used to defray contest expenses.

Each state that has youth entered in the Aksarben 4-H/FFA Livestock Judging Contest is responsible for medical/accident insurance for those youth while traveling to and from Aksarben as well as during the Aksarben 4-H/FFA Livestock Judging Contest and other events associated with the Aksarben Stock Show.

# CONTESTANTS AND ELIGIBILITY

- 1. Contestants must be bona fide 4-H Club/FFA members certified by the Extension Service/State FFA Office of their respective states.
- 2. To be eligible to participate as a contestant in the Aksarben 4-H/FFA Livestock Judging Contest at the Aksarben Stock Show, an individual:
  - A) Shall NOT have participated in **any** post-secondary (university, college, junior college, or technical school) competitive event of a similar nature and in the same subject matter area. A competitive event is defined here as an event open to more than one educational institution (or its students) in which scores are kept and awards are offered to any or all participants.
- 3. Teams and contestants who have earned the right to represent their state in various national competitions in 2021 or 2022 including, but not limited to, the American Royal 4-H/FFA Livestock Judging Contest (October, 2021), the National Western 4-H/FFA Livestock Judging Contest (January, 2022), National 4-H Livestock Judging Contest during the N.A.I.L.E. (November, 2021) or the National FFA Convention (October 2021) are eligible and encouraged to participate in this contest at the discretion of their individual states.
- 4. College freshmen who have qualified to compete in the 4-H/FFA divisions of the American Royal, National Western, or National 4-H (the NAILE at Louisville) and National FFA Convention Livestock Judging Contests may also compete as an individual in the 4-H/FFA division of the Aksarben Livestock Judging Contest provided they meet previously stated eligibility requirements outlined above. (item 2A)
- 5. State 4-H/FFA Leaders are responsible for determining eligibility of participants in the Aksarben 4-H/FFA Livestock Judging Contest from their respective states.
- 6. Contestants will be subject to disqualification from the contest for rules and regulations infractions.

#### METHOD OF CONDUCT

- 1. Contestants and coaches are permitted to visit the Aksarben Stock Show. However, they are required to stay out of the aisles where the beef cattle, swine, sheep and goats are located. Contestants and coaches are allowed in the stands to watch the shows and/or visit the trade show. Contestants who plan to exhibit at Aksarben must notify the Superintendent for approval and permission, by September 10<sup>th</sup>.
- 2. At the coaches meeting, coaches should be prepared to check names, addresses, and ages of all contestants. Substitutions and roster changes may be conducted at this time, but all alternates must be similarly certified by the individual state 4-H/FFA leaders.
- 3. No contestant shall wear any clothing (including belt buckles), pins, or badges that reveal their identity

- 4. or the state they represent. No hats are to be worn during the contest.
- 5. Contestants will be divided into groups for the contest and will remain with their assigned group throughout the contest. While the contest is in progress, the use of all electronic communication devices (cell phones, smart watches, pagers, PDA's, etc.) is prohibited. There shall be no conferring between contestants, except as directed by the Superintendent or their representatives. Any violation of this rule may result in expulsion and disqualification of the contestant.
- 6. The contest will consist of twelve (12) classes of livestock. Of these (12) classes, (beef, swine, sheep, meat goats). All classes will be comprised of four animals, and the animals will be designated by numbers 1-2-3-4. Classes will be market and breeding. Performance classes may include individual performance or genetic records, and a situation (scenario) statement. Breeding classes may be male or female.
- 7. Reasons are taken on four classes. Contestants must have a CLEAN notebook for taking notes the morning of the contest. This is the contestants' responsibility; notebooks and writing utensils are NOT provided. Contestants' notebooks are subject to inspection at any time, and supplemental materials brought into the contest including pre-written notes/terms will subject the contestant to potential disqualification from the contest.
- 8. The contest will consist of two rounds with six classes each. All classes will be 12 minutes with a two-minute warning.
- 9. Upon conclusion of judging each class, contestants will be asked to turn cards in to their group leader. Cards are to be turned in "face down", and cards will NOT be returned once they have been turned in. Cards will be considered LATE and NOT scored once "time in" has been called on the subsequent class. It is the responsibility of contestants to make sure their card has been turned in on time! Blank or double-marked cards will receive a zero. A photocopy of such cards will be made available to coaches after the contest.
- 10. Questions. 4-H/FFA contestants will answer three sets (10 questions/set) of questions. Questions will be asked of all contestants simultaneously upon conclusion of all judging. Contestants will be given 5 minutes to review their notes before each set of questions. The question reader will read each question twice. Once all questions have been asked, questions will each be reread a third time. Each question is worth 5 points.
- 11. Two minutes will be allowed to give oral reasons to judges.
- 12. Breeding cattle will NOT be handled. Market cattle will NOT be handled. All judging of cattle classes will be from a distance of approximately 15-25 feet. However, contestants will have an opportunity, as announced, for close inspection.
- 13. Breeding sheep and breeding goats will not be handled. Market lambs will be placed in sequential order (1, 2, 3, 4 from left to right, when viewed from behind) in stands. Market lambs will NOT be handled, but they will be removed from the racks and walked so contestants may observe structural and muscle differences on the move. In addition, contestants will have an opportunity for close inspection.
- 14. All coaches and assistants should be available during the morning of the contest to assist with the contest. Job responsibilities will be discussed at the coaches' meeting on Saturday, September 25.

#### **SUPERINTENDENT**

It shall be the duty of the Superintendent to see that all rules and regulations of the contest are carried out. He shall decide all questions which may arise in connection with the interpretation of the rules governing the contest. The Superintendent may assign assistant superintendents and helpers to assist him. The Superintendent will be in charge of all final decisions, results and rankings following tabulation.

# **CLERKS AND ASSISTANTS**

The clerks, assistants and attendants shall be under the direction of the Superintendent and shall carry out all assignments in an orderly manner; and none of them shall confer with a contestant unless directed by the Superintendent.

#### DETERMINATION OF RANKINGS

- 1. Tie Breakers: For individual or team species awards.
  - a. 1<sup>st</sup> tie-breaker, for individual or team species awards reasons. The individual or team with the higher reasons score on that particular species will be listed first.
  - b. 2<sup>nd</sup> tie-breaker, for individual or team species awards questions. The individual or team with the higher questions score on that particular species will be listed first.
  - c. 3<sup>rd</sup> tie-breaker, for individual or team species awards overall total points. The individual or team with the higher overall total points will be listed first.

#### 2. Tie Breakers: Reasons.

- a. 1<sup>st</sup> tie-breaker, for individual or team reasons lower placing score. The individual or team with the lower placing score on reasons classes will be listed first.
- b. 2<sup>nd</sup> tie-breaker, for individual or team reasons questions. The individual or team with the higher total questions score will be listed first.
- c. 3<sup>rd</sup> tie-breaker, for individual or team reasons overall total score. The individual or team with the higher overall total points will be listed first.

### 3. Tie Breakers: Overall.

- a. 1<sup>st</sup> tie-breaker, for individual or team overall awards reasons. The individual or team with the higher total reasons score will be listed first.
- b. 2<sup>nd</sup> tie-breaker, for individual or team overall awards questions. The individual or team with the higher total questions score will be listed first.
- 4. Once results are tabulated and submitted by the Superintendent to the Aksarben Stock Show management results shall be final.
- 5. Team alternates are eligible for individual awards.

#### JUDGES

- 1. A committee of judges shall place all classes and listen to and score all reasons. If the number of teams entered indicates that additional judges are necessary to expedite and make more efficient the hearing and scoring of reasons, the Superintendent shall have the authority to appoint such judges.
- 2. The judges shall place the classes while the contestants are working in the area. The judges shall enter their placings on the placing card, indicate the cuts to be made and file that card with the Superintendent.
