The Aksarben Stock Show is requesting bids for enough t-shirts for over 1,300 exhibitors. There were 1,363 shirts ordered in 2022, which we anticipate more for 2023. Specifications of request -

1. Brand – District Very Important Tee (50% Cotton & 50% Polyester), *this is a must



- 2. Color Red, Black, or White (open to other shirt color option, but whole order must be same color)
- 3. Design we welcome companies submitting proposals to provide a couple of designs for the shirt, which we can provide additional items to draft designs. This is not required.
- 4. There will be two logos placed on the shirt, along with the design on the front. The logos will be one on each sleeve. Price should include a logo on each arm, 1 color, and design on the front center, 3 colors.
- 5. Size the sizes included should be...
 - a. Adult small
 - b. Adult medium
 - c. Adult large
 - d. Adult X-large
 - e. Adult XX-large

- f. Adult XXX-large
- 6. APROXIMATE numbers. The number of shirts per size is an ESTIMATE and is subject to be based on the number of exhibitors. ***based on how the Aksarben Stock Show works, the official totals for the order will not be confirmed until first thing in September 2023. The turnaround time is quick!
 - a. Adult small 685
 - b. Adult medium 400
 - c. Adult large 250
 - d. Adult X-large 100
 - e. Adult XX-large 35
 - f. Adult XXX-large 5
- 7. Deadline to have the t-shirts to the Aksarben Stock Show: Monday September 18th, 2023, by the end of the day. To fulfill the order, we are willing to order a portion prior to the show to help with fulfilling the full order. We will not know the exact TOTAL needs until Exhibitor entries close in the first part of September.

Proposal submissions will be accepted until 5 pm CST, Monday, May 8th, 2023. Upon completion of the evaluation by the selection committee an order may be placed with the selected proposal.
