## Bandera Wranglers 2025 HAM Rodeo Vendor Agreement

- 1. It is agreed that the vendor shall fill out, sign, and return this contract.
- 2. It is agreed that booths shall be rented for the entire show and that the vendor for the duration of the show shall tend booths.
  - a. Vendors may open for business anytime between 8:00 am and end of event on Saturday, March 15, 2025.
  - b. Vendors may close at any time before end of event.
  - c. Vendors may not sublease of booth space. ALL VENDORS SHARING A BOOTH AND SELLING MERCHANDISE MUST SIGN CONTRACT.
  - d. Vendors may not drive vehicles in or out of event perimeter after 9:00 am and the end of the event.
- 3. It is agreed that any objects exhibited by the vendor shall be his/her responsibility at all times, and vendor shall be responsible for his/her safety and bear any loss by reason of theft, breakage, or other casualty.
- 4. It is agreed that the vendor shall comply with any and all requirements of any government authority be it federal, state, or local, and to indemnify and hold harmless the promoters and the show facility owners and all its constituents, from any and all liability due to failure to comply with any regulations.
- 5. It is agreed that the promoters reserve the right to make further rules and regulations and such changes, regarding this event as they deem necessary and proper, and upon notice to vendor all said action should become part of this contract and binding on the parties hereto.
- 6. It is agreed that the vendor shall release the promoters and the show facility owners and all its constituents from any and all liability for damages injury or loss to any person or goods from any cause whatsoever and further agrees to indemnify the promoters from any and all claims for damage, injury or loss.
- 7. It is agreed that violators of these rules may constitute non-participation in future Bandera Wranglers events.
- 8. IT IS AGREED THAT ALL VENDOR SPACE FEES ARE NON-REFUNDABLE after March 1, 2024, to include cancelling or rescheduling of event due to weather or other circumstances beyond control of Bandera Wranglers.
- 9. IT IS AGREED THAT VENDOR SPACE FEES ARE PAYABLE UP FRONT, AND NO FEES SHALL BE COLLECTED ON SITE UNLESS PRIOR ARRANGEMENTS HAVE BEEN MADE.
- 10. Ham Rodeo and the Bandera Wranglers have exclusive right to display, license, sell and merchandise all event novelties (t-shirts, ride pins, etc.). Ham Rodeo and the Bandera Wranglers further has the right to inspect, approve, reject, or otherwise control the display, promotion, sale or other merchandising of products or services by vendors at the event in its sole discretion. Any products or services rejected by Ham Rodeo or the Bandera Wranglers must be immediately removed from the event premises and may be removed by Ham Rodeo or the Bandera Wranglers if this does not occur.
