### BEDFORD COUNTY FAIR GENERAL RULES:

1. All pre-registration will be handled at the fair office in Bedford. Entry forms will be available at the fair office or on the website at [www.bedford-fair.com](http://www.bedford-fair.com) events page. (Please call ahead to confirm hours - 814-623-9011)
2. A driver's license must be presented at the time of registration.
3. No entry fees.
4. **All persons must pay the "Pay One Price" (\$15.00) at the fair entrance gates.** This allows you on the rides and into the exhibits, and on the grandstand. (Driver towing in the demo vehicle will receive free general admission (\$15.00) at fair entrance gate. They will be required to pay the \$10 pit insurance fee at the pit gate.)
5. **Everyone, (including all drivers and children) must pay the \$10.00 Pit Insurance Fee at the pit entrance gate and wear a wristband.** Vehicle hauling demo car will not be charged a parking fee. All must sign the Release and Waiver of Liability and Indemnity Agreement to enter the pit area. Children must have parental supervision and parents must sign the Release and Waiver of Liability and Indemnity Agreement to enter the pit area.
6. The decision of the officials will be final.
7. **NO ALCOHOL OR INTOXICATED PEOPLE IN THE PITS!!** They will be ejected and possibly arrested! Any alcohol will be confiscated!!!
8. Registration will close 30 minutes before start of event. Late entries can only be approved by the presiding judge.
9. **The decision of the officials will be final.**
10. **Anyone that does not abide by the rules of the event or the rules/policies of the Fair, will be ejected from the fairgrounds and barred from future events.**

In consideration for the privilege of participating in the event, I acknowledge and agree that the Bedford County Agricultural Society, d/b/a/ Bedford County Fair ("Operator"), its Directors, Officers, volunteers, affiliates, employees, successors or assigns, shall not be liable for any claims, demands, costs or expenses arising out of any personal injury, property damage, death or loss suffered as a result of my participation in the event. I specifically release, discharge and hold the Operator harmless therefrom. I acknowledge that participation in the event is an inherently risky activity and I agree to assume all risk of any such occurrence. I agree to hold Operator and its Directors, Officers, volunteers, affiliates, employees, successor or assigns, harmless and indemnify them from any loss, liability, damage, claim, action, cost, expense or demands with respect to any injury, death, loss or damage to my person or property.
