Adam brought up to pursue MN Holstein organization for the fair week.

Karen brought up maybe having a puppet show during the fair in the Activity Area.

Meat Raffles at Rollies Fridays at 5:30 on 2/3, 3/17, 4/14 and 5/26.

Rod ordered 12 golf carts at a cost of \$1,925.00 for the fair week. The day pass should be good for 1 entry per day.

Rod motioned and Adam seconded, Ken carried the motion for closing hours the fair week. The North end could close at 9:00. A zone preference was brought up for closing hours. Food vendors by the grandstand could close at 11:00. Vendors by the 4H end want to close earlier, maybe the same time as the barns. Beer gardens, and food vendors would stay open until 11:00. Tuesday, Wednesday and Thursday the fair would close by 11:00 with everyone out by 11:30. Friday and Saturday remain open until 11:30 and everyone out by 12:00.

Mary motioned and Jennifer seconded that the ice arena to close at 9:00. Food vendors on the North end can shut down at 9:30.

He would like to be in charge of the grandstand area.

Steve Schwartz, Travis, Mike, Bud and Julie from the Central Chapter MN Abate were attending. The group is looking for a site to host their biker bash that was currently in Hillman. They are looking for a date of the last weekend in August. Their facebook page is central chapter MN Abate. It would be Thursday, Friday and Saturday, with cleaning up the area on Sunday. Bands, bike games, food vendors, alcohol, RV and tent camping. It would also be open to the public. Campers in attendance were estimated to be 300-400 with about 100 day passes to be purchased. Security would likely be the Sons of Silence and that would be 24/7. Bands would be local, 70's, 80's hard rock music. The group would take care of insurance, sanitation. Bank passes to be \$10, parking for RV's would be \$30 extra, entry fee of \$20 for a day pass or \$40 for the weekend. Prep time would be Wednesday before, and clean up time to be completed by
