## **CONTEST RULES & INFORMATION:**

- Handlers meeting at 9:30am (subject to change) at the Central States Fairgrounds Kjerstad Event Center.
- Course be explained at handlers meeting.
- Entries limited to three dogs per handler with a total limit of 65 dogs. Additional dogs will be placed on a waiting list.
- Entries and run order will be drawn on January 13, 2022. After January 13 refunds are granted only with a signed veterinary certificate.
- Top 16 preliminary dogs will compete in the semi-finals with the top 10 returning for the finals.
- Any handler may qualify three dogs in the semi-finals and three dogs in the finals. Top 10 combined times will advance to the finals.
- At trial check-in handlers receive a wrist band for entry along with one adult companion and two childrens wrist bands if needed. Additional passes are available for purchase at the door.
