Meeting Agenda Monday, March 13, 2023 5:30 p.m.

- 1. Meeting called to Order at 5:30PM by Chairman Eddie Gordon.

2. Public Comment: *

- a. Elliott Lowman Eagle Scout Project to repaint the exterior of the food booth Would like to have it completed by June 1st. There would be no financial burden to fairgrounds. This would be a thank you for meeting at the fairgrounds for the last 3 years.

4. Agency Updates

- a. 4H Update Gena Gibson handed out the 4-H update. Handout is with minutes, but quick overview... MALC has purchased a new chute and scales for the beef. It should be here and in place by Fair. The April 1st beef weigh-in was canceled due to safety and the tagging of steers will go back to the Covid protocol of 2020. Swine weigh-in and Sheep/Goat weigh-in will still go as normal at the fairgrounds.
- b. Rodeo Update Levi Irish
 - Rodeo Contracts- Update from Levi stated he had all contracts except for Ryan and Matt's. It should be here by the next meeting.
 - ii. Action Item: Discussion/Decision on purchasing roping boxes for the arena. Jody made a motion to purchase the 14'x16' Roping boxes for \$6200 with free shipping as we are working with North 40. Gaile seconded the motion. The motion Passed.
