FAIRGROUNDS USE TERMS

1. All open riders **MUST** have **PRIOR** permission from the Fair Office to ride on the grounds. You cannot show up and ride unannounced. Failure to get prior permission and/or you are seen riding on the grounds, you assume a risk of being expelled from the grounds for future riding.
2. Rider fee is **\$10 per person/per session** for Open Riding at the Fairgrounds. Fees must be paid prior to riding to the fair office before being allowed to ride. If after office hours, please use the drop box outside the fair office door for payment and form submission. This includes both 4-H & Open Riders.
3. We the fairgrounds staff **DO NOT** work the arena for open ride sessions.
4. Grounds include the Outdoor Arena and Warm-Up Arena. NO other areas of the Fairgrounds are allowed.
5. Indoor Arena is not allowed for use.
6. This Agreement & Separate Participant Liability Waiver Form **MUST** be received by the Fair Office before any riding on the grounds.
7. You are responsible for cleaning up after yourself and your horse. This includes filling pawed holes, removing manure, trash, or other waste from the Fairgrounds.
8. Never tie horses to trees or fences. No portable stalls or pens are permitted on the grounds.
9. All activities on these grounds are subject to the Equine Activities Immunity Act, Idaho Code Title 6 Chapter 1801-1802.
10. By your presence on these grounds, you have indicated that you have accepted the limits of liability resulting from Equine Activities.
11. This is not a spectator area. All persons on the grounds will be regarded as participants and limited by the Equine Activities Immunity Act.
