## General Information/Registration

The Kids Que is an amateur contest for cooking enthusiasts ages 8-12. The contest is part of the Texana Chili Spill BBQ Cook-Off and will begin at 1:00 p.m. on Saturday, November 12<sup>th</sup>.

Registration opens at 8:00 a.m. on Monday, October 3, 2022, at the LNRA Main Office located at 4631 FM 3131, Edna, TX 77957. This event will be limited to 12 contestants on first-come first-serve basis until the maximum number of contestants is reached.

Prior to the contest, all participants will be required to attend a “Kids Que Cooks meeting” with the parent/guardian, which will cover topics such as fire safety, rules for the event, etc. The Cook’s meeting will be held in front of the main stage on November 12<sup>th</sup> at 12:45 p.m.

## Equipment, Materials & Supplies

On the day of the contest, each participant will be provided the following:

- A pre-lit grill to use during the contest
- A rib-eye steak
- An aluminum pan to use for preparation
- A container to be used for turn-in
- An apron to use during the contest (and keep), food service gloves and a designated preparation area

Participants are encouraged to bring the following items:

- Marinades, spices, sauces
- Cooking utensils, such as tongs, spatula, etc.
- A spray bottle to control flames
- Mixing bowls
- An oven mitt

## Cooking Space

On the day of the contest, each participant will have a cooking space in an area designated as the Kids Que “Cooking Corral”. Each cooking space will include one 8’ rectangular table (to be shared with other participants, 3 kids to a table). After the cooks meeting, participants will receive their drawn steak, table assignment, and may begin setting up their area in the “Cooking Corral”.

## Important Rules

1. Each participant must have a parent (or adult partner) onsite with them during the duration of the Kids Que contest.
2. Parent (or adult partner) may not assist the Participant with preparation and/or cooking. Participant must do the preparation, cooking and presentation. If the Participant is unable to do these functions, they may be too young to participate.
3. Each participant must use the rib-eye steak provided, but may use their own ingredients such as marinades, spices, sauces, etc.
4. The steaks provided may not be marked in any way.
5. A Chili Spill representative will be present to assist with fire safety or other assistance needed by the Participant during the competition other than preparation or cooking of the steak.
6. If participant abandons the pit for any reason other than medical emergency or to use the restroom, participant must notify a Chili Spill representative.
7. Participant must use the container provided to turn in for judging.
8. Judges decisions are final.

## Judging

Judging will be based on appearance, degree of doneness (medium), tenderness/taste and overall impression.

All steaks submitted for judging are to be cooked medium. For this contest medium is interpreted as pink and moist in the center of the ribeye, not red and running. Remember, degree of doneness is one of the very important criteria in the steak judging.

The judges will give verbal comments during the judging to the participants with their critique of the submitted steak. Participants will be given their judging sheet with written comments from the judges immediately following the awards.

## Turn-In

The entry turn-in time is 1:30 p.m. The judging will take place as entries are turned in at the Main Stage. If a participant needs assistance turning in their steak, an LNRA representative will walk the participant to the Main Stage.

## Awards & Awards Presentation

The highest scoring Participant will receive:

Cooks Apron with “Bragging Rights”  
Wooden plaque and a new charcoal cooker

All Participants will receive a Cooks Apron.

The contest awards presentation will take place on Saturday, November 12<sup>h</sup> after the judging at the Main Stage. A list of all places (1-12) will be posted at the Judging Tent following the awards.

## Restrooms

Portable toilets and handwashing stations will be located near the Main Stage and Judging Tent. Indoor restrooms are also located on-site.

## Disposal

Ash, grease and trash must be properly discarded in containers located near the Cooking Corral. A Chili Spill representative will be responsible for discarding the charcoal from the pits provided.

## Refunds
