RULES

- **1.** All entries are subject to General Fair, General Livestock, and General Sales Rules and Regulations.
- 2. Only market animals exhibited and shown at the current Brazoria County Fair and not selected for the Jr Livestock Auction are eligible. No other entries will be accepted.
- 3. Any Exhibitor choosing to enter the Freezer Sale must complete a 2022 Seller Contract and W9. Both must be received in the General Sales Office (next to Fair Office) by 6:30 p.m. on the Tuesday before the Jr. Livestock Auction. Exhibitor's decision will be final. Any exhibitor not deciding by the deadline will forfeit their option to participate.
- **4.** Seller Contract can be found online at www.BCFA.org under the Events, General Sales, Freezer Sale page.
- 5. No animal sold in the Freezer Sale will be allowed to exceed the lowest price paid in the same animal division in the Jr. Livestock Sale during the current Fair. A notice will be posted designating the highest price (MAX bid) allowed for each animal division which will be determined by the prior year's lowest price paid in JLA for that animal division. Once MAX bid has been bid, the item will be marked as sold and removed from the auction. Max bid will work like a Buy It Now feature.
- **6.** The official opening bid for animals will be set by the Brazoria County Fair Association and will be based off the current market prices.
- 7. Exhibitors selling in the Freezer Sale whose animal was **NOT PREVIOUSLY** sent to the processor must pick up their auction disposition paperwork between 6 PM 8 PM on the last Saturday of the Fair.
- **8.** If after slaughter, any animal has been found to be tampered with or altered, the Exhibitor will not receive any auction sale or add-on monies. With buyer approval, those funds will be donated to the BCFA Scholarship fund. Also, the Exhibitor will be barred indefinitely from the Brazoria County Fair and will forever forfeit the right to apply for any BCFA scholarships.

Sellers must submit a stamped and properly addressed "Thank You" letter to buyer and add-on contributors, which must be received at the Fair Office on or before November 30th along with any required paperwork before auction payment will be processed. <u>Fair Office</u> will forward thank you letter to buyer.

Terms of Sale: Payment is due at conclusion of Auction. Cash, Check or Major Credit Card will be accepted. All credit card transactions will be subject to a 3% convenience fee. Credit may be extended to previous buyers or to those who make arrangement with the Fair Office prior to the auction. With prior approval, the buyer will be sent an invoice, which will be due and payable upon receipt. Any invoice not paid within 45 days from date of invoice, will be subject to a recurring monthly 2.5% interest charge.
