Media credentials will be issued at the Brazos Valley Fair Main Office. Credentials will ONLY be issued from 9 a.m.-5 p.m., September 1 – October 9. After this date Media credentials and Media Check-In will be at the Media/Volunteer Gate during normal Fair Hours.

Interviews with show personnel (i.e. Executive Director, President) should be arranged through the marketing office. Rodeo interviews should be arranged no less than 48 hours in advance. **No last minute interviews will be granted.**

**Due to Artist's strict copyright limitations, absolutely no filming will be allowed in the stage area during the concerts.** If you wish to film any part of a star's performance, it must be arranged, in advance, through their management and Fair Staff.

All photographers and/or reporters desiring access to any backstage area must make arrangements through the Marketing/Publicity Office at least 72 hours before the event to be covered. No one is allowed in any backstage area without a representative from the BVFR present. Absolutely no one is allowed in the chute area for safety reasons.

## Procedure for Securing Performer Interviews

Any interviews with performers at the **2021 Brazos Valley Fair & Rodeo** must be dually approved through Fair Management and the performer's management (must email request to receive the list of star contacts to [fiona@brazosvalleyfair.com](mailto:fiona@brazosvalleyfair.com)). After an interview has been arranged by a performer's management, you must notify the BVFR Main office. Notification must be sent via mail, fax or e-mail.
