Event Dates:

Monster Trucks - May 5, 2024

• Monster Trucks is a one-day event and has an average attendance of 14,000 spectators.

Xtreme Bulls - July 17, 2024

Xtreme Bulls is a one-day evening event and has an average attendance of 10,000 spectators.

California Rodeo Salinas (Rodeo) – July 18-19-20-21, 2024

Rodeo is a four-day event, beginning the day after Xtreme Bulls, with evening shows on both Thursday and Friday and afternoon shows on Saturday and Sunday. Combined attendance for these shows is an average of 60,000 spectators.

Xtreme Bulls and Rodeo are back-to-back events, if you are selected as a vendor, you <u>must</u> work all 5 days

- Upon approval, Concessionaire shall provide all required licenses and permits required by law and those required by the
 California State Department of Public Health and the Monterey County Health Department. To apply for a Monterey County
 Health Dept Temporary Food Facility permit: https://www.co.monterey.ca.us/home/showpublisheddocument?id=24906
- **Upon approval**, **Concessionaire shall provide** a Certificate of Insurance <u>with</u> Additional Insured Endorsement that meets all requirements of California Rodeo, Inc. **or** purchase event insurance through California Rodeo, Inc.
- <u>Upon approval, if applicable</u>, Concessionaire shall provide a copy of your valid California Seller's Permit. To register for a California Seller's Permit, please refer to https://www.cdtfa.ca.gov/services/permits-licenses.htm
- <u>Upon Approval</u>, <u>Concessionaire's</u> signed contract, Insurance Certificate <u>with</u> Additional Insured Endorsement, Seller's Permit (if applicable), and full payment will be <u>due no later than one month prior to each event</u>, no exceptions. If the signed contract, Insurance Certificate <u>with</u> Additional Insured Endorsement, Seller's Permit (if applicable) and full payment are not submitted on time, your vendor spot will be given to the next available vendor.

Please provide ALL requested information; any incomplete application will not be considered.

Upon receipt of your application, we will review all provided information (the more info, the better!) **You will only be contacted by Show Management if and when your application is selected.** Unfortunately, we cannot call every applicant who is not approved, you will be placed on a waiting list for available space. You must re-apply each year to be considered.

Food vendor fees are determined on an individual basis depending on the food items to be sold and the vendor requirements for the space size, location and facilities. If your application is approved, you will be notified of all fees and charges that apply to you.

California Rodeo shall have the exclusive right to cancel the event at any time up to the date of the event if the event is materially impacted as a result of COVID-19 restrictions in any way, or for any reason whatsoever.
