



Salinas Sports Complex (SSC) Facility Description and Fees

Room: Exhibition Mall

Capacity: *Includes children*

- Banquet/Dining - 480 Maximum (with chairs & tables) – SUBJECT TO RESTRICTIONS
- Seated only - 600 Maximum (with chairs / no tables) – SUBJECT TO RESTRICTIONS
- Standing only – 600 Maximum (no chairs / no tables) – SUBJECT TO RESTRICTIONS

Facilities includes: Banquet Hall, Kitchen (no stove), ice machine, Bar Area (not stocked) & Restrooms

Facility does not provide: Linen, tableware, glassware, utensils, chafing dishes, bar equipment, decorations, ladders, etc.

Wi-Fi: Not provided, must bring own hot spot

- **Fees will vary depending on number of people expected to attend event.** Based on the maximum capacity of 480 people, the estimated final cost *could be up to* \$6,500.00 to rent the Exhibition Mall (*includes refundable deposit and Security*). All fees and paperwork due no later than two weeks before event date.
- Security contracted by Salinas Sports Complex; fees vary depending on expected number of people.

**Events held in 2026, the fee is \$38.00 per hour, per guard (Subject to change)

**Events held in 2027, the fee is \$38.00 per hour, per guard (Subject to change)

**Overtime rate is \$43.00 per hour, per guard

- \$1,000.00 **non-refundable** reservation fee is required to book the Exhibition Mall and is applied as the first payment.
- **\$600.00 refundable** after the event if there is no damage or breach of contract.
- Rates below are for 8-hour event times only.
- Decorating time is free day of event, to be scheduled by Facility.
- Kitchen includes: Walk-in refrigerator, warmer, sink w/counter space, ice machine and prep tables. There is no stove so please plan accordingly.
- Outside chairs and tables allowed. Fees apply at \$0.50 per chair and \$3.00 per table. SSC staff will not set up or tear down any outside chairs or tables; must be removed same night, at end of event.

Fees: Rooms must be paid, and all documentation submitted at least 14 days prior to your event.

Event Hours: Once under contract, any changes to your scheduled rental hours must be granted in writing at least one week prior to your event. Events must be completed no later than 12:00 AM (Midnight). Your event will have a (1) one-hour move-out period, based on the conclusion time of your event. **An overtime rate of \$200.00 dollars for each additional hour will be assessed as late fees.**

Cancellation of the event may occur and be necessary on either the Renter or Salinas Sports Complex's' part due to a Pandemic, disaster or unnatural act beyond human control. All fees paid will be refunded only in such instances when event is cancelled by Salinas Sports Complex. Renter must notify the General Manager or Facility Coordinator at least thirty (30) calendar days prior to the cancellation of any date or dates covered by the Rental Agreement for the facility or all monies paid will be forfeited within 30 days of event.

Cancellation by Renter - Reservation fees are non-refundable except where Renter gives notice of cancellation to the General Manager/Facility Administrator at least one hundred eighty (180) calendar days or (6) six months prior to the date or dates reserved by the Rental Agreement for the facility/banquet halls. All other monies paid will be refunded except within thirty (30) days of event.

Refundable Deposit: The Refundable deposit will be refunded, less any additional clean-up fees, within 14 days after the event provided there is no breach of contract or damage to the rented facility.

Security: The Salinas Sports Complex will provide Security guards for all events. The Salinas Sports Complex reserves the right to determine the minimum number of security guards for each event. The Security fee for events held in 2026 is \$38.00 per hour, per guard, 2027 events are \$38.00 per hour, per guard, overtime rate is \$43.00 per hour, per guard. May be subject to change per written notice. Security guards will be in place prior to the start of your event. No guests will be allowed on the grounds until Security guards are in place. Security counts the number of people who enter the grounds; once agreed-upon attendance is reached, no one else will be allowed in. NO Exceptions!

Decorating: If the facility is not rented the day before your event, the facility may be open to you, we will notify you if available. Day before setup/decorating times to be determined by Salinas Sports Complex, between the hours of 10am-4pm only. The fee is \$25.00 per hour the day prior to your event and \$200.00 per hour after 4pm. Decorating time is free day of your event, times to be determined by Facility. There will be NO Facility Attendant scheduled during decorating time; rooms left unattended will be at your own risk.

Set up policy: We will set up the hall one time based on your request. If we do not receive a set up plan from you, we will set up the hall in our standard set up. It will be your responsibility to move tables and chairs once the setup is complete. We do not provide any equipment such as mops, brooms, ladders or extension cords, etc. We will not set up or tear down any outside chairs or tables; must be removed at end of event.

NO Bounce/Jump Houses; no outside activity allowed during hall rental events. All people must remain inside the hall during all hours of the event. Children must be supervised by an adult at all times.

Clean Up: You are responsible for the cleanliness of the facility. Facilities used by you must be left in a clean and orderly condition. You are not required to put the tables and chairs away. The clean-up fee will cover standard cleaning. Your supplies, equipment and decorations are to be removed from the building within the (1) one hour move out period. If additional clean-up is required, other than normal maintenance, you will be charged at a rate of \$35.00 per hour per cleaning person.

Catering/Food Service: Rules for catering/food service are subject to change at any time at the discretion of the Salinas Sports Complex. Food and drinks are allowed only in designated areas. All food must be brought in prepared/cooked as there are no stoves or ovens in our kitchens. All events that **sell** food must have appropriate County and Health Department permits and licenses; submit copy of permits and licenses to Rodeo Office during normal business hours. All vendors that sell food must provide a Certificate of Insurance that meets all requirements of California Rodeo, Inc. See office for more information.

Keys: Keys are not issued to rental groups or individuals reserving the Salinas Sports Complex. A Facility Attendant will be available throughout your rental time to assist you.

Insurance: General Liability coverage will be provided for User/Contractor for the duration of the event/contract and shall be included in the rental fee. Coverage shall protect against claims for injuries to persons or damages to property which may arise from or in connection with the performance of the work hereunder and the results of that work by the User/Contractor, his agents, representatives, employees or subcontractors. Coverage does not include Liquor Liability. Coverage does not include Clients' personal property.

Insurance for the Sale of Alcohol: If you plan to sell alcohol at your event and are approved for an ABC Daily License, you will need to complete a Liquor Supplemental Application to be submitted to our Insurance Underwriter for approval. Once approved, there will be an additional cost to you for this policy, based on the information provided in the application.

Alcohol/Concessions: Rules for alcohol service are subject to change at any time at the discretion of the Salinas Sports Complex. All events that **SELL** alcohol are required to obtain all necessary state and local permits for daily liquor licenses, see below. A copy of the license must be submitted to the Rodeo Office during normal business hours prior to your event. You are responsible for the behavior and orderliness of all guests and hosts. Under no circumstances shall minors (persons under the age of 21) be allowed to possess or consume alcohol, under California State Law.

- Alcoholic beverages will not be sold or served at youth-based events, such as Quinceanera's.
- Alcoholic beverages may not be served, sold or consumed within one (1) hour of the end of the event, or beyond 11:00pm, whichever applies.
- All alcohol must be poured into clear cups or glasses - ABC requirement.

To Sell Alcohol: You must visit www.ABC.ca.gov and follow instructions to apply for an ABC Daily License – General License:

- To qualify for a GENERAL license, you must be:
 - An organization formed for a specific charitable or civic purpose
 - A fraternal organization in existence for over five years
 - A religious organization, or
 - A political organization.
 - Complete Daily License Authorization (Form ABC-221)

COVID-19 RESTRICTIONS:

In allowing the Event, the Salinas Sports Complex (Complex) will be required to comply with all applicable laws, regulations, orders, and guidelines required by state and local authorities related to novel coronavirus ("COVID-19") in effect at the time of the Event (collectively "COVID-19 restrictions"). Renter acknowledges that such COVID-19 restrictions could include, without limitation, changes in the length, format, exhibits or activities of the Event, changes in food and beverage service at the Event, the elimination of vendors, exhibits, and limitations on the number of attendees that may attend the Event or requiring that the Event be held without attendees in attendance. Complex shall have the exclusive right to elect to terminate this Agreement with Renter at any time prior to the Event if the Event is materially impacted as a result of COVID-19 restrictions in any way, or for any reason whatsoever, in Complex's sole and absolute discretion. Following such notice: (i) Complex shall immediately refund any Deposit paid to Complex or reschedule the Event; (ii) Complex will have no obligation to provide services for the Event; (iii) if canceled, Renter will have no further obligation to pay any amount to Complex under this Agreement, and (iv) this Agreement shall be terminated and of no further force or effect.

COVID-19 GUIDELINES:

- All Users/Renters of the Premises/Facility will ensure that their event/gathering/meeting will adhere to the State of CA and Monterey County guidelines for the prevention of transmission of communicable diseases, including COVID-19.
- In the event of an outbreak as a result of your event/gathering, you must inform California Rodeo, Inc./Salinas Sports Complex immediately. An outbreak is defined as 4 or more people testing positive within 14 days of the event.
