## RELEASE AND WAIVER OF LIABILITY AGREEMENT

I AM AWARE THAT THE ABOVE-DESCRIBED ACTIVITIES ARE HAZARDOUS ACTIVITIES AND THAT I COULD BE SERIOUSLY INJURED OR EVEN KILLED. I AM VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES WITH KNOWLEDGE OF THE DANGER INVOLVED, AND AGREE TO ASSUME ANY AND ALL RISKS OF BODILY INJURY, DEATH OR PROPERTY DAMAGE, WHETHER THOSE RISKS ARE KNOWN OR UNKNOWN.

As consideration for being permitted by the Posse, the County of Monterey ("the County"), the State of California ("State") and any lessor of the Posse Grounds ("Lessor") to participate in these activities and use the Posse grounds & facilities, I forever release the Posse, the State, the County, the Lessor, any Posse affiliated organization, and their respective directors, officers, employees, volunteers, agents, contractors, and representatives (collectively "Releasee") from any and all actions, claims, or demands that I, my assignees, heirs, distributees, guardians, next of kin, spouse & legal representatives now have or may have in the future, for injury, death, or property damage, related to (i) my participation in these activities, (ii) the negligence or other acts, whether directly connected to these activities or not, and however caused, by any Releasee, or (iii) the condition of the grounds where these activities occur, whether or not I am then participating in the activities. I also agree that I, my assignees, heirs, distributees, guardians, next of kin, spouse and legal representative will not make a claim against, sue or attach the property of any Releasee in connection with any of the matters covered by the foregoing release.

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN MYSELF AND THE POSSE, THE COUNTY, THE STATE AND THE LESSOR, AND SIGN IT OF MY OWN FREE WILL. IF YOU ARE UNDER 18 YEARS OF AGE, YOU AND YOUR PARENT OR LEGAL GUARDIAN MUST SIGN AND INITIAL THIS FORM WHERE INDICATED.
