



Facility Description and Fees ATHLETIC EVENTS ONLY

Stadium (All Areas): Cost TBD – Fee determined by services requested.

Main Field Only: Minimum 2-hour rental - Restroom open, no locker rooms

Nonprofit & Local Schools: \$100 per hour

For Profit: \$120 per hour

Practice Field: Minimum 2-hour rental - No restrooms/no bleachers/no locker rooms on Visitor Side

Nonprofit & Local Schools: \$50 per hour

For Profit: \$60 per hour

Setup/Teardown Time:

- **Day of event** – No charge for entry half hour before event start and half hour after event ends.
- **Day of event** – Additional fees for events that need extra setup/teardown time, \$Hourly rate above.
- **Day before or day after event** \$Hourly rate above.

Capacity: Maximum capacity is 7,000 (includes Home & Visitor sides & Standing Room)

Wi-Fi: Available

Security: Security will be contracted by Salinas Sports Complex. Number of guards/fees vary depending on expected number of people. Security will be required for all adult games and practices. Renter will be responsible for this cost.

**Events held in 2025, the fee is \$37.00 per hour, per guard

**Overtime rate in 2025 is \$42.00 per hour, per guard

AVAILABLE SERVICES:

- PA Sound System \$200 per day
- Video Board Operator \$300 - 3 hour minimum, \$150 thereafter
- Scoreboard Operator \$300 - 3 hour minimum, \$150 thereafter
- Dumpster(s) \$200 per dumpster
- Janitorial \$35 per hour, per janitor
- Lights \$100 per hour (April-October after 8pm / November-March after 5pm)
- Locker Rooms (2) \$200 per day, per locker room
- Ticket Booth \$100 per day
- Main Concession \$200 – per day (Renter Must Clean After Use – Includes BBQ pit)
- Add'l Concessions (2) \$100 per day
- Parking Lots MAIN LOT and/or VIP LOT – Fee will be assessed if charging to park
- Announcers Room \$50 per day (Renter must clean after use)
- Coaches Rooms \$50 per day (Renter must clean after use)
- Radio Room \$50 per day (Renter must clean after use)
- Table Top Microphone \$50 per day
- Wireless Microphone \$50 per day

Fees: Facility fees are determined by services requested. All fees must be paid, and all documentation submitted at least seven (7) days prior to your event.

Event Hours: Events must be completed no later than 12:00 AM (Midnight). Unless otherwise specified, your event will have a (1) one-hour move-out period, based on the conclusion time of your event. **An overtime rate of \$(See above) dollars for each additional hour will be assessed as late fees.**

Security: The Salinas Sports Complex will provide Security guards for all events. The Salinas Sports Complex reserves the right to determine the minimum number of security guards for each event. Security fee for events held in 2025 is \$37.00 per hour per guard, and the overtime rate is \$42.00 per hour per guard. Security guards will be in place prior to the start of your event. No guests will be allowed on the grounds until Security guards are in place. Security counts the number of people who enter the Stadium.

Set up policy: Renter will be assessed setup/teardown fees. Facility fees will apply for events that need day before setup or day after teardown.

NO Bounce/Jump Houses; no outside activity allowed during events. Children must be supervised by an adult at all times.

Dumpsters: Dumpster fees will be assessed if more than five hundred (500) people are expected to attend event. Renter responsible for this cost.

Clean Up: You are responsible for the cleanliness of the facility. Facilities used by you must be left in a clean and orderly condition.

Janitorial: Salinas Sports Complex will provide janitorial services. For event of more than five hundred (500) people, the Complex will hire a female restroom attendant for the duration of the event. Renter responsible for this cost

Parking: Renter shall not charge for parking without the prior written consent of the Salinas Sports Complex. Parking fees will be assessed if Renter charges for parking.

Catering/Food Service: Rules for catering/food service are subject to change at any time at the discretion of the Salinas Sports Complex. Food and drinks are allowed only in designated areas. Events that **sell** food must have appropriate County and Health Department permits and licenses; submit copy of permits and licenses to Rodeo Office during normal business hours. Vendors that **sell** food must provide a Certificate of Insurance that meets all requirements of California Rodeo, Inc. See office for more information.

Insurance: Renter Must Provide a Certificate of General Liability Insurance naming **California Rodeo, Inc. – Rabobank Stadium – 175 Maryal Drive, Salinas, CA 93906** as Additional Insured, certificate **must** include a copy of the Additional Insured Endorsement as referenced in the Description of Operations:

1. The Insured name must be the same as listed on the application.
2. Current policy dates must cover date(s) of event(s).
3. Certificate must meet all requirements, request from Rodeo Office.

Insurance for the Sale of Alcohol: If you plan to sell alcohol at your event and are approved for an ABC Daily License, you will need to provide a certificate of insurance that includes Liquor Liability Coverage in the amount of \$1 Million dollars. If you are unable to provide a certificate you must complete a Liquor Supplemental Application to be submitted to our Insurance Underwriter for approval. Once approved, there will be an additional cost to you for this policy, based on the information provided in the application.

Alcohol/Concessions: Rules for alcohol service are subject to change at any time at the discretion of the Salinas Sports Complex. All events that **SELL** alcohol are required to obtain all necessary state and local permits for daily liquor licenses, see below. A copy of the license must be submitted to the Rodeo Office during normal business hours prior to your event. You are responsible for the behavior and orderliness of all guests and hosts. Under no circumstances shall minors (persons under the age of 21) be allowed to possess or consume alcohol, under California State Law.

- Alcoholic beverages will not be sold or served at youth-based events.
- Alcoholic beverages may not be served, sold or consumed within one (1) hour of the end of the event, or beyond 11:00pm, whichever applies.
- All alcohol must be poured into clear cups or glasses - ABC requirement.

To Sell Alcohol: You must visit www.ABC.ca.gov and follow instructions to apply for an ABC Daily License – General License:

- To qualify for a GENERAL license, you must be:
 - An organization formed for a specific charitable or civic purpose
 - A fraternal organization in existence for over five years
 - A religious organization, or
 - A political organization.
 - Complete Daily License Authorization (Form ABC-221)

Keys: Keys are not issued to rental groups or individuals reserving Rabobank Stadium. A Facility Attendant will be available throughout your rental time to assist you.

Cancellation of the event may occur and be necessary on either the Renter or Salinas Sports Complex's' part due to a Pandemic, disaster or unnatural act beyond human control. All fees paid will be refunded only in such instances when event is cancelled by Salinas Sports Complex. Renter must notify the General Manager or Facility Administrator at least thirty (30) calendar days prior to the cancellation of any date or dates covered by the Rental Agreement for the facility or all monies paid will be forfeited within 30 days of event.

Cancellation by Renter - Reservation fees are non-refundable except where Renter gives notice of cancellation to the General Manager/Facility Administrator at least one hundred eighty (180) calendar days or (6) six months prior to the date or dates reserved by the Rental Agreement for the Facility. All other monies paid will be refunded except within thirty (30) days of event.

Refundable Deposit: If applicable, the refundable deposit will be refunded, less additional clean-up fees, within 14 days after the event provided there is no breach of contract or damage to the rented facility.

COVID-19 RESTRICTIONS:

In allowing the Event, the Salinas Sports Complex (Complex) will be required to comply with all applicable laws, regulations, orders, and guidelines required by state and local authorities related to novel coronavirus ("COVID-19") in effect at the time of the Event (collectively "COVID-19 restrictions"). Renter acknowledges that such COVID-19 restrictions could include, without limitation, changes in the length, format, exhibits or activities of the Event, changes in food and beverage service at the Event, the elimination of vendors, exhibits, and limitations on the number of attendees that may attend the Event or requiring that the Event be held without attendees in attendance. Complex shall have the exclusive right to elect to terminate this Agreement with Renter at any time prior to the Event if the Event is materially impacted as a result of COVID-19 restrictions in any way, or for any reason whatsoever, in Complex's sole and absolute discretion. Following such notice: (i) Complex shall immediately refund any Deposit paid to Complex or reschedule the Event; (ii) Complex will have no obligation to provide services for the Event; (iii) if canceled, Renter will have no further obligation to pay any amount to Complex under this Agreement, and (iv) this Agreement shall be terminated and of no further force or effect.

COVID-19 WARNING:

COVID-19 is an extremely contagious disease that can lead to severe illness and death. By attending any event at the Salinas Sports Complex, you assume all risks, hazards, and dangers arising from or relating in any way to the risk of contracting COVID-19 or any other communicable disease or illness, or a bacteria, virus, or other pathogens capable of causing a communicable disease or illness, whether occurring before, during, or after the event, however, caused or contracted, and voluntarily waive all claims and potential claims against Salinas Sports Complex, California Rodeo Association, California Rodeo, Inc., event promoters, vendors, and their affiliated companies, and any of their respective present and future subsidiaries, affiliates, partners, members, officers, directors, employees, stakeholders, shareholders, agents, other representatives, successors and assigns event promoters, vendors, and their affiliated companies relating to such risks.
