

# CARROLL COUNTY BORN & RAISED JR. FAIR CLASS VERIFICATION FORM

**THIS FORM MUST BE SIGNED AND RETURNED AT TAG IN** to be eligible to be entered in the Born & Raised class at the 2024 Carroll County Jr. Fair. **By completing this form, you will automatically be entered into the Born & Raised competition at the 2024 Carroll Co. Jr. Fair, but you MUST still make an entry for the animal in its regular weight class (i.e. market class). The exception are market hogs, which MUST be entered in the born and raised class only, and is in addition to completing this form. Simply completing this form does NOT enter a born & raised market hog into the class.** In other words, you still need to make an entry for the animal for its weight class.

The Carroll County Born & Raised Class was created to showcase market beef steers, hogs, lambs, goats, and dairy beef feeders that are born and raised by local breeders and Jr. Fair Youth.

**TO BE ELIGIBLE, THE FOLLOWING CRITERIA MUST BE MET:**

- A. The market animal must be born and raised at the residence of the Jr. Fair Exhibitor.
- B. If the market animal is purchased, it must have been born and raised in Carroll County until purchased by the Jr. Fair Exhibitor.
- C. The market animal was born in Carroll County of natural conception – **NO embryos are allowed.**

The Jr. Fair Exhibitor must also sign stating this market animal is being raised in Carroll County. Tag numbers will be entered at the time of tag in.
