During the set up and throughout the show, please be aware of and comply with the following items.

1. Criteria for a booth space:

- Crafts
- Home Based Businesses such as Mary Kay, Tupperware, etc. Non-Profit Organizations
- Limited Food vendor spaces are available. Please contact Nikki Davis for availability and pricing prior to application submission. Only one distributor/representative from each company will be permitted.
- 2. This is a juried show by the Cass County Fair. We reserve the right to refuse anyone that does not meet our criteria or we feel would not be right for our show.
- 3. No equipment is provided. Exhibitors are responsible for any tent, tables, chairs, extension cords or adapters etc. needed.
