### Information and Rules

1. Entry fees are as follows:

Showmanship: Free

Per Head Entry: \$5.00 (by **July 1, 2023**)  
\$10.00 (after July 1, 2023)

*All pre-entered exhibitors, by July 1st, will receive a Cass County Fair Livestock Exhibitor T-Shirt.*

2. Any out of state exhibitor must have health papers the day of the show

3. Only healthy animals will be admitted. All animals may be subject to a health inspection from a state licensed veterinarian and he/she have the authority to have any animal deemed a health risk and removed from the fairgrounds.

4. **Open to exhibitors 21 years of age or younger**

**The show is open to any youth wishing to exhibit, not just those from Cass County**

5. Cass County Fair will follow the rules set forth by the Missouri State Fair unless otherwise noted:

- Wrist bands will not be used for approved animal care and show prep designations
- Please remember this is a youth show and 4-H/FFA Code of Ethics are enforced

6. This is a youth show; therefore all 4-H and FFA Code of Ethics will be applied and enforced.

7. Breeding gilts must be born November 1, 2022 and after

8. Breeding gilts will show by weight

9. Breeding gilts cannot be shown in both breeding and market hog show

10. Market hogs (barrows and gilts) must be born on/after December 1, 2022

11. Market hogs will be shown by weight

12. All hogs will be released at the completion of the show
13. Limited electricity is available, generators welcome
14. Due to limited facilities exhibitors will be allowed (encouraged) to show off of their trailers
15. Bedding will not be supplied
16. Please remove all bedding at the completion of the show
17. All stalls must be cleaned before being released by the Superintendent
