DATES TO REMEMBER:

- **Storage Date:** 10/26/2024 at 8:00 AM (*arrive no later than 9:30 AM*)
- **Removal Date:** 04/26/2025 at 8:00 AM (*arrive no later than 9:30 AM*)

Please return this agreement with payment to the CWSF office at the address listed above.

- **Multiple storage items:** It is required that Lessees fill out one form per item stored. For a smoother storage experience, Lessees should have ALL storage items on the grounds no later than 9:30 AM. During removal, Lessees shall remove ALL stored items from the buildings before leaving the grounds, even if you plan to return shortly.
- **Past Lessees:** This Storage Lease Agreement must be completed and sent back to the CWSF office, along with full payment, no later than August 15th. After August 15th, all remaining spaces will be opened to the public.

By signing this lease agreement between the Central Wisconsin State Fair, hereinafter referred to as "CWSF" or "Lessor", and the renter, hereinafter referred to as "Lessee", the lessor does hereby lease to the lessee, and lessee agrees to store the following described property for the rental fee as listed on the Rate Schedule found below. It is further mutually agreed between the parties as follows:

1. The Lessee assumes liability for and hereby agrees to indemnify, protect, and hold CWSF and its successors, assigns, agents, employees, officers, directors, parents, and subsidiaries harmless from and against any and all liabilities, obligations, losses, damages, injuries, claims, demands, penalties, actions, costs and expenses (including reasonable attorney fees), of whatever kind and nature, arising out of the use and operation of the Event grounds. This obligation shall continue in full force and effect notwithstanding the expiration or termination of this Contract.
2. Lessee agrees to remove all batteries from stored item(s) before leaving. For safety purposes, all batteries should be taken home and not left inside the buildings.
3. The Lessee understands that once the item listed on their lease agreement is stored, that storage is for the identified season and the Lessee shall not expect access to the storage space until the end of the season. If for any reason an item must be removed, the Lessee is responsible for all costs incurred with removal. Items stored may be inaccessible.
4. Any Winter Storage cancellations must be made by October 1st of each year. After October 1st, refunds will not be available.
5. The Lessee or his/her agent will be present to remove the stored property on or before the above-listed removal date. If the Lessee or his/her Agent is not present, the Lessee will be liable for an additional storage charge of \$10.00 for each day beyond the termination date that the equipment is left in the building, plus any damages incurred by other parties due to the failure to remove their items at the designated date and time.
6. The CWSF reserves the right to move items as needed if the Lessee is not present to remove their items at the designated date/time listed above. The Lessee waives any and all claims to damages caused by moving the items.
