Reservations are not held until a complete reservation form and full payment are received by the CWSF office and are on a first come, first serve bases. No exceptions.

<u>Payments:</u> All payments are required with the return of this form and must be mailed no later than two weeks prior to your reservation dates. Payments can be made via credit card, checks, or in the Fair office located across from the Round Barn. Additional charges may apply for credit card purchases.

<u>Campground Rules:</u> Per City Ordinance, we ask that all loud activities stop at 10:30pm. Failure to comply with this ordinance could result in your removal from the Fair campgrounds without a refund. Generators and fireworks are not permitted on the campgrounds. Small camp fires are permitted in raised fire pits only and are not supplied by the CWSF. Pets are permitted on the grounds, however, per City Ordinance, all pets must be on a leash at all times. You are held responsible for the disposal of your pet's litter and waste. You may be asked to leave, with no refund, if there are any issues reported.

<u>Check-In:</u> The Fair Office is open from 9:00 AM - 4:00 PM on weekdays and closed on weekends. You will receive a camping permit via mail upon the revival of full payment and this form. This permit <u>must</u> be placed in your camper window and must be visible at all times.

<u>Dump Station:</u> Upon check-out you may wish to use a Sanitary Dump Station. The Dump Station is located on the grounds, next to the Round Barn off 17th Street, by the Fair Office. There is a city fee of \$5.00 per use for this service. All payments for the dump station can be placed in the drop box located next to this Station. Checks must be written out to the CWSF.

Showers / Bathrooms: Campers are welcome to use the showers and bathrooms located inside the Lang 4-H building near the campgrounds during their stay. If you would like to utilize these services, please come to the Fair Office to sign out a key during normal business hours (Mon – Fri from 9AM - 4PM). A \$25 fee will be charged if you do not return the key upon leaving the fairgrounds. If you are part of a large group coming to use the Campgrounds, the restrooms will already be open per that group's contracted agreement.

<u>Internet Access:</u> WiFi access codes can be purchased at the Fair Office during normal business hours as listed in the "Showers/Bathrooms" section. Each pass is only good for one device.

<u>Garbage:</u> There are dumpsters available throughout the grounds for your garbage needs. We ask that you help us keep the grounds clean and looking nice at all times. You may be asked to leave, with no refund, if there are any issues reported.

Indemnification:

Camper assumes liability for, and hereby agrees to indemnify, protect and hold CWSF and its successors, assigns, agents, employees, officers, directors, parents, and subsidiaries harmless from and against any and all liabilities, obligations, losses, damages, injuries, claims, demands, penalties, actions, costs and expenses (including reasonable attorney fees), of whatever kind and nature, arising out of the use and operation of the Event grounds.
