The goals are to promote reinvestment into historic assets, update DowntownTX.org website database for Gonzales and downtown speakers.

Some opportunities for improvement are that this event conflicts with other events and consistent advertising. Also, posting no parking signs was suggested. The Placer AI Report YoY showed that more people attended this year, most people came in from the Gonzales area and that people spent more time at the event than in the previous year.

He is willing to work with Main Street to promote and drive event traffic to local businesses. The board talked about potentially allowing event banners to be put on Main Street area utility and light poles. Board Member Craven made a motion to rent Main Street area poles for \$300 each with

artwork approved by City of Gonzales. Board Member Peeler seconded the motion. Chairperson Caka called for a roll call vote. For: Unanimous. The motion passed 5 to 0.
