If any provision of this Resolution or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Resolution and the application of such provision to other persons and circumstances shall nevertheless be valid, and the City Council hereby declares that this Resolution would have been enacted without such invalid provision.

BACKGROUND:

On September 10, 2020 the City Council of the City of Gonzales Approved the Operating Budget for the City of Gonzales for the Fiscal Year Beginning October 1, 2020 and ending September 30, 2021. In the adopted budget, funds were appropriated for the following Special Contracts:

Annually the City Council is asked to approve various Special Contracts whereby the City provides funding to local entities. The disbursement of these funds will be quarterly beginning December 31, 2020.

POLICY CONSIDERATIONS:

The contracts with these entities will benefit the general welfare and well-being of the City of Gonzales and achieve a legitimate public purpose.

FISCAL IMPACT:

The funds are currently budgeted in Account 100-7-101.521 Gonzales County Mental Health Advisory Board for \$2,640, Account 100-7-101.527 The Edwards Association for \$7,500, Account 100-7-101.520 Gonzales County Senior Citizens Association for \$7,500 and those amounts were verified with the Finance Director.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GONZALES, TEXAS AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACTS BETWEEN THE CITY OF GONZALES AND THE GONZALES COUNTY MENTAL HEALTH ADVISORY BOARD, THE EDWARDS ASSOCIATION, AND GONZALES COUNTY SENIOR CITIZENS ASSOCIATION; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, on September 12, 2020 the City Council approved the operating budget for Fiscal Year 2020-2021; and

WHEREAS, within said approved budget funds are currently budgeted in Account 100-7-101.521 Gonzales County Mental Health Advisory Board for \$2,640, Account 100-7-101.527 The Edwards Association for \$7,500, Account 100-7-101.520 Gonzales County Senior Citizens Association for \$7,500; and

WHEREAS, annually the City Council is asked to approve various Special Contracts whereby the City provides funding to local entities to benefit the general welfare and well-being of the city of Gonzales and achieve a legitimate public purpose; and

WHEREAS, the Gonzales County Mental Health Advisory Board, Inc. requests funding to provide and maintain the physical site and utilities for the Mental Health Clinic which provides programs and services to meet the needs of the citizens in the City of Gonzales by helping with medication, food or other services which achieves a legitimate public purpose; and

WHEREAS, the Edwards Association requests funding to provide and maintain the physical site and provide utilities for the Edwards High School which provides facilities and organization for activities for all age groups including educational opportunities and to articulate the history and meaning of the Edwards High School which achieves a legitimate public purpose; and

WHEREAS, the Gonzales County Senior Citizen's Association requests funding to provide programs and services to meet the needs of senior citizens such as delivering meals to their homes and providing transportation to medical appointments, lab work, dialysis, grocery shopping, restaurants, work and any other need they may have which achieves a legitimate public purpose; and

WHEREAS, the City Council finds that entering into an agreement with the Gonzales County Mental Health Advisory Board, the Edwards Association and the Gonzales County Senior Citizens Association is in the best interest of the City and its citizens and will further promote the public health, safety, and general welfare of the City.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GONZALES, TEXAS:

- Section 1. The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Resolution for all purposes and are adopted as a part of the judgment and findings of the City Council.
- Section 2. The City Council of the City of Gonzales hereby authorizes the City Manager to execute contracts with Gonzales County Mental Health Advisory Board (Exhibit "A"), the Edwards Association (Exhibit "B"), and Gonzales County Senior Citizens Association (Exhibit "C") in the amounts specified herein the attached Exhibits.
- Section 3. All resolutions or parts thereof, which are in conflict or inconsistent with any provision of this Resolution are hereby repealed to the extent of such conflict, and the provisions of this Resolution shall be and remain controlling as to the matters resolved herein.
- Section 4. This Resolution shall be construed and enforced in accordance with the laws of the State of Texas and the United States of America.
- Section 5. If any provision of this Resolution or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Resolution and the application of such provision to other persons and circumstances shall nevertheless be valid, and the City Council hereby declares that this Resolution would have been enacted without such invalid provision.
- Section 6. It is officially found, determined, and declared that the meeting at which this Resolution is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this Resolution, was given, all as required by Chapter 551, Texas Government Code, as amended.

WHEREAS, the City finds that these programs and services provided by the Advisory Board are a benefit to the general welfare and well-being of the City of Gonzales and achieve a legitimate public purpose.

NOW, THEREFORE, in consideration of these premises and the mutual covenants and agreements herein set forth, the parties agree as follows:

- 1. The City shall provide funding to the Advisory Board in the amount of \$2,640.00 for the budget that runs from October 1, 2020 to September 30, 2021. The Advisory Board shall provide programs and services to meet the needs of the City of Gonzales' citizens. City funds will be disbursed quarterly pending receipt of satisfactory quarterly information and is also subject to available funding.
- 2. The Advisory Board shall provide quarterly financial and program information regarding financial position, use of funds, services offered, and number of people served at the end of each quarter. Quarters will end December 31st, March 31st, June 30th, and September 30th of each year. Financial reports along with invoices and/or proof of payment shall accompany the financial statements.

BACKGROUND:

On September 14, 2020 the City of Gonzales received an application for a zoning change (Case 2020-02) for a 2.25 acre tract of land located between 1543 and 1619 Seydler Street. The property is currently zoned R-1 Residential 1 District and the applicant is seeking to change the zoning to R-2 Residential 2 District for the stated purpose of allowing apartments or townhomes. The subject property is described as follows:

PROPERTY OWNER: Verle and Mary Williams

LEGAL DESCRIPTION: Lot 2, Henry C. Schmidt, III Subdivision

PARCEL: 28627

A notice was published in the newspaper on September 24, 2020 and notices were mailed to property owners within 200' of the subject property on September 29, 2020. When the November 12, 2020 City Council meeting was canceled, the property owners were renotified and a new notice was published in the newspaper. Eight property owners were notified of the zoning change. As of preparation of the staff report, two property owners filed a letter of objection to the change and no property owners filed a letter of no objection. One letter was returned unable to forward.

Surrounding property:

North: R-1 Residential 1 District – Single family home

East: C-2 Heavy Commercial – High School field and metal buildings

South: R-1 Residential 1 District – Single family home, further south small warehouse

West: R-1 Residential 1 District – Vacant land

The 2013 City of Gonzales Comprehensive Plan contemplates the property to be single family residential and has a separate multi-family residential district called out within the plan.

WRITTEN REPORT FROM THE PLANNING & ZONING COMMISSION:

The Planning and Zoning Commission met on October 15, 2020 and conducted a public hearing

on the rezoning application. The Planning and Zoning Commission unanimously recommended denial of the application with one member absent.


The La Pasada Apartments complex is about 500 ft north of this lot and there is an 8 unit town house complex south across the street intersection.



- Section 2. The property described as Lot 2 of the Henry C. Schmidt, III Subdivision, Gonzales, Texas as shown and more particularly described in the attached exhibit A, is hereby zoned from R-1 Residential District to R-2 Residential District.
- Section 3. The Official Zoning Map of the City of Gonzales, Texas shall be revised to reflect the above amendment.

Section 4. All ordinances and codes, or parts thereof, which are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters resolved herein.

Section 5. This Ordinance shall be construed and enforced in accordance with the laws of the State of Texas and the United States of America.

Section 6. If any provision of this Ordinance or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Ordinance and the application of such provision to other persons and circumstances shall nevertheless be valid, and the City hereby declares that this Ordinance would have been enacted without such invalid provision.

Section 7. It is officially found, determined, and declared that the meeting at which this Ordinance is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this Ordinance, was given, all as required by Chapter 551, as amended, Texas Government Code.

Section 8. This Ordinance shall be effective upon the date of final adoption hereof and any publication required by law.

Section 9. This Ordinance shall be cumulative of all other ordinances of the City of Gonzales, and this Ordinance shall not operate to repeal or affect any other ordinances of the City of Gonzales except insofar as the provisions thereof might be inconsistent or in conflict with the provisions of this Ordinance, in which event such conflicting provisions, if any, are hereby repealed.

It has been the policy of the City of Gonzales to require all boards and commissions appointed by the City Council to hold meetings in accordance with the Texas Open Meetings Act. The attached ordinance amends Chapter 9, Article 9.40 of the Code of Ordinances to add a new section to Rules of Procedure that codifies the requirement to hold meetings in accordance with Chapter 551 of the Texas Government Code, known as the Texas Open Meetings Act and all the boards to be entitle to the same rights and privileges established in the Act.

POLICY CONSIDERATIONS:

This is consistent with current procedures and expands on the rights of the boards in conducting meetings in accordance with the Texas Open Meets Act.

FISCAL IMPACT:

There are no fiscal impacts at this time.

ATTACHMENTS:

Staff respectfully recommends the council take the action they deem necessary.

ORDINANCE NO. 2020-26

AN ORDINANCE AMENDING CHAPTER 9, ARTICLE 9.40, OF THE CITY OF GONZALES CODE OF ORDINANCES BY AMENDING DIVISION 1 RULES OF MEETINGS AND ORDER OF BUSINESS; PROVIDING FOR A CUMULATIVE CLAUSE; PROVIDING FOR SEVERABILITY AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Council has previously adopted uniform rules of decorum and procedure for all boards, commissions and committees appointed by the City Council; and,

WHEREAS, to improve efficiency and transparency while protecting the interests of the City and public it is necessary to amend the previously adopted rules of decorum and procedure; and,

WHEREAS, the City of Gonzales, as a home rule municipality has the authority to extend the provisions of the Texas Open Meetings Act to all boards, commissions and committees appointed by the City Council; and,

WHEREAS, the City Council hereby finds and determines that amending the Code of Ordinances to designate all boards, commissions and committees appointed by the City Council as governmental bodies as defined by Chapter 551 of the Government Code is in the best interest of the City.

NOW, THEREFORE: BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GONZALES, TEXAS:

Section 1. Code Amended.

City of Gonzales Code of Ordinances, Chapter 9 (entitled "Personnel"), Article 9.40, (entitled "Rules of Procedure Decorum and Ethics"), Division 1. (entitled "Rules of Meetings and Order of Business") is hereby amended as shown on **Exhibit A**, and incorporated herein.

Section 2. Findings.

The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Ordinance for all purposes and are adopted as a part of the judgment and findings of the Council.

Section 3. Repealer.

All ordinances, or parts thereof, which are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters resolved herein.

Section 4. Relation to Other Ordinances.

This ordinance shall not be construed to require or allow any acts which are prohibited by any other ordinance.

Section 5. Effective Date.

This Ordinance shall become effective immediately from and after passage and any publication if required by governing law.

Section 6. Savings Clause.

The repeal or amendment of any ordinance or part of ordinances effectuated by the enactment of this ordinance shall not be construed as abandoning any action now pending under or by virtue of such ordinance or as discontinuing, abating, modifying, or altering any penalty accruing or to accrue or as affecting any rights of the City of Gonzales under any section or provisions of any ordinances in effect at the time of passage of this ordinance.

Section 7. Cumulative.

The provisions of this ordinance shall be cumulative of all ordinances not repealed by this ordinance and ordinances governing or regulating the same subject matter as that covered herein. This ordinance shall not be construed to require or allow any act which is prohibited by any other ordinance.

Section 8. Severability.

It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs, and sections of this ordinance be severable, and, if any phrase, clause, sentence, paragraph, or section of this ordinance shall be declared invalid by judgment or decree of any court of competent jurisdiction, such invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, or sections of this ordinance and the remainder of this ordinance shall be enforced as written.

Section 9. Proper Notice and Meeting.

It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code. Notice was also provided as required by Chapter 52 of the Texas Local Government Code.

THE CITY OF GONZALES CODE OF ORDINANCES IS HEREBY AMENDED AS SET FORTH BELOW. (ADDITIONS ARE BOLD AND UNDERLINED)

ARTICLE 9.400 RULES OF PROCEDURE DECORUM AND ETHICS

Division 1. Rules of Meetings and Order of Business

Sec. 9.402 Regular Meetings

- (a) <u>Time and Location</u>. The time and location of each board meeting shall be established in the bylaws or by official action of each respective board.
- (b) Other Locations. The boards may, occasionally, elect to meet at other locations and, upon such election, shall give the public notice of the change of location in accordance with state law.
- (c) <u>Location During Local Emergency</u>. If by reason of fire, flood or other emergency, it is unsafe to meet at the regular meeting location, the meetings may be held for the duration of the emergency at such other place as may be designated by the board chair or in the absence of the board chair, the board liaison.
- (d) <u>Cancellation of Meetings</u>. When the day for any regular meeting falls on a legal holiday, the regularly scheduled meeting for such day shall be deemed canceled unless otherwise specified by the board. At other times, when the board deems appropriate, regular meetings may be canceled and rescheduled by a majority vote of the board.
- (e) Texas Open Meetings Act. For purposes of Chapter 9 of this Code of Ordinances, all boards, commissions and committees appointed by the city council are hereby deemed to be governmental bodies as that is defined in the Texas Government Code Chapter 551, as amended. As such, all boards, commissions, and committees appointed by the city council shall fully comply with the requirements set forth in Chapter 551, known as the Texas Open Meetings Act, and be entitled to any rights and privileges established therein.

BACKGROUND:

The Gonzales Economic Development Corporation (GEDC) was incorporated on March 14, 1997, and filed its Articles of Incorporation with the Texas Secretary of State. At the time of the filing Article Eight stated, "The Affairs of the Corporation shall be managed by a Board of Directors ("the Directors") which shall be composed of seven (7) persons appointed by the City Council each of the directors shall be a resident of the City."

The Texas Legislature has since modified Sec. 505.052 (b) of the Texas Local Government Code, which provides for,

- (a) Each director of a Type B corporation authorized to be created by a municipality with a population of 20,000 or more must be a resident of the municipality.
- (b) Each director of a Type B corporation authorized to be created by a municipality with a population of less than 20,000 must:
 - (1) be a resident of the municipality;
 - (2) be a resident of the county in which the major part of the area of the municipality is located; or
 - (3) reside:
 - (A) within 10 miles of the municipality's boundaries; and
 - (B) in a county bordering the county in which most of the area of the municipality is located.

POLICY CONSIDERATIONS:

During the November 23, 2020, GEDC Regular Meeting, the Board of Directors reviewed and approved the amendment and recommends the City Council approve the amendment that supports Section 1. (g) of the Amended Bylaws of the Gonzales Economic Development Corporation adopted on the 20th of May, 2019 and approved by the City Council of the City of Gonzales held on the 13th day of June 2019. Section 1. (g) "Each Director must reside within the City of Gonzales or Gonzales County. Expanding the area in which directors may reside greatly increases the number of qualified eligible applicants to serve the community.

WHEREAS, by the adoption of this Ordinance, the City Council of the City of Gonzales, Texas, finds and determines that it is advisable that the proposed amendments to the GEDC's Articles of Incorporation be made, authorizes the same to be made, and approves the form of the proposed amendments as set forth in the Amendment to Articles of Incorporation, a copy of which is attached hereto as Exhibit A, and in accordance with section 501.301(b)(1)-(3) of the Texas Local Government Code.

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GONZALES, TEXAS, AS FOLLOWS:

- <u>Section 1</u>. Incorporation of Premises. That the foregoing recitals are hereby found to be true and correct legislative findings of the City Council of the City of Gonzales, Texas, and are fully incorporated into the body of this Ordinance.
- Section 2. Approval of Amendment to Articles of Incorporation. That the City Council of the City of Gonzales, Texas, finds and determines that the Amendment to the Articles of Incorporation of the Gonzales Economic Development Corporation, a copy of which is attached hereto as *Exhibit A*, is hereby approved and adopted by a majority vote of the City Council of the City of Gonzales, Texas.
- <u>Section 3.</u> Authorize the Filing of Amendment to Articles of Incorporation. That the City Council of the City of Gonzales, Texas, authorizes the filing with the Texas Secretary of State's office the Amendment to the Articles of Incorporation of the Gonzales Economic Development Corporation, a copy of which is attached hereto as *Exhibit A* (hereinafter referred to as the "Amendment").
- <u>Section</u> **4. Making Certain Findings.** That the City Council of the City of Gonzales, Texas, in accordance with Section 501.301(b)(1)-(3) of the Texas Local Government Code determines that it is advisable to adopt the Amendment; authorizes the adoption of the Amendment; and approves the form of the Amendment.

SECTION ONE NAME

(a) <u>Amendment.</u> That the second sentence, in the first paragraph of Article Eight, of the Articles of Incorporation of the Gonzales Economic Development Corporation, as amended, is hereby amended to read as follows:

"Each of the directors shall be a resident of the City or a resident of Gonzales County, Texas, consistent with Section 505.052 of the Texas Local Government Code, as amended."

TYPE AGENDA ITEM:

Resolution

BACKGROUND:

At the November 16, 2020 Council meeting, the Mayor requested a future agenda item to include a job description for a newly created position involving public information. Staff has provided a job description for Communications Manager. Included is the proposed job description and updated position classification form.

This position was not anticipated in the 2020-2021 budget and would require a budget amendment. If approved, the City Manager would add the responsibilities of Communications Manager to the Tourism Director and provide a salary increase from \$57,783 to \$65,000.

POLICY CONSIDERATIONS:

This Resolution will increase the duties of a current employee and will amend the current version of classification for the new position.

FISCAL IMPACT:

Adding the duties to the Tourism Director and increasing the salary by \$7,217 would cost the city approximately \$8,480 which includes benefits. With the change effective December 12, 2020, it would require an additional \$6,550 from the general fund for FY 2020-2021 budget. A budget amendment would be required at a later date.

Staff respectfully recommends the council take the action they deem necessary.

Discuss, Consider & Possible Action on Concession Stand Operations at J.B. Wells Arena.

DATE: December 10, 2020

TYPE AGENDA ITEM:

Action

BACKGROUND:

The J.B. Wells Arena concession stand has been leasing out the concession stand to interested parties since approximately 2011. Our current lessors have given notice that they will be giving up their three-year contract as of December 31, 2020 primarily due to family commitments. Since there is a cutting beginning on December 31, 2020 through January 2, 2021, their last event will be December 19, 2020.

The City of Gonzales placed an RFP in early November, which had a due date of November 19, 2020. As of today November 30, 2020, we have not received any proposals, although we hope to have some to review prior to the Council meeting.

Staff has prepared three options for Council discussion and direction:

- A. Staff has been in contact with Amy Loehse, who owns a business finding food trucks for events. Ms. Loehse has been talking to three different trucks to switch out for each event at the arena, one food truck possibly being available for all events. As of November 30th, Staff does not have full details or a commitment from Ms. Loehse. We do know that the City would not be required to execute a contract with her or pay any fees. She generates her revenue through contracts with the individual food trucks. Staff hopes to have more details to provide at the Council meeting.
- B. On November 30, 2020, three different parties reached out to Staff expressing interest in leasing the concession stand. One is very familiar with the horse industry and has knowledge of the J.B. Wells Arena layout. All of the individuals have been provided information included in the RFP and one is scheduled to tour the location this week. Staff is hopeful that one of these individuals will execute a lease.
- C. The final option would be for the City to take over operation of the concession stand again. This would of course require hiring part time help and the expense of stocking the concession stand in order to run the concession stand. This has the potential to generate revenue, however, there would be a lot of new labor for the city. In an attempt to research revenues generated the last time the City ran the concession stand it is difficult

to obtain accurate revenue records due to a number of factors. The current lessors said after expenses and labor they cleared \$25,000.00 for the year; however, this number seems to be on the low end considering the number of attendees and customers throughout the year.

POLICY CONSIDERATIONS:

This is consistent with current procedures and expands on the rights of the boards in conducting meetings in accordance with the Texas Open Meets Act.

FISCAL IMPACT:

The current lessor pays the City \$800 per month for use of the concession stand. The original RFP requested a minimum of \$750 per month. If the Council moves forward with Option A, there would be no expense to the City, but there would not be any revenue either. Both Option B and Option C would require further evaluation to determine their budgetary impact.

STAFF RECOMMENDATION:

Staff recommendation is at this time is to continue to look for a new lessor and if we need to supplement someone in the meantime see about having food trucks come to the arena for the weekend events. The arena is booked every weekend of 2021. Alternatively, staff may receive some proposals prior to the Council meeting that staff can review during the meeting.

BACKGROUND:

On October 26, 2020, the City was notified by the Texas Department of Agriculture (TDA) that our grant application had been approved in support of a Downtown Revitalization project for the City of Gonzales in the amount of \$500,000. The purpose of this project is to provide economic development activities in the form of sidewalks, street improvements in the downtown area. This project will be funded through the Texas Community Development Block Grant (TxCDBG) Program as Contract No. 7220052.

City staff sent a Request for Proposals to Environmental Services Providers and Engineers to provide professional services for the project. Unfortunately, we received no responses for environmental services. Staff's recommendation is to allow the engineering firm that is awarded the project to subcontract out the environmental services.

We received three (3) responses from engineering firms. The three proposals received were from Doucet & Associates, Inc., Southwest Engineers, and SRI Global Inc.

On December 7, 2020, City staff met and evaluated the proposals based on the criteria set forth in the RFP and ranked the proposals with a possible score of 100 points: Doucet & Associates scored 96 points, Inc., Southwest Engineers scored 94 points, and SRI Global Inc. scored 42 points.

POLICY CONSIDERATIONS:

This is consistent with previous actions and with the requirements of the awarded grant.

FISCAL IMPACT:

When the City applied for the grant, we committed to a 10% match, being \$50,000. This project will require a budget amendment. Staff will also submit a request to the GEDC and GCVB for possible assistance.

STAFF RECOMMENDATION:

Staff respectfully recommends the approval of this resolution.

WHEREAS, on November 10, 2020 City staff issued a Request for Qualifications (RFQ) for engineering services for the City of Gonzales for the TxCDBG Main Street Infrastructure Grant; and.

WHEREAS, proposals were received from Doucet & Associates, Inc., Southwest Engineers, and SRI Global Inc. by the due date published; and,

WHEREAS, City staff evaluated the proposals based on the firms understanding of the requirements, experience in providing similar services to the City or any other governmental entity, samples and references and key personnel professional background, certifications, and experience in providing the requested services during which Doucet & Associates received the highest score of the three proposals; and,

WHEREAS, the City Council finds that entering into an agreement with Doucet & Associates to assist the City of Gonzales with the TxCDBG Main Street engineering services for downtown infrastructure improvements to promote the public health, safety, and general welfare of the City.

BACKGROUND:

In 1950 the City Council identified that there were unsanitary, unsafe inhabited dwelling accommodations and that there was a shortage of safe and sanitary dwelling accommodations for families of low income. It was at that time Council established a Housing Authority for the City of Gonzales.

Local Government Code 392 outlines the guidelines that the municipal Housing Authority must abide by. The Housing Authority is considered to exist in its own right, a public body that is separate from the municipality. The Housing Authority governs its own affairs without interference or funding from the municipality. Furthermore, municipalities do not have any authority to oversee the actions of the board of commissioners or the operations of a housing authority, except as reflected in LGC §392.031 which states the presiding officer of the governing body shall appoint the commissioners. In addition, LGC §392.034 states that after the original creation and appointment of the commissioners to the Housing Authority of a municipality each subsequent appointment will be for two-year terms.

POLICY CONSIDERATIONS:

Certificates of Appointment to the Housing Authority of a municipality are required by the Texas Local Government Code.

Discuss, Consider and Possible Action on **Resolution** #2020-138 Appointing the Municipal Court Judge and Authorizing the City Manager to execute an agreement for judicial services.

DATE: December 10, 2020

TYPE AGENDA ITEM:

Action/Executive Session

BACKGROUND:

At the October 8, 2020 meeting, Council directed staff to solicit requests for qualifications (RFQ) for the position of Municipal Judge. A notice was published in the Gonzales Inquirer and on the City's website. Staff also emailed the RFQ to the current Municipal Judge, Deidra Voigt and to Michael Scott Hanson who had previously requested to be notified if such action was taken. The deadline to submit qualification was Monday, November 30, 2020 at 2:00 p.m. Staff received one submittal from Judge Deidra Voigt which is provided under separate cover. The City Council will have the opportunity to interview and discuss the candidate during executive session, while the appointment must be made in open session.

Judge Deidra Voigt, the current judge, was originally appointed on May 24, 2011 to fill an unexpired term for the previous judge that ended on December 8, 2012. Judge Voigt was last reappointed at the November 8, 2018 Council meeting with a term expiration of December 8, 2020.

Government Code Section 29.005 states that the term of office of a judge of a municipal court is two years unless the municipality provides for a longer term pursuant to the Constitution. A municipal court judge who is not reappointed by the 91st day following the expiration of a term of office shall, absent action by the appointing authority, continue to serve for another term of office beginning on the date the previous term of office expired.

As per the City of Gonzales Charter Section 4.04 (b) the judge of the municipal court shall be a qualified voter of the city and shall be appointed by the city council, shall hold his/her office at the pleasure of the city council and shall receive such salary as may be fixed by ordinance of the city council.

POLICY CONSIDERATIONS:

In 2018, Council held discussions regarding whether it would be appropriate to advertise a request for qualifications for the position. It does not appear that this was done for the last appointment.

FISCAL IMPACT:

The Municipal Court Judge is currently compensated \$1,950 per month. There was no proposed increase included in the Fiscal Year 2020-2021 budget.

STAFF RECOMMENDATION:
Staff is seeking Council direction on this item.

WHEREAS, the municipal court judge must be reappointed by the 91st day following the expiration of a term of office shall, absent action by the appointing authority, continue to serve for another office beginning on the date the previous term of office expired; and

WHEREAS, the current sitting municipal judge's term ends on December 8, 2020; and

WHEREAS, the City Council finds that appointing ____ as the Municipal Court Judge to perform municipal judge services would be in the best interest of the City of Gonzales.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GONZALES, TEXAS:

- Section 1. The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Resolution for all purposes and are adopted as a part of the judgment and findings of the City Council.
- Section 2. The City Council of the City of Gonzales, Texas hereby appoints ______ to serve as the Municipal Court Judge until December 8, 2022.
- Section 3. The City Council authorizes the City Manager to negotiate a contract for professional services with the Municipal Court Judge in accordance with expenses adopted in the Fiscal Year 2020-2021 Budget.
