## GONZALES TOURISM ADVISORY COMMITTEE MEETING

Thursday, October 24, 2013 City Hall at 12:00 P.M.

### MINUTES

- 1. Chair Richard Tiller called the meeting to order at 12:00 pm and certified a quorum with Paul Frenzel, Ann Covert, Barbara Crozier, Richard Tiller, Ken Morrow, Alison Rodriguez, Cindy Munson, Meena Patel, Barbara Friedrich, and Tim Patek. City Manager Allen Barnes, Mayor Bobby Logan, and Marketing consultant Loretta Shirley were also present.
- 2. Public/Citizens Comments.

Meena Patel reported that Best Western Regency Inn & Suites was recognized with the M.K. Guertin Award as well as the Champion Customer Care Award at Best Western's International's 2013 Convention held in San Antonio.

- 3. Discuss and Approve minutes of September 26, 2013.
  Following discussion, Paul Frenzel moved to approve the minutes with the correction for item #9 to state that Ann Covert offered to work on a plan of work for the following budget year. Alison Rodriguez seconded the motion. The motion prevailed by unanimous vote.
- 4. Discuss and Consider request for funding for repairs and renovations to Gonzales Memorial Museum.

Tim Patek reported that City Council had approved funding for cleaning of the museum and concrete work on the outside of the museum. The concrete work will cost approximately \$18,000 and the cleaning will cost approximately \$44,000. The cleaning will be contracted with the contractor doing the work at the First United Methodist Church. City staff has met with the Texas Historical Commission and THC is very familiar with this contractor. City staff will be working closely with THC.

Following comments and discussion, Ann Covert moved to recommend that funding be made up to \$18,000 for the concrete work at the museum and recommend that funding be made up to \$44,000 for the cleaning of the museum. Barbara Crozier seconded the motion. Barbara Crozier commented that she was delighted that the Tourism Committee could utilize the funds for more things than advertising and marketing. Richard Tiller commented that many cities do not have advisory committees and City Council makes all the decisions as to how funds are spent.

The motion prevailed by unanimous vote.

5. Report by Marketing Consultant Regarding Advertising, Smart Phone App, Billboards, and Website.

Loretta Shirley submitted the Marketing Report. She reported that the 1/6 ad was in the November issue of the Southern Living Magazine. In addition to the ad, we will receive a listing on their website for the month of November. Loretta also presented information and pricing on billboards, and on a Google Ad Campaign. The committee requested that both these items be placed on the November agenda for consideration.

- 6. Report on Upcoming Events.
  Pride in Gonzales Community Clean-Up Day, Happy Fall Ya'll, Victoria College Health Clinic, Ranch Rodeo, Rusted Gingham Barn Sale in November and Crystal Theater will present "It's a Wonderful Life" in conjunction with Winterfest.
- 7. Financial Report.
  Financial Report was reviewed.
- 8. Report from Committee Members and Staff.
  Paul Frenzel reported that the Burma signs were all ready to go up, but he has to have the phone lines marked. The County and ISF will assist in putting these up.
- 9. Discuss and consider changing standing date of committee meetings.
  Following discussion, Meena Patel moved to approve changing the date of the Tourism Committee Meetings to the second Thursday of the month at 12:30 P.M. The next Tourism Committee meeting will be November 14, 2013 at 12:30 p.m. Ann Covert seconded the motion. The motion prevailed by unanimous vote.

## Request for Additional THMD Signage Funding





#### **DESCRIPTION** (color rendition with dimensions attached to this email)

SIGN FRAME – Welded commercial heavy gauge 2.5" square metal tubing frame with commercial heavy gauge .75" square metal tubing pickets, primed and powder coated black with welded tabs for aluminum sign mount. Overall size is 128.5" high X 30" wide. Height includes 30" to be set below ground level. Above ground height is 98.5". Our suggestion is to set the sign in concrete for wind load requirements and stability. **Don't forget!** Whoever is going to install the sign will need to check for underground wiring and pipelines before they dig the two holes 30" deep.

ALUMINUM SIGN – Two-sided .080 gauge Aluminum sign material covered with full color printed vinyl (artwork supplied by the Gonzales County Historical Commission). The vinyl will be coated with heavy UV coating for longevity. Size is 5.5' high X 2' wide. The aluminum sign should be attached to the welded tabs on the sign frame with stainless steel or other corrosion resistant bolts.

#### PRICE

SIGN - \$791.45 (does not include shipping charges)

SHIPPING CHARGES – The odd thing about shipping some items is that the cost may not vary much at the base rate. The cost doesn't begin to increase until you reach a certain weight. I'm guessing the shipping charges to be \$50-\$62.50. The shipping cost for five of these sign frames won't be much different than the cost of one. The savings of \$200-\$250 may influence your decision of how many to order.

Let me know how to proceed and how many sign frames to order. I have artwork from Loretta for the Jail Museum aluminum panel so I'm ready to get it printed if we're ready to move forward. If we're going to order more than one, Loretta will need to forward artwork for the additional signs.
