SHOW: Wednesday, April 10, 2024 | 7:00 PM

 $\textbf{FAIR ARRIVAL 4/8/2024:} \ 12:00 \ PM - 2:00 \ PM \ | \ Bring \ an \ unopened \ bag \ of \ feed, \ no \ barrels, \ or \ buckets.$

LOCATION: Fairgrounds, Livestock barn | **ENTRY FEE:** \$25.00 Due at final weigh in

All Steer must go to slaughter after exhibition, to a USDA-FSIS facility.

ELIGIBILITY:

- All exhibitors must have completed an application and meet the entry/drawing rules to be eligible for participation.
- Exhibitors must be 10 years old by September 1, 2023.
- All 4-H/FFA members who wish to exhibit a Steer in the 2024 Fair must
- attend the Mandatory Steer Meeting on Sunday, December 3, 2023 at 2:00 PM. Rules, Regulations and Requirements will be discussed at this meeting.
- Exhibitors must reside in Clay County or attend a Clay County School. High school graduates are
 ineligible. Exhibitors must be in good standing in school. Exhibitors not in good standing will not be
 allowed to participate.
- School FFA Chapters are allowed only 1 swine or 1 steer unless the school has 2 FFA Chapters.
- Exhibitors must be a bonafide member of a Clay County 4-H Club or FFA Chapter at the time of the fair verification process. The Fair cross-references the list of applicants who have submitted applications to exhibit swine with Clay County 4-H Agents and FFA Chapter Advisors. 4-H or FFA members must have been a verified member in good standing to earn eligibility to show a swine in the Clay County Fair. Individuals who are not verified members in good standing are not eligible to exhibit. 4-H Members at Large do not qualify.
- Participants are required to write letters to three (3) potential buyers and include addressed, stamped, unsealed envelopes. Letters must be submitted at the meeting, December 3, 2023. **This is a requirement!** These letters will be mailed by the Fair Office.
- Animal must be of beef type and not less than 75% BEEF BREEDING.
- All steers must be unloaded and weighed on foot, on certified scales at the Clay County Fairgrounds on December 3, 2023 at 2:00 PM in the presence of the Steer Superintendent/Fair Livestock Director. Steers must weigh a minimum of 700 pounds to be qualified and must be a quality animal. Parents may not assist in weighing their own child's steer.
- This weigh-in also qualifies all exhibitors to participate in the Weight Gain Contest.

STEER ORIGIN:

- May be purchased anywhere.
- Must be polled or dehorned thirty (30) days before the show; however, scurs and secondary growth of horns two (2) inches or less will be accepted. Final acceptance will be by the Livestock Committee.
- An official tag number that clearly identifies the animal will be assigned on December 3,
- 2023 at the mandatory weigh-in.

SPECIFIC SHOW RULES:

- Each 4-H and FFA participant must have the ability to control their animal independently or will be disqualified. Each participant must assume all liability in case of injury or damage to, or caused by exhibitor's animal, relieving Clay County Fair Association, Inc. from all liability.
- Exhibitors may only show and sell one market animal. Both Junior High FFA Chapters and Senior High FFA Chapters may show and sell one market animal.
- Exhibitors must wear official 4-H or FFA attire at the show, and sale. No caps or cowboy hats are to
 be worn during the show or sale. Closed toed leather boots shall be worn at all times. (no Hey Dude or
 Crocs), when exhibitors are working around or with their project animals. (including feeding,
 grooming, tie out for night, etc.) FAILURE TO ADHERE TO DRESS CODES DETERMINED BY
 THE STEER SUPERINTENDENT WILL RESULT IN NOT SHOWING AND/OR SELLING THE
 ANIMAL.
- In the event of a legitimate medical or family emergency, (as determined by the livestock directors) a market swine or market steer may be shown in competition for its placing in class by another swine or steer participant in the fair. The animal will compete in its class for placement in class only and will not be allowed for competition for the showmanship categories. Exhibitor must participate in the market show to be eligible for sale in the livestock auction. Exhibitor must have their animal properly trained so that it may be managed and led into the show ring by the EXHIBITOR. A non-controllable animal will be disqualified. (Disqualification will result in no participation in show or sale, exhibitor will be responsible for safe removal of animal from fairgrounds)
- Any tampering with animals entered during the Fair, (such as filling with a foreign substance, etc.) is prohibited. The use of tranquilizers on show animals or the possession of same after arrival at the Fair will be construed as a form of tampering. The Livestock Committee and authorized agents shall have the right to handle and examine animals at any time during the Fair. If evidence of tampering is found, the animal shall be removed from the Fairgrounds and disqualified. If after the sale, all proceeds will be forfeited and the exhibitor is prohibited from showing the following year.
- GIFTS: Mandatory for livestock swine / steer participants: All livestock participants are required to provide <u>one (1)</u> buyer gift per participant to include a thank you card for the main buyer of their animal on auction night. (This thank you card does not take the place of the buyer thank you letter due after the fair; see page 8 of the rules "After the Fair" #1 for clarification). The gift must be checked in at the sale arena prior to the sale. (a table will be setup at the arena for checking in the gifts) Participate must provide a 3x5 card with the participants name, sale # and animal tag #. Gift prices range from \$25.00 \$75.00.

Gift ideas:

- a. Gift basket
- b. Gift cards with a thank you card: restaurant, store, visa card (to use anywhere Participants not providing gifts for their buyers the night of the sale, will be penalized a \$50.00 fee from their sale check.
- Livestock Buyer Dinner: The dinner is provided for Livestock Buyers and special guest only.
 Exhibitors are not allowed at the buyer's dinner. Tickets and information are available through the Clay County Fair Association office.

- LIABILITY: The exhibitor assumes all liability in the case of death, or injury to his/her animal until the close of the Fair. No show official or member of the Clay County Fair Association, Inc. may be held liable for the loss of any animal or damage caused by exhibitor's animal.
- CLINICS: Highly Recommended to Attend. Educational Clinics will be available for exhibitors to attend on December 3, 2023 after weigh in.

GENERAL BARN RULES:

- All exhibitors must use bedding provided by the Clay County Fair.
- Feed and water pails must be provided by the exhibitor. No animals are to be moved through the barn for any reason during fair hours unless authorized and accompanied by the Steer Superintendent or designee.
- All exhibitors of livestock will be required to maintain their stall, walkway, and space in a clean and sanitary condition, and to remove any filth or litter and place it in a designated pick-up area. The sanitation department of the Fair will remove refuse from designated pick-up areas only. Noncompliance of this rule will result in hiring of personnel to clean exhibitor's area, and labor costs will be deducted from exhibitor's proceeds.
- Each steer must be securely tied at all times with at least a 3/8 inch rope halter and neck rope. All steers will have a neck rope on at all times while tied at the Fair. The neck rope and lead rope shall be no more than 18" from knot to animal at any one time that they are tied. Failure to do so could result in a \$5.00 fine deducted from sale price of steer. (This is to keep animals from getting tangled in their ropes or their neighbor's ropes due to not keeping ropes tied properly). Same rule for untied, loose animals.
- Exhibitors not properly feeding, caring for and/or managing their steers will be charged \$25.00 and forfeit right to all awarded premiums. Further violation will result in removal of animal and disqualification.
- Each exhibitor is responsible for his animal arriving on time at the place designated by show officials.
 Any questions or problems will be handled in the order of the Steer Superintendent, or the Livestock Directors.
- Closed toed leather boots shall be worn at all times. (no Hey Dude or Crocs), when exhibitors are working around or with their project animals. (including feeding, grooming, tie out for night, etc.) FAILURE TO ADHERE TO DRESS CODES DETERMINED BY THE STEER SUPERINTENDENT WILL RESULT IN NOT SHOWING AND/OR SELLING THE ANIMAL.

SHOW & JUDGING:

- All steers must gain a minimum of 254 pounds total following the weigh-in, and must weigh at least 954 pounds at the Fair weigh-in on April 10, 2024. Steers not meeting the weight or grading requirements will be disqualified from the show, showmanship & sale. Owners of these steers may participate in record book competition only.
- Exhibitors must be present for both the show and sale. If you do not show your animal, you do not sell.
- Steers may be divided into separate weight divisions for the show depending on the number of entries.
- Show and Sale Grooming area before and during the show will be open to exhibitors working on animals. Juniors and Intermediates may have one (1) parent to provide **VERBAL HELP ONLY**. Seniors may not have any help. Advisors and 4-H leaders may enter, (for safety reasons only). Exhibitors will be charged a cleanup fee if their work area is left unkept.
- All exhibitors will abide by State of Florida Livestock Health Regulations and Requirements listed on the Clay County Fair website. A health certificate is required to accompany the animal to the fairgrounds. Must be issued by a vet.

- Junior, Intermediate and Senior exhibitors may participate in Showmanship competition.
- Juniors are 11 years of age and under as of September 1, 2023. Intermediates are 12-13 years of ages of September 1, 2023. Seniors are 14-18 years of age as of September 1,2023.
- You can only show the tagged steer from the mandatory meeting, December 3, 2023 for showmanship. No sharing of animals and no non tagged market animals are allowed for the showmanship show.
- Sale receipts will be handled by the Clay County Fair office.

AUCTION / SALE:

IT IS THE RESPONSIBILITY OF THE EXHIBITOR TO FIND A BUYER FOR HIS/HER ANIMAL

- All steers qualifying will participate in the sale and must go to slaughter.
- Maximum steer sale weight is 1275 pounds. Any steer weighing over 1275 lbs. will be sold as weighing 1275 lbs.
- The Clay County Fair Association is not responsible for providing buyers. **Exhibitors should not solicit fair vendors as potential buyers.** It is your responsibility to keep track of your livestock buyer's information. It is not the responsibility of the fair office to provide this information.
- Multi-Buyer(s) Form (One Animal per sheet)
- Please complete ALL information in full including Email for billing purposes
 (Please use pen or pencil to complete the form. NO Markers) Your buyers will be billed for their
 purchase by email listed on the multi-buyers' form, from karen@claycountyfair.org or
 info@claycountyfair.org. Bill must be paid by June 30, 2024
 Please do not list any buyers under \$1.00 (Anything below \$25 a pound the participant is
 - <u>Please do not list any buyers under \$1.00</u> (Anything below \$.25 a pound the participant is responsible for collecting.)
- All steer will be sold to the highest bidder, and all animals must be slaughtered following the sale.
- Three Percent (3%) will be deducted from the total sale of the animal and put in the Livestock Fund. This will be used to bring any sale animal up to minimum sale price or to buy a sale animal that has received no bids. The minimum sale price will be determined at the sale by the Clay County Agricultural Fair Livestock Director. If the expense does not exceed the 3% income for that year, the remaining 3% balance will remain in the livestock account. Excess money will be used for the same purposes in future Clay County Agricultural Fairs. Other expenses such as the hauling fee, Buyer Dinner expenses and the Auctioneer fee will be deducted from this account; any other expenses may be deducted from this account only by the Livestock Director and approved by the CCFA Board of Directors.

HOMEGROWN DIVISION:

• To participate in the Homegrown Division animal must have been born within the boundaries of Clay County Florida.

"THE CLAY COUNTY FAIR ASSOCIATION "LIVESTOCK DIRECTOR AND THE CCFA BOARD OF DIRECTORS" The Livestock Director and the CCFA board of Directors will have the final judgment in regard to the interpretation of all rules and regulations. During the creating/typing/printing of these rules, changes, errors, deletions, or omissions may occur, in which case the "Clay County Fair Association" reserves the right to construe its own rules and regulations, and to decide all matters and differences in regards thereto including amendments. The Clay County Fair Association also reserves the right to refuse exhibitors.

AWARDS:

All animals will be graded by the Judge by the Modified Danish System. They will be awarded a Blue, Red or White Ribbon, and receive premium money in each division.

Awards will be presented at the Barn, Saturday, April 13, 2024 @ 6:00 PM.

All premium award money will be forfeited if not collected by the end of the Fair.

AFTER THE FAIR:

- Agricultural Fair Office no later than the close of the business day (4:00 PM) Friday, May 3, 2024. Any Record Books received after this date or not complete will result in the 4-H/FFA Exhibitor being fined a \$100.00 penalty from their final check that will be put into the 3% Livestock fund and they will have to go into the drawing for the next year. The exhibitor will sign in at the fair office acknowledging their book is at the fair office. After all books are received, the swine and steer superintendents will turn all 4-H books over to the 4-H office which will complete the fair project. FFA books are returned to each FFA participant. Write thank you letters to all buyer(s) and turn them in with your project book in an addressed, stamped, sealed envelope. The Fair Association will mail the letters. It is your responsibility to keep track of your livestock buyer's information. It is not the responsibility of the fair office to provide this information. An exhibitor who met all requirements on time and meet all current Clay County Fair requirements will be eligible for the same animal project. (Participant can have the option to switch programs one time only.)
- **BUYER PLAQUES:** Plaques must be picked up from the Fair Office **after** May 27, 2024 by the exhibitor or parent and delivered to their buyer(s). A Livestock Buyer Follow up Form must be completed when delivering the plaque and returned to the Fair Office when you are picking up your check. If a correction has to be made on a plaque, the participant could be responsible for the price of the replacement.
 - An email will be sent out to notify you that the Buyer Plaques are ready for pick-up.
- Checks: Checks will not be issued until after June 17, 2024 providing "ALL" Livestock Buyer payments have been received. If anyone of your buyers do not pay their bid amount it will be deducted from your check. An email will be sent out to notify you that the checks are ready for pick-up. No checks will be disbursed until all requirements have been completed. Checks will only be given to exhibitors with proper identification, such as photo ID, Fair ID Badge or 4-H/FFA card. Parents listed on application may pick up checks with proper ID. ****The steer project requires that all checks must be deposited within 30 days of receipt. If a check is not deposited within this timeframe the checks will be voided and your slot in the next year's show & sale will be jeopardized.
