- Revised Rental Form –Kassie will make changes to the form to add the pole barn and will present at the next work session for approval.
- Maintenance Report Butch moved the container for fuel per the Fire Marshall Dahlgren's will donate a portion
 of the cost of materials to repair the poultry, and sheep barns we will recognize that as in-kind sponsorship.
 There were electrical problems during the QMRA, kids were driving around in a golf cart who turned off electrical
 power. all the food in the refrigerator in office kitchen was ruined water all over floor. they are now locking
 all the gates between the different areas.
