RULES:

ATTIRE: Long Sleeve Shirts, Jeans, Hard Soled Shoes (NO SHORTS, TANK TOPS, FLIP FLOPS)
ROUGH STOCK: SAFETY EQUIPMENT IS NOT PROVIDED. Contestant must provide their own helmet and vest if they so choose to wear one.
ROUGH STOCK: RIGGING NOT PROVIDED. Contestant must provide their own
ROUGH STOCK: Contestant must attempt to get on animal in a timely manner once their name is called and the committee is at their chute. Contestants will get one refusal. If contestant refuses second time the contestant will be disqualified and there will be no refund. Judges decision is final.
ROPING/DAUBING: There will be a 30 second time limit.

PARTICIPANT RELEASE / CONSENT FORM

AGREEMENT: In consideration for being allowed to participate in the Columbia County Fair 2022 Junior Rodeo, the above-named Participant and Participant's parents/guardians agree to the following.

ACKNOWLEDGEMENT OF RISK: the Participant and Participant's parents/guardians understand, acknowledge and accept that rodeos are dangerous activities and that the participation in a rodeo, including the Columbia County Fair 2022 Junior Rodeo, either as a contestant, an employee or volunteer, exposes the Participant to a substantial and serious risk of property damage, personal injury and/or death.

RELEASE: The Participant and Participant's parents/guardians, being fully aware that participation in the Columbia County Fair 2022 Junior Rodeo will expose him/her to a substantial and serious risk of property damage, personal injury and/or death, hereby waive, release and discharge Columbia County, the Columbia County Fair Board and their offices, agents and employees, from any and all liability for any and all property damage, personal injuries and/or death, or any and all other claims, whether known foreseen and unforeseen, future or contingent, arising from the Participant's participation in the Columbia County Fair 2022 Junior Rodeo.

COVENANT NOT TO SUE: The Participant and Participant's parents/guardians covenant that the Participant and Participant's parents/guardian shall not now or at any time in the future, directly or indirectly, commence or prosecute any action, suit or other proceeding against Columbia County, the Columbia County Fair Board and their offices, agents and employees, concerning, arising out of, or related to the actions, causes of actions, claims and demands hereby waived, released and discharged.

ASSURANCES: The Participant and Participant's parents/guardians assure, represent and warrant that they have full power, authority, capacity and right without limitation to execute, deliver and perform this Release on behalf of the Participant and Participant's parents/guardians.

NAME AND LIKENESS: The Participant and Participant's parents/guardians hereby give die Columbia County Fair permission to use the above-named Participant's name and photographic likeness, in connection with his/her participation in the Columbia County Fair 2022 Junior Rodeo, for advertising or any other lawful purpose.
