- **Pants, long-sleeve shirts & sturdy shoes are required.**
- **Helmets are not required but highly recommended. Please bring your own as none will be provided.**
- This is an exhibition event, so dress to please the crowds! *Western attire is encouraged!*
- The participant and one (1) adult only will be allowed in chute area.
- Proof of age and weight may be required at sign-in. A scale will be provided.
- There will be two (2) qualifying classes. The first class will be ages 4-5 and the second class will be ages 6-7 years old.
- Rides will be judged by time and distance of ride (30 foot chalk line). Decision of the judges is final. The top 3 rides for each age group will place.
- Finalists for each age group will be awarded with a belt buckle.
- Please arrive at 9:30 am on Saturday to check in.

The undersigned expressly acknowledges that participation or his child's participation in any rodeo event will involve such hazards.

Mindful of these facts, the undersigned, intending to be legally bound hereby, and in consideration of being allowed to participate, or being allowed to have a child participate, in the
