- Non-revenue generating events for the month of October: Crooked River Roundup meeting in Lookout Mtn Building, Sherriff's office borrowed the dunk tank, tables & chairs for Faith and Blue, FFA leadership dinner in CFH, BTI training in the event parking, Town Hall meeting in Carey Foster.
