DAKOTA COUNTY FAIR - CAMPING AGREEMENT 2021

Dakota County Agricultural Society, Inc. owns and operates the Dakota County Fairgrounds property. The primary purpose of this investment and operation is to provide a place with accommodations for the annual Dakota County Fair function. During the week of the Fair, some camping is available near the Horse Arena in the designated campground area.

Use of short term space will only be permitted to those users who can provide additional accommodations, should they be necessary, to meet State of Minnesota "camp site" regulations. Tents are allowed only during special events.

Registration must be provided before entry into the grounds. Camping is limited and registration forms are available through the Fair Office. All camping applications must be submitted to Fair Office by 4:30pm on August 8, 2021. Campsite selection will be made through a 'lottery-type' drawing. If you pay by check and it does not clear, you will not be eligible for the lottery. Registering individual must be 18 years of age or older. **An adult must accompany children under the age of 18 at all times.**

Check-In time is Friday August 13th after 12pm at the entry booth

For the safety of all people and livestock, no vehicles are allowed in the camping area other than one in front of designated site. Vehicles must park in designated parking lots. No horses are allowed behind fencing in tent area on Southeast end behind sectioned off area. Absolutely NO exercising or riding of horses allowed outside the main arena, warm-up arena or round pen!

Quiet time is 10:00 PM to 7:00 AM. Please be courteous to others if you do not have a "quiet" Generator and run it only during Non Quiet Times posted. Generators may be ran 24/7 with a signed Medical release from your Doctor. This release needs to be handed in with your application to the Fair Office.

NO CAMPFIRES ARE ALLOWED ON THE FAIRGROUNDS unless written permission is given from Fair Office.

Bicycles, Minibikes, dirt bikes, three and four wheelers, golf carts or similar vehicles are prohibited.

Firearms, firecrackers and sparklers of any kind are not allowed on the grounds.

Pets are **NOT** allowed on the grounds during the week of the Fair, August 5-11, 2019.

Sites must be kept clean; site users must furnish refuse bags and dispose of all refuse in provided containers. Dishes may not be washed in restrooms; site users shall clean showers and other areas of bathroom after use.

Be courteous to neighbors. Vehicle maintenance is not permitted. No car, RV or trailer washing Functions not depicted as appropriate for site use is prohibited. Determination of appropriate use is sole discretion of the Fair Board.

OBSERVE 10 MPH speed limit at all times.

DAMAGE TO property or necessary cleanup will be the expense of the site user.

Non-Compliance with any of the above regulations will result in removal from the grounds.
