**POLICY AND PROCEDURE**

Current Dane County Fair Board of Director members who have completed at least one two-year term on the Board of Directors are eligible to serve as an Executive Committee member on the Dane County Fair Association Board of Directors. The nominee must agree to certain terms to include adherence to the Fair Association’s Articles of Incorporation, By-Laws, Code of Ethics, and term requirements noted below.

**Executive Committee nomination forms are due no later than September 1 of each year.** The Dane County Fair Association retains final approval of all selections to the Executive Committee. Application review and selection is performed by the Fair Nomination Committee and final election is done in November by the currently seated Dane County Fair Association Board of Directors. Executive Committee members are elected for three-year terms and begin service at the Annual Meeting in January.
