Deschutes County owns the buildings and land, and provides these to OSU extension as part of a larger agreement. An MOU is not currently in place, but is in process

 - i. Potable Water: Provided by City of Redmond Municipal services.
 - ii. Irrigation: Provided by an on site well, pumping system and holding pond system in the center of the property.
