Public Meeting

Approval of Last Meeting Minutes

Treasurer's Report

Wes covered 2022 Fair Budget recap, stating \$607,505 total in expenses to date with a few details to be adjusted and looking to lock in final numbers by October meeting.

Dean gave credit to the group stating, "to grow this Fair and to be known as a top Fair & Rodeo in this revenue category is a success to those around the table".

Reports from other groups

Fair Foundation

- Cindy reviewed the 2022 Livestock Educational Grant Program stating that 9 total animals were awarded, 7 of which qualified to show and 5 of which qualified for the Livestock Sale. For 2023, the program has added rabbits which will bring the total animals awarded to 12. Applications for the 2023 program are due by September 30, 2022. The Grant Breakfast will be held on November 12 at the Fairgrounds and is generously sponsored by Obrien's Café. Attendance from the Fair Board is welcome.
- The annual Ghost Town Hoedown is set for October 22, 2022. Tickets are on sale now. Volunteer support in person is still needed and donation of Wine or Whisky for the pay to play events is welcome.
- The 10th Anniversary Party has been rescheduled to March 4, 2023, at the Osborne Ranch.
- The Cowboy Ball is set for May 6, 2023.
- Anniversary Buckles are available for purchase at \$250; Only 25 buckles were ordered with a limited number remaining for purchase.

4-H Youth/Leaders Council

 Tori reminded the Board that Achievement Night will be in the Events Center on October 12, 2022, and everyone is invited to attend. The Leadership retreat is scheduled for October 14-16, 2022.

Regular Agenda

Staff Report

- Michelle reported that staff is finalizing Fair items from 2022 and are beginning to work on 2023. Staff is working on submitting IAFE Awards for this year. Debbie has helped an done a lot of work on them as well. The team is also working to transfer to a new CRM software, Event Pro, for year-round events. The hope is to use the new software for Fair bookings as well.
- Luanne reported that the new Event Coordinator will start on 10/5/22 and we are excited to have her.

New Business

Phil recommended to recognize and recommend the following Associate Members to the Livestock Sale Committee for 2023: Nick Candelaria, Kyle Moore, John Holst, and Patti Russell. John motioned to approve, Wes second. No discussion. All approved.

Pam reported that Debbie asked her to pass around letter sample to thank the 2022 sponsors.

Staff presented a new Committee meeting schedule to the Board. The Board reviewed the proposed committee schedule adjustments and asked that an updated schedule be sent out to Directors for final review. It was discussed that if the committee has no agenda, no meeting will be held. If the Chair of the committee is not present and has not appointed chair to conduct meeting, the meeting will be ended after 10 minutes. Chairs are asked to communicate to committee and staff if there is a cancelation. Fair Board will continue to meet every 3rd Thursday.

John Adams stated that in past there has been a struggle with how to plan meetings for the future, so he and Michelle met to go through agendas & minutes from the past year as well as the task spreadsheet. They went month by month to decide what is due each month to create an agenda - if no items due and no agenda; no need to have a meeting.

Dean discussed the policy for standing committees from the bylaws in regards to the Administrative Committee. In recent years, the Administration Committee had not been considered a Standing Committee. Phil motioned to turn the Administration Committee into a Standing Committee – Craig seconded. No discussion. All approved for the Administration Committee to be an official standing committee.

Director comments

Dean informed the Board that the 2022 debrief will hold off until the October 20 Fair Board meeting. He requested to have committee lists of pros and cons to him to review prior to the meeting and will use this list complied for the Board to discuss the top 3 areas to improve and focus on for 2023.

The Awards Committee worked hard in 2022 to standardize awards for the 4-H shows, they will be meeting with Superintendents between now and 10/20 to iron out wrinkles from this year. If you've heard feedback, please communicate that to the Awards Committee.

Rules for Citizen Engagement at Fair Board Meeting

To have orderly, efficient, civil, and productive board meetings, the following rules apply to all citizens that have a desire to address the Board:

- 1. Citizen comments will be heard during the public comment section at the board meeting.
- 2. All citizen comments must be addressed to the Board. Directing comments to staff or other members of the public is not permitted during Board meetings.
- 3. Public comment section is limited to ten minutes collectively.
- 4. Citizens are asked not to repeat comments made by others; merely indicate their concurrence.
- 5. Citizens will be asked to use a microphone so that Board members and the audience can hear their comments
- 6. Clapping, cheering, booing and the like are not permitted at Board meetings.
- 7. Failure to abide by the aforementioned rules of engagement is considered disruptive to the public process and will result in a warning to the violation citizen(s) by the Board Chair. If after that warning the citizen(s) continues to violate these rules, they will be asked to leave the meeting. If the citizen does not leave the meeting when asked, the appropriate steps will be taken by the Board Chair to have them removed from the meeting.
