## Staff review of

**Carnival:** Coral Miller stated the Carnival is ready for their contract and the County has begun the process. Luanne mentioned that the percentage from gross sales for the Fair will be 10% rather than 20% from previous years. This might be able to be renegotiated next year.

**Concert:** No new updates on concert. Offers have been made and we are awaiting a response.

Tim Hallmark discussed if a wider door could be made onto Kirk Hall.

**Judges:** Ben, Hayden, Michelle and Rob are currently working on judges.

**Review open items on task spreadsheet:** Dean Elliott requested that the committees review their task sheet regularly to confirm that everything is getting done when it needs to.
