

DOUGLAS COUNTY FAIR BOARD- LIVESTOCK SALE COMMITTEE MEETING WEDNESDAY, JANUARY 8, 2020 AT 6:30 PM FAIRGROUNDS EVENTS CENTER CONFERENCE ROOM AGENDA

Meeting

Attendance: Sarah Fischer, Wes Jacobs, Pat Candelaria, Nick Candelaria, John Holst, Michelle Bartlett, Luanne Lee, Phil Riesselman, John Woodrick.

Animal Numbers: Wes gave a summary of the number of animals, buyers, records and addons for the 2019 sale. Discussion was had about how the committee would like to display add-ons, either by quantity or amount given. John Holst brought up the idea that this would foster "competition" and hopefully get people to donate more to the kids. The decision was made to display this as two corrugated plastic signs with 1) anyone who has donated \$2,500 or more and 2) anyone who has donated to 20 kids or more.

There was discussion about wanting more goats in the sale. Phil expressed his concern that they all are donated back and go to market and no one wants to buy them to eat.

Catering: The committee has decided to go with Plum Creek Catering for the Buyer's BBQ.

Photographer: The committee would like to explore the option of using a different photographer.

Giveaway Options: The committee is looking into other options besides a tractor. Some ideas for other options include: another piece of equipment such as a snow blower, log splitter, etc. The committee would still like to pursue the same sponsor but look at a different option. The idea was brought up of potentially giving away two items. This would give buyers more opportunities to win. Phil asked the committee members to bring ideas to next meeting. Phil is going to reach out to Potestio Brothers (sponsor) about different options.
