FFA GENERAL RULES:

All entries in this division must be from SAE (supervised agricultural experience) Projects carried on as a part of the regular high school Agriculture Science and Technology Program and FFA. FFA members may compete in the department including selling of a market animal no later than the sale/fair held the same year as their high school graduation.

All projects are the liability of the student and family. Personal insurance will be held liable if there is any accident or incident, regardless of location. The individual school districts, FFA chapters, and the Douglas County Fairgrounds are not responsible in the case of an accident.

1. All animal exhibits must be in the possession and care of the FFA member exhibiting the animal by June 1 of this year and continued through the fair. Any animals that are not owned by the exhibitor must have a lease agreement by this date as part of their records and available for review. All animal exhibits must be entered onto the FFA Entry Form available from advisors and must be submitted no later than July 1 of this year.
2. Crops are due 10am-3pm the Saturday before the fair. All other static exhibits are due in place with Exhibitor Cards by Sunday, 5pm. (Mechanics, educational displays, wool, etc.).
3. In cases where there is no competition, or entries are deemed unworthy of premiums offered, the premiums will be awarded according to the discretion of the judges. Champion of the breed/division will be awarded at the discretion of the judge.
4. No exhibitor will be permitted to enter the same animal in both 4-H and FFA.
5. All FFA livestock exhibits must be in place by the end of vet check/check in as scheduled during Fair Week. Check schedule for specific vet check times by species.
6. Each FFA livestock exhibitor is required to exhibit in the showmanship contest in each division in which they have an animal entered. No chapter-entered animals will be entered in showmanship unless a chapter member is a chapter manager and their records, business agreement, and journal show this; then this member can show the chapter animal(s) in showmanship.
7. All FFA livestock exhibitors/chapters are automatically entered in the herdsmanship contest in each division in which they have an animal entered.
8. Exhibitors will be allowed two entries in each livestock class, two in each wool class, two entries in each ag mechanics class, and one showmanship entry in each livestock division. Members having two entries in a specific livestock class may have the second animal shown by another FFA member. Each member may designate one market animal for the livestock auction. The designation must be made before the animals are weighed per the Market Auction rules.
9. Each exhibitor is responsible for having their exhibit in the ring or other proper place designated when the class is called for, the exhibit to be judged or sold. It is their responsibility to familiarize themselves with the class name and number of each entry they intend to show. If they do not have the entry in the proper place at the proper time for judging, the entry will not be allowed to compete.
10. Dress - All FFA exhibitors will be required to wear appropriate clothing while exhibiting their entries and at the awards ceremony. This attire would include the following items:
 - An FFA jacket, white collared shirt, and FFA tie or scarf
 - Black jeans, pants, or skirts (if appropriate).
 - Proper black foot wear
 - All items should be clean and worn in good taste.

12. The FFA Superintendent, Assistant FFA Superintendent and FFA Department Superintendent have the authority to make any decisions necessary on questions of interpretations on rules of that department.
13. The County Fair Board and FFA advisors shall make all interpretations on these FFA General Rules.
14. The local chapters have the right to enforce additional requirements.
15. All FFA exhibitors, in order to exhibit in their division, must be under the direct supervision of their agricultural science & technology classroom instructor/FFA advisor, who must be onsite daily for the duration of Fair.

Note: General Rules For All Fair Exhibitors and General Livestock Rules are found at the end of this Premium Book (see Table of Contents). All FFA exhibitors will follow all Fair rules, guidelines, and Market Auction Guidelines when appropriate. Failure to do so may result in loss of premiums, and dismissal from fair and/or market auction.

PREMIER CHAPTER AWARD

The purpose of this award is to encourage FFA members to participate in all Departments. The winner of this award will be based on the ranking of each chapter in all Departments listed in this Premium Book.

BRED & FED RECOGNITION

The purpose of this recognition is to highlight those students who are exhibiting livestock that are the result of their own breeding livestock SAE.

Members who exhibit Bred & Fed animals will be presented with an exclusive stall sign that recognizes the achievements of their animal SAE. In order to qualify as 'Bred & Fed', the following must be true:

- 1) The animal being exhibited has been under the management and care of the member since birth.
- 2) The dam of the animal being exhibited was owned, managed, and part of an active SAE of that member and was entered into the FFA recordbook at the time of parturition. If the dam was owned by another person (relative/etc) it does not qualify.
- 3) Both criteria will be verified and approved by the FFA advisor at the time of registration.

DIVISION 2200: Herdsmanship Contest

The contest is conducted on a chapter basis. All FFA livestock exhibits are automatically entered. A suggested scoring is outline below and may change depending on the herdsmanship judge.

Basis for Scoring

Animals	40 Points	Animals must be clean, comfortable, and regularly fed and watered. Pens must be neat. Animals must be securely and safely tied or penned.
Barns/Kennels	40 Points	Equipment, feed, and supplies must be neatly arranged, clean, and safe. Alleys, stalls, and pens must be neat and properly bedded. Stall cards must be neat and easy to read.
Educational Component/Club Member	20 Points	Exhibitors should show good attitude, cooperation, courtesy, and friendliness. Youth must handle their own animals and complete their own work. Members should demonstrate skill in animal handling. Chapter decorations should include an educational component.
POSSIBLE SCORE	100 Points	

Awards presented to the top chapter exhibiting beef, sheep, dairy cattle, rabbits, goat, poultry, and swine. Awards are provided and sponsored by the Douglas County Fair in the form of a \$50 gift card for one of the local farm stores.

PREMIER LIVESTOCK EXHIBITORS

The purpose of this award is to encourage FFA members to raise and show quality breeding stock. This award will be given to the individual FFA member that has the best breeding exhibit in beef, sheep, swine, goat, rabbit, poultry and dairy cattle. In order for an FFA member to be eligible for this award, they must 1) show two or more breeding animals, 2) show good citizenship, 3) do a good job on herdsmanship, and 4) do a good job on showmanship. All animals must be clean and properly fit to be eligible. The Department Superintendent will have the responsibility of determining which animals qualify. The winner will be selected on a total point basis as follows:

- A. Conformation places (not counting group classes) points: 1st-20; 2nd-16; 3rd-12; 4th-8; 5th-7.
 - B. Each Champion Rosette receives an additional 20 points. Reserve Champion Rosette receives an additional 16 points.
 - C. Showmanship Placing Points: 1st-10; 2nd-9; 3rd-8; 4th-7; 5th-6; 6th-5; 7th-4; 8th-3; 9th-2; 10th-1. Experience level (adv, beg, nov) Champion - 10pt, Res Champion - 8pt.
 - D. Herdsmanship Placing (as chapter) Points: 1st-30; 2nd- 28; 3rd- 26; 4th-24; 5th-22; 6th-20; 7th-18; 8th-16; 9th-14; 10th-12; 11th-10; 12th-8; 13th-6; 14th-4; 15th-2.

4-H/FFA EXHIBITORS RULES AND REGULATIONS

DOUGLAS COUNTY 4-H/FFA SHOWRING CODE OF PRACTICE DOUGLAS COUNTY GUIDELINES

The following is a listing of guidelines all exhibitors must follow to enter any animal at organized competitive events.

1. All exhibitors must have viable proof of ownership or viable leases, if appropriate, available to Fair and Livestock show officials at their request. Documents should include current ownership information, transfer of ownership (if any), length of ownership, and age of animal(s). Misrepresentation of ownership, age, breed, or any facts relating thereto is prohibited. Exhibitors and their agents - advisors agree to comply with the printed show rules upon entry. This is in compliance with #1 and #2 of the Oregon 4-H Animal Science Ethical Standards.
 - a. No exhibitor may show a market animal which has been previously sold at an auction or sale as a market animal through another Fair or Livestock show, whether or not there is an actual change of ownership (progress level shows excluded).
 - b. Any method used to misrepresent the age of an animal for a class in which it is shown is deceptive and prohibited.
 - c. Showing an animal for another individual by claiming ownership to show in a specific livestock class or event is prohibited. The Barn Superintendent, FFA Advisor, and 4-H Program Coordinator will be notified, and the exhibitor and the animal will be disqualified.
2. All handling, care, and fitting must be done by a **Douglas County 4-H or FFA member**.
 - a. Because of the educational nature of livestock shows, parents, leaders, and/or other persons may give **VERBAL** assistance in the preparation of livestock for show. Involvement of adults must be limited to: advising, holding a lead temporarily, opening and closing gates, and intervening if animals or a situation becomes unsafe.
 - b. Adults are NOT allowed to: feed, lead/carry, groom, wash, tack, clean stalls, or generally care for the exhibits. If outside (parental or other adult) help occurs, the Barn Superintendent and 4-H Program Coordinator will be notified, and the exhibitor and animal will be disqualified.
 - c. Compliance with #3 of the Oregon 4-H Animal Science Ethical Standards is required.
 - d. Normal care given during barn duty may be coordinated with other members to cooperate to ensure proper husbandry. This is considered an allowable exception.
 - e. 4-H and FFA members in good standing in Douglas County may **ASSIST** each other.
3. Show Ring Dress Code for exhibitors is as follows:
 - a. Exhibitors should be neat and clean with hair combed and shirts tucked in.
 - b. No hats of any kind are permitted in the show ring with the exception of horse exhibitors.
 - c. Exhibitors should be wearing long pants.
 - d. Cell phones are not appropriate for the show ring and are not allowed.
 - e. Appropriate hard-soled shoes (Romeos or boots) should be worn at all times around cattle and horses.
 - f. Exhibitors should not be chewing gum or eating in the show and/or sale ring.
 - g. Clothing must be free of references or symbolism to drugs, alcohol, weapons, profanity,

violence, or discrimination. All other shirts or attire may not display writing, logos, or emblems larger than 2x2 inches.

4. Market Auction Dresscode is addressed in the Market Auction Guidelines. See #21 of the Market Auction Guidelines for more information.
5. Use of tranquilizers, sedatives, or any other drugs that alter the physical or physiological state of the animals is prohibited. If an exhibitor suspects drugs and/or medications are being administered to an animal, they must bring the following information (if possible) to the Barn Superintendent: The name of the drug, its purpose, the person who administered the drug, and the date and time the drug was administered. This is in compliance with #4 of the Oregon 4-H Animal Science Ethical Standards.
 - a. Off products specifically designated for use in livestock may be administered with prior approval from the barn superintendent and/or a veterinary prescription.
 - b. Market animals and animals whose produce products that will enter the food chain for human consumption (meat-producing animals, dairy animals producing milk, and poultry producing eggs) must follow the medication withdrawal time protocol.
 - c. During livestock events, if an animal requires treatment, Barn Superintendents need to be notified immediately, and all medications, including off label (extra-label) products, shall be administered by or under the supervision of a licensed veterinarian.
6. Any surgical procedure or injection of any foreign substance or drug or external application of a substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, conformation, or appearance is prohibited.
 - a. Surgical procedures used in generally accepted animal health practices performed previous to the event for the sole purpose of protecting the health and usability of the animal is allowed. This is in compliance with #5 of the Oregon 4-H Animal Science Ethical Standards
7. Substances used for practical cleaning purposes, external applications of substances to the hooves or horns of animals which affect appearance only, and other hair grooming products prescribed for use on animals are allowed unless prohibited in the Fair rules and/or rules for a specific event. Any directions, indications, healing, and withdrawal times for products and procedures must be followed. This is in compliance with #5 of the Oregon 4-H Animal Science Ethical Standards
8. The use of inhumane showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivances, or other similar practices are not acceptable and are prohibited. This is in compliance with #6 of the Oregon 4-H Animal Science Ethical Standards
 - a. Other practices, unless under the written authority of a licensed veterinarian, that are not acceptable or prohibited include, but are not limited to, liquid diets for lambs, excessive shrinking, excessive exercising, tying animals with their feet off the ground, icing animals down, and electric stimulation.
9. The balancing of the udder by abnormal means that includes the use of a mechanical contrivance or the injection of fluid or drugs, setting the teats, and/or occluding with a mechanical contrivance or the use of chemical preparation is prohibited. Treating or massaging the udder or its attachments with an irritant or counter-irritant is prohibited.
10. Direct criticism or interference with the judge, Fair or Livestock Show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, Fair and Livestock Show management, or other

officials shall be treated with courtesy, cooperation, and respect, and no person shall direct abusive or threatening conduct toward them. This is in compliance with #7 of the Oregon 4-H Animal Science Ethical Standards

11. No person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons, either by affirmative action or inaction, to violate this code of ethics. Violations of this rule shall subject such individuals to disciplinary action, including but not limited to immediate disqualification of the youth exhibitor and removal from the Fair. This is in compliance with #8 of the Oregon 4-H Animal Science Ethical Standards
12. Barn Superintendents and 4-H Program Coordinator reserve the right to require animal health certificates. Health inspections and diagnostic tests may be made before or after the animals are on the livestock show premises for exhibitor and animal safety, or to implement disease control procedures, which may become necessary in emergencies as determined by animal health officials.
13. All grievances are to be submitted in written form to the 4-H Office for further review. See Barn Superintendents and/or 4-H Program Coordinator for forms. This is in compliance with #1 and #2 of the Oregon 4-H Animal Science Ethical Standards
14. The expectation is that everyone – exhibitors, parents, volunteers, and staff – treat one another with respect and care. This event is a place for youth to grow and learn, and adults are role models in that process. Any threats – verbal, written, or physical – toward show management, 4-H or FFA staff, or volunteers will not be tolerated. This includes threats made by youth, family members, leaders, or others. Such actions will result in immediate disqualification and removal of the exhibitor and their animal from the premises. Market animals will no longer be eligible for the Junior Livestock Auction.

GENERAL RULES FOR ALL EXHIBITORS

1. **ELIGIBILITY** - All residents of Douglas County are eligible to exhibit. Other Oregon Counties may enter in all departments except School Arts & Crafts.
2. Articles completed since the 2025 Fair may be exhibited.
3. **ENTRY FORMS & FEES** - There are no fees for entering static exhibits in the Douglas County Fair; with the exception of Livestock departments and 4H youth department. 4-H does not have fair entry fees, but all enrolled 4-H leaders and youth (with an exhibit entered in lamb show or fair) aged 13 and over will have the option to purchase a 4-day fair entry pass for \$10. Please bring your items to the Exhibit Building on the entry day for your department. All paperwork will be completed when you arrive; no pre-registration necessary for Open Class. 4H and FFA have additional requirements for pre-registration. Please reference the Open Class Schedule on page 6 or the rules for specific departments to find the entry day and time. If you are unable to bring entries in person to the fairgrounds, they may be mailed to 2110 SW Frear Street, Roseburg, OR 97471. Articles must arrive at the Fairgrounds Complex by noon on Friday prior to the opening of the Fair.

The entry fee for Open Class Livestock (per animal) is \$5 for beef or dairy cattle and \$3 for goats or sheep.

4. **ENTRIES** - The same animal, article, or duplicate article (i.e. cookies or photos) cannot be exhibited in both 4-H and FFA. 4-H and FFA participants may show the same animal or duplicate static exhibit in Open Class divisions. Members must assume responsibility to meet all Open Class requirements; you must have two static exhibits so items can be displayed in both Open Class and in 4-H or FFA displays.

In the following departments, exhibitors are allowed to enter **up to two items in any one class**: Textiles, Art, Crafts, and Photography.

5. **OWNERSHIP** - All articles or animals must be entered in the name of the owner or maker.
6. **EXHIBITORS** - An exhibitor found in violations of rules or in practices unethical or adverse to the Douglas County Fair, shall be penalized by forfeiture of premiums and/or privileges and be subject to such penalty as the Fair Management Team may order. Exhibitors that are involved in water fights, throwing of water, disturbing of any exhibits may result in all premiums being forfeited.
7. **RESPONSIBILITY OF ALL EXHIBITORS** - All exhibits will be under the control and direction of the Fair Board, but the Fair will in no case be responsible for any loss or damage that may occur, and each exhibitor will waive any right or subrogation against the Fair where permissible, under any contract of insurance owned by him. The Fair's public liability does not cover exhibitors; therefore, each exhibitor is responsible for any loss, injury or damage done to, or occasioned by or arising from, any animal or article exhibited or owned by him, and shall save, free and harmless, the Fair, its officers, board and employees, from any claims for damage or loss, either to person or property, from all and every cause whatsoever.
8. **MANAGEMENT** - The Fair Board reserves to itself the right to accept or reject any entry for sufficient cause. All disputes in competition must be made in writing to the Division Superintendent.
9. **RULES INTERPRETATION** - The Fair Board reserves the final and absolute right to interpret these rules and regulations and arbitrarily settle and determine all matters, questions, or differences in regard thereto or otherwise arising out of, or in connection with, or incident to the Fair, except as otherwise specified herein.
10. **PRESERVATION OF EXHIBITS** - The Fair Board will use every precaution in its power for the safe preservation of all articles and stock on exhibition, but cannot be responsible for loss or damage, or for disease developing in transit or at the Fairgrounds. No individual, superintendent, staff personnel or other exhibitor shall tamper with an exhibit without permission from the owner of that exhibit.
11. **VENDOR/SOLICITOR** - No roving vendor or solicitor, acting for either profit or non-profit organization or on his own behalf, shall be permitted on the Fairgrounds.

12. **DISTRIBUTION/SALES** -Any person wishing to sell any item to support his or her own interest or the interest of any profit or non-profit organization or to distribute any gift, sample, coupon or merchandise must first obtain a booth, stand or designated area from the Fair Complex office.
13. **DOMESTIC ANIMALS** - Dogs or cats will not be permitted on the Fairgrounds during the Fair, including entry days. (Exception: Licensed service animal, animal attractions or exhibits and dogs entered in 4-H competition.)
14. **ALCOHOL** beverages will not be permitted on the Fairgrounds, except those sold by authorized concessionaires. **ALCOHOL IS PROHIBITED** in the carnival area, commercial buildings including Douglas Hall, Conference Hall, Floral Building, Exhibit Building, and the agricultural buildings, including Pavilion, River Arena, cattle, horse and small animal barns. Alcohol Monitors will patrol for enforcement.
15. **SUPERINTENDENTS** - Each superintendent, under the direction of the appropriate supervisor, shall have full charge of the department to which he or she may be assigned, and exhibitors must follow his or her order relating to placing of exhibits, showing, etc.
16. **ALL ATTENDANTS AT EXHIBITS** must be neatly attired and conduct themselves in a quiet and orderly manner.
17. **ALL EXHIBITS WHEN ASSIGNED SPACE** become subject to the control of the department superintendent.
18. **JUDGING** - No person shall be allowed to interfere with judges or staff during the judging. Violators of this rule shall be excluded immediately from the judging area and from competition, and be subject to such additional penalties, including cancellation of awards, as Fair Management may consider proper.
19. **EXHIBIT DISQUALIFICATION** - A judge may disqualify any exhibit not of show quality.
20. **JUDGE SYSTEM** – In general, the single judge system is the policy of this show, and in every case the judge will be selected with the utmost care. 4-H Exhibits are judged using the Danish Merit System. FFA exhibits are judged using the single judge system, with the exception of Market Animals and crops which use the Danish Merit System.
21. **JUDGES DECISION** - The decision of the judges shall be final in all cases except where mistake, fraud, misrepresentation, or collusion, not discovered at the time of the awards, is proven. In such cases the Fair Board or such referees as may be appointed, will make the decision, from which there can be no appeal.
22. **AWARDS** - No article shall be entered in more than one class, nor shall be allowed to compete for more than one premium. {Exception Livestock} No exhibitor may be awarded more than one premium in any one class. (Exceptions: See Livestock Rules). Special awards will only be given if three or more exhibits are in the class (4-H and FFA require three or more participants); unless the judge has deemed the project as Grand Champion quality.
23. **PREMIUMS** - Shall be pro-rated if funds are not sufficient.
24. **PREMIUM PAYMENTS AND RIBBONS: Open Class** may be collected at the Exhibit Building Office on Friday, of Fair from 4 p.m. to 10 p.m., Saturday of Fair from 9 a.m. - 10 p.m. and Sunday of Fair week from 8 a.m. to 12:00 p.m. [4-H & FFA check with your leader or advisor for Premium Payout Information](#). Open Class premiums will be available for payment in the Fair office during the week immediately following Fair: Monday-Friday from 8 a.m. to 4 p.m. Any premiums not picked up by the Friday following Fair will be forfeited. No premiums will be mailed.
25. **DONOR AWARDS** - The Fair Board is not responsible for awards from private donors, although all reasonable care will be taken to insure that winners receive such awards.
26. **RELEASE OF EXHIBITS** - No article shall be withdrawn before the close of Fair.
27. **RELEASE TIME** for all exhibits shall be Sunday of Fair between the hours of 8:00 a.m. and 12:00 p.m. Livestock may be removed at 6:00 a.m.
28. **EARLY REMOVAL** before release time and date may cause forfeiture of all premiums won.

29. **ENTRIES PICK-UP DEADLINE** - The Fair cannot be responsible for entries left after four days after the close of Fair, except when arrangements have been made to keep them longer. Perishable items will be disposed of if not picked up by Monday morning following fair.
30. **SECURITY** - The Douglas County Fair will have security officers on the grounds and will use every reasonable precaution in its power for the preservation and protection of persons, article on exhibition, livestock and property, but will not be responsible for loss or damage by theft or fire or assume any liability for accidents to persons on property.
31. **FIRE PROTECTION** - All matters of fire protection are under the direct supervision of the Douglas County Fire District 2. The Douglas County Fair will use precaution to guard against fire but will not be responsible for any losses occasioned by fire or damage by water.

GENERAL LIVESTOCK RULES OPEN CLASS / 4-H / FFA

Rules and regulations relating to Livestock entries. Also read General Rules for all Exhibitors.

Rules and regulations relating to Livestock entries. Also, read the General Rules for all Exhibitors.

1. **Entries** - The Fair Board reserves the right to refuse acceptance of entries from any prospective exhibitor and reserves the right to return entries after available pens and space in buildings have been taken. Entries may be limited if space dictates. The same animal, article, or duplicate article (i.e., cookies or photos) cannot be exhibited in both 4-H and FFA.
2. **Open Class** - 4-H and FFA participants may show the same animal or duplicate static exhibit in Open Class divisions. Members must assume responsibility to meet all Open Class requirements; you must have two static exhibits so items can be displayed in both Open Class and in 4-H or FFA displays.
3. **Ownership** - Every animal shall be entered in the name of the owner or lessee.
4. **Entry Changes** - No person having entered anything for the competition will be allowed to withdraw or change the entry after the opening day of the show. Substitutions may be accepted in the event of injury, sickness, or death of any animal that has been properly entered and accepted. Such substitutions must be prior to the date of judging.
5. **Number of Entries** – Open Class Livestock Exhibitors will not be limited as to the number of entries, but if an exhibitor wins more than two places in any one class, they may collect only 2 monies.
6. **Parking Permits for Livestock Trailers** - There will be a \$10.00 fee for a parking permit for those needing to permanently park livestock trucks, trailers, etc. during the Fair. There are a limited number of spaces available, and any item without a permit will be towed. Permits are sold through the Fairgrounds Business Office, first come, first served, and with limited parking.
7. **Livestock Delivery Passes** - are available for presale at \$35 from June 3- July 5th. Beginning July 8th, the price will be \$50 each at the Fair Office, Monday - Friday 8 a.m.—4 p.m. You must purchase one of these passes to bring a vehicle inside the gates. This Livestock Delivery pass will include general parking privileges. *ALL EXHIBITOR VEHICLES MUST BE REMOVED FROM INSIDE THE GATES BY 9 a.m.*
8. **Vehicle Entry** - through the Livestock gate, only between the hours of 5:00 a.m. and 9:00 a.m. for the purpose of feed delivery. Must have a Livestock Delivery pass to enter the gate.
9. **Parking** - Vehicles may be parked in the general parking area after 9:00 a.m. with proper parking credentials.
10. **Inside Parking** - Parking inside the gates must have a special permit from the Fair Office. All others will be towed.
11. **Qualification** - Prior to showing of animals at production sales, state or county fairs, or any other situation wherein there is a mixing of livestock, any flock or herd that is under

quarantine or on a hold order must apply for and receive written approval from the State Veterinarian prior to participating in any or all of the above-named events.

12. **Registration** - All animals must be recorded or accepted for record in the recognized books of record of their respective breeds. Exotic breeds will be accepted only with papers of dam and sire.
13. **Livestock Entry Gate** - Must use the Livestock gate only with a Livestock Delivery pass.
14. **Entry Time** - Veterinarians will be on the grounds between the hours of 8:00 a.m. to 12:00 noon on entry day to check all animals in questionable health and to collect test papers for appropriate animals. No animal may be unloaded except during these hours. Exception for Swine – entries are from 6am – 12pm and Horses 5pm – 6pm.
15. **Judging** - Animals will be shown in such a manner as the judges may require, and if the exhibitors refuse to submit to the proper requirements of the judges, their animals will be ruled out.
16. **Judging Order** - The order of showing livestock will be as listed in the premium book. All items not covered in the premium book shall be left to the decision of the Barn Superintendent.
17. **Judging Show Time** - Exhibitors will promptly lead their animals into the ring for competition when called by the Superintendent or may forfeit premiums. If you are showing in both 4-H/FFA and Open Class, you must pay attention to show time. Youth exhibitors also in 4-H and FFA will be required to do their own fitting and prepping. Assistance from county-recognized 4-H club and FFA chapter members in good standing is acceptable.
18. **Show Ring** - NO PERSON, other than those holding the animals being exhibited, will be allowed in the show ring during the time of judging, except the Superintendent of the division, the judge, clerks, officially accredited reporters, and **persons listed specifically as needed on accommodations forms.**
19. **Exhibitors Talking to the Judge** is prohibited, except when answering a question of the judge. Those who wish to discuss or explain their exhibit must do so through the Superintendent or clerk and must not interfere with the judge.
20. **Animal Control** – An assessment of unruly animals will be made by each entity (4-H, FFA, and Open Class) to determine safe protocol to verify if the animal will need to be removed for its safety and the health and/or the safety and health of the public exhibitor, and other animals. Once an animal has been released, it must be removed as quickly as possible. No released animals will be eligible to return to the current event for this show season (market or breeding). Exhibitors are liable for damage caused by animals they have entered.
21. **Animal Feed** - Each exhibitor shall furnish necessary feed for their animals and arrange for their care.
22. **Bedding** - Sawdust bedding will be provided by the Fairgrounds for all barns. Sawdust is to be used moderately. The amount used will be monitored and regulated by superintendents.

Straw will be provided by exhibitors. Any deviation from these guidelines must be discussed with the Overall Livestock Superintendent, Barn Superintendent(s), 4-H Agent(s), and FFA Advisor(s).

23. **Bedding and Manure** – All animal waste must be deposited in DESIGNATED AREAS. Bunkers are provided at either end of the horse stalls and the south end of the sheep barn for manure disposal. Anyone dumping or depositing bedding or manure in the Fair garbage containers or any other area is subject to forfeiture of premiums or disqualification in future fairs. After the fair, the horse and cattle barns will remove all their animals' bedding into the center aisle of their animals' barn before departure from the fairgrounds. If the exhibitor does not comply, they will be billed a \$50 pen/tie/stall cleaning charge. Exhibitors are expected to check out by the barn superintendents.
24. **All Livestock Areas** - Please have all livestock areas cleaned by 8:00 a.m. to allow Fairgrounds personnel time to clean the grounds.
25. **Tack/Pen Space** - is available as room allows. Stall assignment and structure of pens will not be altered without approval from the Superintendent.
26. **Decorations** - Exhibitors are encouraged to decorate their exhibit area but must have the approval of the Department Superintendent before placing such decorations.
27. **Signs** - Livestock exhibitors are permitted to display a sign over each exhibit advertising their own herd or flock. Exhibitors having livestock for sale may display one sign to each exhibit. All forms of signs or advertising must be approved by the Fair Board which reserves the right to have objectionable signs removed.
28. **Commercial Signs** – Signs advertising products such as feeds, minerals, stock, medicines, etc. will not be permitted anywhere in the livestock exhibits. Superintendents will see that this rule is enforced.
29. **Weigh In** – Market Swine weigh-in will begin at 1:30 p.m. in the Lilja Pavilion; Market Steer weigh-in following completion of vet check in the beef ring. Market Goat weigh-in will begin at 3:00pm in the south end of the livestock pavilion.
30. **Animal Health Requirements** - Douglas County is a certified brucellosis-free area, but all animals must meet state and federal health requirements. All sheep and goats must be identified (tagged or tattooed) to meet scrapie eradication requirements to be eligible to show.
31. **Veterinary Inspection** - All animals will be subject to a clinical inspection by the veterinarian in charge at the time of entry. Dogs will have a general health inspection each morning before their show begins. Any animals showing evidence of disease will be refused entry.
32. **Veterinarians** – The professional advice of local veterinarians will be considered by barn superintendents when decisions are made about an animal's admittance to the grounds.
33. **Evidence of Disease** - Any animal or bird showing evidence of contagious or infectious disease, including but not limited to, abscess, sore mouth, mastitis, foot rot, warts, boils, or

ringworm, will be refused entry into the fairgrounds and removed from the fairgrounds at the discretion of the [veterinarian](#).

34. **Sick Animals** – If an animal or bird develops a disease or health issue during the Fair, please notify the barn superintendent to begin the process to determine if the animal will need to be released.
35. **Exhibitor Financial Responsibility** – Exhibitors are responsible for veterinary care received during Fair for animals sick or injured. (Department Superintendent will make a vet call if attempts to contact the exhibitor were unsuccessful).
36. **Livestock Horns/Dehorned** - All livestock must be dehorned and properly healed. Dairy animals over 8 months of age are not to have horns. Horns will be allowed with the following stipulations:
 - a. Horns are allowed on registered breeding stock only.
 - b. Horns must be part of the breed standard.
 - c. Animal must be well-trained and controllable.
 - d. Horns on goats are strongly discouraged. All kids born after [January 1, 2025](#), must be dehorned unless breed standard dictates otherwise. Additional 4-H rules may apply.
37. **Birds** - No birds shall be vaccinated with live Newcastle disease (Pneumoencephalitis) virus or any other live virus within 45 days prior to entry.
38. **Imported Birds** - must meet full interstate requirements.
39. **Poultry** - It is recommended that all poultry be dipped/deloused before the County Fair. The State of Oregon is applying for APullorum Typhoid Free Status© from the Federal Government. One of the conditions is that ALL birds entering ANY Fair in the State must EITHER be from a N.P.I.P. flock OR be tested negative. This applies to all classes of poultry, whether it is 4-H or FFA (No open class entries for poultry). A technician will be on hand to test all birds requiring testing, that have not been previously tested.
40. **Rabbits** - All rabbits must have ear tattoo prior to coming to Fair. (No Open Class entries for rabbits.)
41. **Dogs** - Dogs in season will [only](#) be allowed to show at the Douglas County Fair [pending approval from the 4-H Dog superintendent and will be required specific requirements outlined by the s.](#) (No Open Class entries)
42. **Dog Certification** - Proof of current Rabies, DHLPP, Parvo virus, and Bordetella, vaccinations for dogs must be presented at 4-H Dog Members Registration on Saturday prior to fair from 10am – 3pm (no dogs). Certificates available at Extension Office.
43. **Horses** - It is required that all horses have the following shots after [February 15](#) and no later than [July 1](#) of the current 4-H year for both 4-H Junior Fair and County Fair: Tetanus, Eastern and Western Encephalitis, Influenza, West Nile, and Rhino Pneumonitis. Horses receiving

their first West Nile vaccination should receive two shots, 3-6 weeks apart. The second West Nile vaccination should be administered by July 1st. A certificate signed by a supplier and a vet or leader is required. Only these certificates will be accepted by veterinarian checks. Certificates are available at the Extension Office. (There are no Open Class horse entries)

44. **Release of Livestock Exhibits** - No livestock exhibit will be permitted to be removed before 6:00 a.m., Sunday of Fair week. Any exception to this rule must be with the approval and signed release form by the Open Class Exhibit Director, 4-H Program Coordinator, 4-H Education Program Assistant, Overall 4-H Livestock Superintendent, or FFA Advisor. Any animal released early will not be permitted to return to the Fair.
45. **Animal Health Release Policy** - Animals released by a veterinarian or Fair management will not be allowed to return to the fairgrounds. Veterinarian release requests must be made on-site and with the knowledge of the Fair Exhibit Office. Animal release forms are available from your overall superintendent of the appropriate division. 4-H animals released will not be eligible for the present year's State Fair competition. This policy is subject to exception only by the overall Fair Committee, consisting of the Open Class Exhibit Director, 4-H Program Coordinator, 4-H Education Program Assistant, and the Overall FFA Advisor.
