- Trailer tongues must be locked in an open position for storage
- **No Goosenecks**
- **Once your vehicle is dropped off and stored, it must remain in storage until 03/25/2022**
- ESE will retain a set of keys for stored vehicle
- \$100 a day (no later than March 28th) will apply to every item remaining after spring pick-up date (March 25) Note: Any remaining vehicles stored inside after March 25, will be removed from the building
