### **Definitions:**

*Entry Deadline:* The last date for exhibit entry in EPC Fair; 4-H member indicates intent to exhibit something at the County Fair by pre-entering information into the online Fair Entry system by the "Entry Deadline" in June.

Exhibit Drop-Off: The 4-H member/family delivers the project exhibit item(s)that have been pre-entered into the Fair Entry online system to the County Fairgrounds (Whittemore Building. Only those entries that have been pre-entered will be eligible for judging and exhibit.

**Exhibit Day:** The Friday before the County Fair opens to the public for 4-H members to interview and have their project exhibit judged. 4-H members will be assigned an interview time with the judge evaluating their project exhibit(s).

## Requirements

### COUNTY ONLY QUALIFING EXHIBITS – SELF-DETERMINED

CLASS 1001: Self-determined – Jr. CLASS 1002: Self-determined – Int.

CLASS 1003: Self-determined – Sr.

1. Exhibits will consist of the following:

2. The completed self-determined e-record (do not download from the state website as the county is using a different one) presented in a pronged folder cover.

3.ONE of the following:

- a. A display board illustrating a topic investigated during the project year. The standardized display board size of 4 ft. x 3 ft. is to be used with 4-H projects. **OR**
- b. An item that was created, built, designed, etc. by the 4-H member during the project year.

NOTE: Members may register for and submit more than one self-determined to fair. However, all projects must follow the above requirements, including an e-record for each.

Please use the e-record supplement on the county

website, not the one on the state website. This is a county project only. Self-determined projects are not eligible to progress to State Fair.

### **CLOVERBUDS**

**CLASS CLV:** Cloverbuds (Ages 5-7 as of 12/31/20) Each Cloverbud is encouraged to submit an exhibit showing what he/she learned in the program this year. Participation ribbons only will be awarded.

## Exhibit will consist of the following:

1. Story of learning experiences

- 2. Pictures of project activities (pictures may be in a scrapbook) or binder of activity sheets completed.
- 3.ONE of the following: a. A display of subject area studied. Please DO
  - NOT use a tri-fold board.
- b. Up to three items made in Cloverbud project (not to exceed 2'x2' display space).

## STATE QUALIFYING EXHIBITS

El Paso County uses the exact **same rules and class numbers** as the State Fair for our General/Tabletop/Static State Qualifying Exhibits. Please use the State Exhibit Requirements and class numbers for these projects which can be found online at:

## 1. PLEASE NOTE: Deadline for Exhibit Entry is

Friday, June 10, 2022. A member who misses the June online Fair Entry deadline must notify the CSU Extension Office immediately. The exhibitor must submit in writing to explain the extenuating circumstances Late entries will be considered on a case-by-case basis and late fee applied.

2. **Fair Entry Payments are DUE no later than** Friday, June 19, 2022. **No refunds** will be given after the June online Fair Entry payment deadline.

3. **4-H Club Member Eligibility:** Youth must be officially enrolled El Paso County 4-H club members (as indicated by registration in 4HOnline) whose project work/records are certified, up-to-date and signed by the club leader/project leader (via signature in the e-record) and enrolled as of 5/1/22, to exhibit a 4-H static exhibit at the El Paso County Fair. Youth ages 8- 18 as of 12/31/21, will exhibit for competition and possible state fair qualification. Cloverbuds (4-H youth ages 5-7 as of 12/31/20) will exhibit for participation ribbons only.

4. **Exhibit Day and Interviews:** Exhibitors will be provided an opportunity to interview with a judge on Exhibit Day (the Friday before County Fair opening day). Interview participation is highly encouraged. Interview times will be shared at drop off.

In the event an exhibitor is not able attend Exhibit Drop-Off in person, arrangements MUST be made to have the member's project(s) delivered on behalf of the 4-H member by end of Exhibit Drop-Off. The CSU Extension Office and the County Fair Office are not able to accept early exhibit items due to storage limitations.

 <u>EXHIBITS</u>: Drop-Off of exhibits is scheduled for <u>Thursday, July 14, 2022</u>, at the Whittemore building on the fairgrounds in Calhan, Colorado. Interviews will be conducted on Friday, July 15, 2022. Exhibits and placings are then open to the public on Saturday, July 16, 2022. Exhibitors are judged on project exhibit article(s), e-record & applicable manual completion. All exhibits require an up-to- date e-record (record book).

5. **4-H Age divisions** (Youth age, current 4-H year as of 12/31/21):

Cloverbud, 5 to 7 years old Junior, 8 to 10 years old Intermediate, 11 to 13 years old Senior, 14 to 18 years old.

6. Each item exhibited should be labeled to include member's name, age, project name and class (fair class entered), club name, and county. All display boards should be labeled on the back-left hand side.

 All clothing or stitched articles must have SEWN IN LABELS with the same information listed above (see #6). Clothing projects must be brought in on hangers. Hangers will not be returned.

8. Exhibitor's record books may be completed in pencil or ink, by typewriter or computer--but be consistent throughout. Member's choice will not affect judging. However, neatness is considered in the judging. Use a pronged folder for record books, *unless project specified* (*i.e. photography*). A prong folder is the preferred method for submitting an e-record. The green "4-H Member Record Book" (can be purchased from the CSU Extension Office or online via 4-H National Supply) is highly recommended. 9. Exhibitors shall exhibit in the unit they are enrolled in & entered in for the fair. Project unit enrollment errors must be brought to the attention of the CSU Extension staff person on duty immediately after the error is found. *Errors in entries could affect placings and eligibility for State Fair.* 

10. No 4-H exhibitor may enter more than one exhibit in the same class or enter the same item in more than one class.

11. Exhibits of unusual size or shape may not be on public display. Check size requirements carefully. If project is not displayed, exhibitor cards and ribbons will be displayed in project areas. All other projects will be displayed unless there is a safety, health, or space issue. Projects deemed unsuitable for public viewing due to opposition of 4-H code of conduct or policies will not be displayed. Make sure to check the <u>State Exhibit</u> <u>Guidelines</u> for sizing limits.

12. Display boards for fair must be tri-fold boards that measure 4 ft. wide x 3 ft. tall. Incorrect board sizes are not eligible to move onto State Fair. Cloverbuds classes have separate size requirements.

13. Projects (with the exception of Cloverbud Projects) will be judged by the Danish Ribbon System. All participants will receive an award ribbon based on the quality of performance/exhibit and how well standards are met.

Blue, Red & White Ribbons will be awarded. There is no set number of blue, red or white ribbons awarded in the Danish System.

- Blue Exhibit meets standards; is of high quality (well done).
- Red Exhibit meets standards and is of good quality or is of high quality and missing a minor requirement.
- White Exhibit does not meet all standards/requirements; needs improvement.

14. All exhibits will receive awards they merit, and blues or champions are not guaranteed. Even in the case of no competition, a blue or champion should not be assumed. An exhibit shall receive an award no greater than its merit justifies.

15. Champion, reserve champion, and third place (premium winners) will be selected only from the blueribbon winners in each unit or project. <u>State recognized</u>4-H project unit champions will be eligible to compete at the State Fair in Pueblo.

16. Self-Determined project unit champions are <u>not</u> eligible to compete at State Fair as county-level projects and do not have a state level competition.

17. Premiums paid as follows: Unit Champion \$5.00; Unit Reserve Champion - \$3.00; Third Premium - \$2.00.

18. Record books will be released for viewing at the end of fair and are not open to the public.

19. All exhibits, including record books, regardless of their placing, will remain in the display area for the duration of the fair. In the event that any exhibit item or display is required for participation in another event, a request must be submitted in writing to the CSU Extension Office prior to Fair Exhibit Day. The request is subject to approval.

20. Tabletop exhibits will be available for pick up until noon on Sunday, the day after the close of the County Fair. No exhibits will be released early. Members, or another designated party, are responsible for picking up their respective exhibits. There will be a sign out sheet for all projects. Instructions for pick up will be provided at drop-off.

23. Exhibiting a 4-H project item at the County Fair that is open to the general public is not without risk. Staff and volunteers extend care to protect the exhibits. And while most exhibits are returned without damage, CSU Extension and the Tabletop Committee cannot be responsible for loss or damage to exhibits.



# **4-H CONTESTS**

**CONTEST EVENTS**: Contests are separate events from exhibits. Exhibits showcase a 4-H members' work, Contests showcase applicable skills learned. See "State Qualifying Contest" below for dates, times, places, rules & appropriate entry forms/fees. Participation in a contest does not constitute as an exhibit or demonstration; therefore, state qualifying contests (Fashion Revue & Shooting Sports) cannot be substituted for public speaking county project completion requirements.

## STATE QUALIFYING CONTESTS

### FASHION REVUE

### Pre-registration required on FairEntry website.

Location: El Paso County Fairgrounds Contest Date: Wednesday, July 20, 2022 Contest check-in will begin at 2 PM Registration Deadline: Monday, June 13, 2022

Participation in this contest is optional and is not a substitute for any project completion requirement.

**Eligibility:** Contestants must be enrolled in any of the following 4-H projects: Clothing Construction STEAM 1 – STEAM 3, Recycled Clothing, Upcycle Your Style (Decorate Your Duds), Creative Clothing, Buymanship Project, Heritage Arts, or Leathercraft.

The Sewing for Others project is not eligible for Fashion Revue. Participants are to model wearable garments they have made for themselves in these projects. The section and class numbers can be found in the category descriptions in the <u>state contest requirements</u>.

#### **Requirements:**

1.Register through Fair Entry (May 31 – June 2.Submit a half page, double spaced TYPED

- commentary for each item to be modeled with the entry form or email to **Georgia Hock** NO LATER **THAN July 8, 2022.** For questions – call Georgia at 719 231-4150.
- 3.NOTE: Commentaries may be edited for content and length.

4. Clothing items must be carried in on hangers (hangers will NOT be returned) and EACH ARTICLE of clothing must have a SEWN-IN label PRIOR to check-in. Labels will consist of the competitor's name, age, project name and class entered (fair entry class) club name, and county. Labels must be attached at the neckline or at the waistband of skirts and pants. Please Note: All modeled clothing articles need to be brought to Exhibit Day for construction judging and ribbon placing as a static exhibit. Fashion Revue items are not judged for County Fair exhibit placing during the contest.

**Modeling Workshops:** Workshop dates will be announced in 4-H newsletter. <u>Competitors who have not</u> <u>previously participated in Fashion Revue should attend</u> the workshop.

### Judging Guide for Fashion Revue:

- 1.Preparation: Design and style; choice of fabric and color; overall appearance of garment; accessories; grooming.
- 2. Presentation: Appropriate for garment style; movement: walking, standing and turns; poise & posture; variety of movement: use of space and creativity; attitude and enthusiasm.
