



Elkhart County 4-H Fair Parade Rules

Parade Date: Sunday, July 25, 2021 Entries Due: Monday, July 19, 2021 by 5:00pm

With up to 30,000 people in attendance along a three-mile parade route, patience and cooperation are needed. To help everyone involved, please read, and abide by these rules as you plan for and participate in this year's parade. Any violations of these rules are subject to disqualification and removal from the parade.

ENTRY FEE

Category 3, 4, 5, 7, & 8 – \$89 Category 1, 2, & 6 – Free

ENTRY CATEGORIES

(*Judged Categories)

- 1. *4-H Club Floats from Elkhart County
- 2. *Youth & Agricultural Clubs from Elkhart County (examples: Drill Teams, Saddle Club, Girl & Boy Scouts, Boys and Girls Clubs)
- 3. Marching Bands & Musical Units- Self Contained (examples: Calliope, Square Dance Groups, Pep Bands, Etc.)
- 4. Equestrian Units (Other than 4-H)
- 5. *Open Class FLOATS or units carrying out the Parade Theme
- 6. Fraternal Organizations (examples: Shriner's, Exchange, Kiwanis, Rotary)
- 7. *Antique Automobiles & Tractors: 50 years or older
- 8. *Commercial Entries that are not carrying the Parade Theme

2021 THEME

The theme of this year's parade is "Honor the past. Celebrate the present. Embrace the future". Use imagination and good taste in creating your entry/float.



RULES

- 1. Every club/organization must prepare a 40-50 word statement to be read as your unit passes in review before the grandstand. This statement will also be used for public relations and other media. Statements should be TYPED so that the announcers can easily read them.
- 2. There will be NO RAIN DATE this year. The parade will go unless there is a State of Emergency in effect.
- 3. There is to be NO handing out or throwing of any items from ANY MOVING vehicle (motorized, horse drawn, or people powered). Handouts are allowed by responsible persons walking adjacent to respective unit preferably 8-10 feet from units and close to curb line.
- 4. Any club with motorized vehicles, including but not limited to, motorcycles, cars, tractors, and jeeps, will be limited to 12 vehicles per entry. This is done because of our staging areas are filled to capacity.

- 5. Multiple entries for the same club/organization are not allowed.
- 6. Curtailment of sirens and air horns are requested for emergency vehicles. Electronic sirens are too loud for many of the spectators along the route.
- 7. Clubs with motorized vehicles are limited to 4 sub-units. This is done because our staging areas are filled to capacity. Multiple entries for the same club are not allowed. This limit does not apply to bonafide service clubs or agricultural expositions. We also ask that commercial entries limit themselves to one tractor-trailer combination.

STAGING AND REGISTRATION

- 1. The parade will stage in the parking lots at Linway Shopping Plaza, Rogers Park, and Ares Fitness located in the general vicinity of the intersection of West Lincoln Avenue and Chicago Ave in Goshen, Indiana.
- 2. Members and Friends of the Goshen Noon Kiwanis club will be in the staging areas to help you find where to stage your float.
- 3. The parade order will be staged using a computer-generated random number, except for 4H clubs and parade dignitaries. Please do not call with special placement requests.
- 4. A registration table will be at the far west of the Linway Plaza parking lot. Registration will begin at 9:30 am. Each unit will be assigned the randomly generated ID number at registration.
- 5. The parade will step off promptly at 1:30 pm once traffic has been cleared from the streets.
- 6. The parade director will make the final decision on all parade related activities.
- 7. Please note that to help with traffic, the fair traffic directors have determined that once an entry passes by the Grandstand, it will be permitted to leave the Fairgrounds immediately through the new County Road 36 entrance ONLY. Otherwise, like previous years, entries will be held on the infield of the grandstand track after the parade. Your entry may be held there several hours. Once the incoming traffic dissipates, the fair traffic directors will allow you to leave the Fairgrounds.
- 8. The parade is a community event. In respect to the community, we need to make sure the parade keeps a steady pace. This is for the sake of all involved, including participants and spectators. Please make sure that all members of your entry, including walkers, can keep the pace of the parade. If your unit is not able to keep pace with the parade you may be asked to pull aside.

JUDGING

- 1. Judging will be done along Main Street in the Goshen Business District.
- 2. All winners will be announced at the Grandstand and awards will be presented at that time. Monetary awards can be picked up at Fair Office the following day of the parade, Monday after 12:00 noon.
- 3. Presentations before the judges stand and grandstand need to be limited to 60 seconds. After performing, your unit needs to quickly close up the gap in the parade that was created. Failure to keep your performance to 60 seconds and close up the gap shows disrespect for other parade participants and spectators.
- 4. Group 1 4-H Club Floats from Elkhart County Group 1 will be previewed at 12:30 pm. 4-H Leaders need to make sure that their club is ready for judging at 12:30 pm.

JUDGING CRITERIA FOR CATEGORY 1:

Theme Use –25 points.

How well does your float communicate the Fair's Theme?

Quality of Design – 15 points.

How well was the space used on the float? How well were colors and materials chosen?

Utilization of 4-H members – 25 Points.

Are the kids a prominent part of the float, or are they just catching a ride to the fairgrounds?

Quality of Workmanship – 20 Points.

How neat and precise was the workmanship? How good was the structural design?

Overall Presentation – 15 Points.

How well does the theme, quality of workmanship, and use of 4-H members flow together? Does the float look like a cohesive unit?

JUDGING CRITERIA FOR CATEGORIES 2, 5, 7, & 8

Floats should be decorated on both sides and display a 4-6 word theme or slogan. The name of the sponsoring organization should be conspicuous and may be either on the hood, cab, tractor or on a lower edge of your banner. Unit #'s should appear on front right side of vehicle. Numbers are assigned at parade registration.

All floats are to be at their place and assembled in the Linway or Rogers Park staging area by 12:15 pm, at which time "preliminary review" will begin. Please have all personnel who will be riding the float assembled on board float by 1:15 pm. Each club/organization should have one representative check in at the registration table between 9:30 am and 12 noon to acquire number and confirm staging location.

Judging will be based on the following criteria:

- A. Promotion of the 4-H Ideals
- B. Similarity between float Design and Parade Theme
- C. Aesthetics: Color, Materials and Workmanship
- D. Overall affect: Creativity and Originality

It is the intent of Kiwanis Club Parade Sponsors to provide adequate time for the judges to impartially review your entry. Please keep your entry in numerical order as it passes the judges and the grandstand.
