**\*\*There will not be sewer hook-ups, a pump service will be available\*\***

**You will receive a notice following the deadline if your request was accepted as space is limited. You will need to respond with the exact dimensions of your camper, length (hitch to bumper), width (including slide outs).**

**Campers will be assigned a move in time that will start Saturday August 7, 2021 with those camping for the two weeks first so the camper lot is used efficiently. If you cannot make the time assigned other arrangements will need to be made during times available.**

# Livestock Campground Guidelines

**Camping requests:** Requests only accepted online. Once the camper lot has reached the maximum amount of requests it will no longer be available online. Please call the office at (716) 649-3900 ext. 6407 for other arrangements. Spots are reserved on a first-come, first-served basis.

**Arrival:** Again, this year there will be adults that volunteer their time to help set up the campgrounds. Campers may arrive on Saturday August 7, 2021 at the time slot they are allotted. No campers will be allowed to park unless a campground committee member is present. At the time of your arrival you will be given the campground rules. It is important for all families to follow this procedure so that camp spaces are used efficiently and safely. Failure to follow this procedure may result in the loss of your camping privileges at The Erie County Fair.

## **CAMPGROUND RULES:**

**At the direction of the New York State Department of Health and in order to maintain our operating permit, the following regulations must be implemented and adhered to at all times.**

- 1. A seven (7) foot separation between each unit/extremities MUST be maintained on all sides. This measurement is from the furthest extremity, slide out or other apparatus.**
- 2. No bonfires/campfires**
- 3. No open flames of any type, including propane grills, charcoal, cook stoves etc.**
- 4. No awnings are allowed in the down position**
- 5. Do NOT block the roadways with any personal vehicles**
- 6. All fire lanes must be maintained at all times.**
- 7. Speed limit is 5mph.**
- 8. No gray water dumping is permitted in any lot. (*Scavenger services are available by visiting the main office and paying for a pump-out*)**
- 9. Outside cooking is permitted in designated areas only and must be a minimum of twenty five (25) feet from any structure or unit.**
- 10. ALL units MUST have a fire extinguisher or method of fire protection available.**
- 11. Vehicles must have appropriate pass to be permitted in the RV Parking.**
- 12. No alcoholic containers are allowed outside of the RV's.**
- 13. Any child under the age of 18 must be accompanied by an adult at all times while in the RV Parking.**
- 14. Quiet hours are 11pm-7am**
- 15. All spaces MUST be pre-paid prior to arrival.**

**Failure to comply with these regulations will result in the loss of privileges and immediate removal of the unit.**

## **\*\*FOR 2021 4-H/Livestock Camper Lot\*\***

Gray Water Full? We Can Help!

1. All residents will be responsible to go the **Erie County Fair Main Office (Located behind Grandstands)- Agriculture and Competitive Exhibits Office** to pay for pump by 7PM the night before to get on the pump schedule for the next day. ***If not signed up by 7PM the night previous, you will NOT get pumped.***
2. When you come to the office you will need:
  - \$35 for the pump.
  - Camper license plate number.
  - Brand of camper
3. The pump truck will **only** pump those that have paid and are on the list provided by the Erie County Fair Main Office.
4. Payment per pump is \$35.00 ***No pumps will be completed without payment!***
5. No payments will be accepted at the 4-H/Livestock gate. All payments ***must*** go through the Erie County Fair Main Office.
