Bidders shall state whether the items and services proposed strictly meet these specifications and if not, they shall list each variation.



Cattle:

1. Approximately 800 tags
2. Visual printed with TSF, and last 4 digit tag number. No repeats in any visual number within the complete order.
3. Visual tag is to be large sized at approximately 3" high x 2 ¼" wide
4. Visual to be green in color with black lettering and numbering.
5. Packaged in numerical order.

Sheep/Goat/Swine:

1. Approximately 10,500 tags
2. Visual printed with TSF, and last 4 digit tag number. No repeats in any visual number within the complete order.
3. Visual tag is to be medium sized at approximately 1 ¼" – 1 ½" high x 1 ¼" – 1 ½" wide
4. Visual to be blue in color with black lettering and numbering.
5. Packaged in numerical order.

Samples: Sample of tags and packaging must be submitted with the bid.

Prices: Bids shall reflect total cost. No additional costs will be permitted. All bid prices must include freight prepaid and shipped to:
