Cattle:

- 1. Approximately 800 tags
- 2. Visual printed with TSF, and last 4 digit tag number. No repeats in any visual number within the complete order.
- 3. Visual tag is to be large sized at approximately 3" high x 2 1/4" wide
- 4. Visual to be green in color with black lettering and numbering.
- 5. Packaged in numerical order.

Sheep/Goat/Swine:

- 1. Approximately 10,500 tags
- 2. Visual printed with TSF, and last 4 digit tag number. No repeats in any visual number within the complete order.
- 3. Visual tag is to be medium sized at approximately $1 \frac{1}{4}$ " $1 \frac{1}{2}$ " high x 1 $\frac{1}{4}$ " – 1 $\frac{1}{2}$ " wide
- 4. Visual to be blue in color with black lettering and numbering.
- 5. Packaged in numerical order.

Samples: Sample of tags and packaging must be submitted with the bid.
