Specifications For Portable Yard Ramp(s)

INTENT: The Tulsa County Public Facilities Authority (TCPFA) is requesting sealed bids for the purchase of a new or used portable yard ramp(s).

PORTABLE YARD RAMP SPECIFICATONS: Vendors shall provide one (1) or two (2) new or used portable yard ramps for TCPFA. **Vendors must submit complete specifications of units and a list of any deviation in specifications.** Vendors may provide multiple options to be considered. Unit shall be equipped with the following:

Construction – All steel frame. Steel or aluminum decking.

Capacity – 20,000 lbs.

Width – 84" (78" Useable Deck)

Total Length – 36' (30' Incline, 6' Level-Off)

Service Range – Approximately 33" – 67"

Leveling Mechanism – Double acting Hydraulic Pump

Tires – Solid Rubber Pneumatic Profile Tires 18"

Safety Chains – Included

Mobility Tool – Ramp Clamp Included

Used units – must submit year ramp was manufactured

WARRANTY: Vendor shall furnish equipment warranty with bid.

PICTURES: Vendor shall provide pictures of all yard ramps submitted.

DELIVERY: Bid shall include price to deliver the yard ramp(s) to TCPFA at 4000 East 15th Street, Tulsa, OK 74112.
