## South 40 Trail – Official Rules

**IT IS THE ANGLERS' RESPONSIBILITY TO KNOW/BE AWARE OF ALL TOURNAMENT DEADLINES, RULES, AND REGULATIONS ASSOCIATED WITH THE TOURNAMENT. INTERPRETATION OF THESE RULES SHALL BE LEFT EXCLUSIVELY TO THE TOURNAMENT DIRECTOR. FAILURE TO COMPLY MAY RESULT IN DISQUALIFICATION. DECISIONS OF THE TOURNAMENT DIRECTOR ARE FINAL AND ARE NOT SUBJECT TO APPEAL. PROTESTS MUST BE MADE IN WRITING WITHIN 10 MINUTES OF THE OFFICIAL CLOSING OF THE SCALES AT EACH TOURNAMENT & PROTEST DEPOSIT OF \$100 MUST BE PAID AT THAT TIME. IF THE PROTEST IS UPHeld, THE PROTEST DEPOSIT WILL BE RETURNED TO THE PROTESTOR.**

### GENERAL RULES AND INFORMATION

- Registration Deadline: Registration for each stop will close prior to the start at the designated lake. A late fee may be applied. Each team must register in person at the designated site during official registration. A completed and signed entry form must be received, with full payment, prior to the registration deadline. Flight numbers will be randomly drawn at the draw party before each stop and the morning of each qualifying tournament in order of arrival. Flight number drawing will close 15 minutes prior to safe light, all entries received after cut-off will be placed in the first flight for check-in times but will take off at end of the line.
- Contestants may not enter or scout tournament waters or potential fishing waters after 11:59 p.m. the Sunday before each qualifier. Scouting includes any method of intentionally visiting the tournament water or potential fishing waters to gathering information about such waters. Shootout Championship off limits is the Sunday before the Shootout at 11:59 p.m.
- Tournament is open to all anglers except professional anglers. A professional angler is defined as: Any angler that has entered more than one bass tournament that required an entry fee greater than \$2,499 in the six months prior to the date of the Tournament.
- Licensed guides that have guided on the body of water in the previous 14 days will not be allowed.
- All contestants must have a valid fishing license on their person.
- Official Checkpoints: There will be only one official checkpoint used for boat inspection in the morning and boat check-in in the afternoon. Failure to go through the official checkpoint in either the morning or afternoon will result in disqualification from the event. During morning check-out, all teams are required to idle a minimum of 100 yards before putting the boat on plane. It is the sole responsibility of each contestant to arrive at the official checkpoint on time. Regardless of what you are told or understand, it is the angler's responsibility to verify their provided flight card time. All fishing must cease upon check-in, or upon such other time as may be designated by the Tournament Director.
- Fishermen will start in sequence based on their drawn number. Flights for weigh-in will be 25 per flight every 15 minutes starting at 3 p.m.
- Competitors not at the official checkpoint at the designated time will be penalized at the rate of .1 pound per minute, deducted from the total weight for the day. Any team more than 15 minutes late for weigh-in will be disqualified without recourse.
- Contestant must leave and return to the check in by boat.
- Contestants boats must remain in the tournament waters during the event. In the event of a mechanical breakdown, there are two permitted methods of returning to the check in; by remaining in the boat and being towed by water, or by entering the boat of another competitor. In the event of a breakdown, the contestant should immediately contact the Tournament Director.
- In the event of severe weather or location limitations, alternate take-off and check in instructions will be given at the registration site and draw party, at the sole discretion of the Tournament Director. All boats must wait until the official first cast time designated by the Tournament Director and must stop fishing at designated time also determined by the Tournament Director. Contestants may launch their boat at a ramp other than the designated take-off location, but all Contestants must come through the official check-in locations before leaving to fish. The Contestants must return to the official check-in location by the methods set forth by their assigned check-in time to avoid late penalty. All trailering, other than the situations mentioned above, is not allowed.
- Contestants may launch their boat at any ramp on the designated lake, but they must come to the official checkpoint prior to leaving to fish.

- Teams may fish anywhere accessible by boat except areas designated as off-limits or within 25 yards of another team's boat anchored or not.
- Any team that allows any other team to fish within 25 yards of the team's boat has suspended the 25-yard rule and has opened the water to all competitors.
- Scales will close 30 minutes after the last flight is due in. This time may be lengthened/shortened at the Tournament Director's sole and absolute discretion.
- If one partner is unable to fish then you may fish solo.
- Polygraphs may be used.
- All Qualifying Fishermen must attend the mandatory meetings the Friday before the Shootout Championship and those that qualify after Saturday.
- Any change to the above stated official scale closing time will be announced during registration and boat check-out. It is the angler's responsibility to verify the official scale closing time and to be in the weigh-in line by such time.

### **SCORING & TIES**

- The pounds and ounces of each team's catch will determine tournament standings during the tournament.
- Only largemouth, spotted or smallmouth bass will be weighed.
- The limit shall be five (5) fish per team.
- Culling must be done immediately upon catching the sixth fish.
- The minimum official length will be 14 inches unless the lake limit is more than 14 inches, in which case the lake limit will prevail.
- A penalty of .5 pound will be deducted from the total weight for each short fish, plus loss of the small fish.
- A penalty of .25 pound will be deducted from the total weight for each dead fish.
- A team that presents more fish than the tournament limit will be disqualified.
- In case of a tie, combining awards and dividing equally among the tied teams will resolve positions.
- Trophy positions will be determined by a coin toss.
- If a team fishes a tournament but does not weigh-in a fish, they will receive 100 points. Team must participate (be on the water and fishing for a minimum of one hour) in the tournament to receive the points.

### **BOAT, MOTOR, TACKLE AND EQUIPMENT**

- Only artificial lures with the exception of pork rind may be used.
- Only one rod and reel combination may be used at one time. Trolling as a method of fishing is prohibited. All bass, large mouth, spotted and small mouth must be caught live and in a conventional sporting manner.
- All boats must have a properly accredited or re-circulation live well to maintain a live limit (5) catch of bass.
- Each boat must have all required U.S. Coast Guard safety equipment.
- Maximum horsepower for all outboards used in tournament competition may not exceed the horsepower limitations as set by the U. S. Coast Guard in such vessel.
- Falsifying information on entry forms or altering the horsepower numbers on the motor or rating plate to conceal such limitations will be cause for disqualification from the tournament.

### **SPORTSMANSHIP**

- All contestants will follow the highest standards of sportsmanship, courtesy, safety and conservation. Violation of this rule will be reason for immediate disqualification without recourse.
- No alcoholic beverages or non-prescribed drugs are allowed in the boat at any time.
- No alcoholic beverages may be consumed until after the official weigh-in has started.
- Drunkenness will be grounds for immediate disqualification without recourse.
- Each contestant must keep the waters clean and dispose of all trash in the appropriate trash containers.
- Switching or sharing fish with other teams or individuals is a violation of these rules and will result in immediate disqualification.
- All angling must be conducted from the boat. At no time may a contestant leave the boat to land a fish, or to make the boat more accessible to fishing waters.
- During tournament hours, contestants may not receive fishing information from non-competitors or participate in the practice of "hole sitting." The use of mobile communication devices such as cellular phones, marine radios, walkie-talkies, CBs, etc., to communicate information during tournament hours is prohibited.
- The act of moving bass from one area of the lake to a confined area of the same lake, whether or not during official practice days or competition days, is prohibited.
- Any violation of state, local, or federal laws will result in immediate disqualification without recourse.

## **SAFETY**

- Safe boating will be observed at all time.
- Each competitor must wear a serviceable U.S. Coast Guard approved life preserver (PFD) any time the combustion engine is in operation and until the combustion engine is shut-off.
- The boat operator must have a safety-stop switch (kill switch lanyard) attached to his/her person when the combustion engine is running.
- The driver must be seated in the driver's seat anytime the combustion engine is engaged in gear.
- Tournament days may be shortened or canceled due to unsafe weather or any conditions that would endanger the safety of the competitors at the Tournament Director's sole and absolute discretion.
- Competitors are allowed to leave the boat and seek shelter in bad weather, at which time no fishing may occur.
- Tournament Director reserves the right to place an official observer in a contestant's boat at any time during competition hours.
- In the event of an emergency situation, competitors should call 911 first, then notify tournament officials.
