- _____ I have not personally tested positive or knowingly been exposed to someone who has tested positive with COVID 19 in the 10 ten days prior to my arrival at the conference location.
- _____ I agree to self-assess and monitor my health each day while attending Conference activities.
- _____ I agree to immediately notify FFEA staff should I begin to exhibit any COVID19 symptoms including: fever, chills, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, diarrhea.
- _____ I understand that masks are required when at indoor FFEA functions within 6' of others, except when actively eating and drinking.

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be extremely contagious. Evidence has shown that COVID-19 can cause serious and potentially life-threatening illness and even death.

The Florida Festivals & Events Association (FFEA) cannot prevent you from becoming exposed to, contracting, or spreading COVID-19 while attending the FFEA Convention, August 24-26 at the Hyatt Regency Grand Cypress in Orlando, FL. It is not possible to prevent against the presence of the disease. Therefore, if you choose to attend the FFEA Summit and/or enter onto rented premises you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.

ASSUMPTION OF RISK: I have read and understood the above warning concerning COVID-19. I hereby voluntarily choose to accept all foregoing risks of contracting COVID-19 for myself in order to attend the FFEA Convention. These services are of such value to me that I accept the risk of being exposed to, contracting, and/or spreading COVID-19 in order to attend the FFEA Conference rather than arranging for an alternative method of enjoying the same services virtually. I accept sole responsibility for any injury to my myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my attendance at FFEA or participation in FFEA events ("Claims").
