## **RULES FOR FAIR GROUND USE**

- 1. <u>Sawdust</u> bedding only. (**NO STRAW**-Renter must furnish their own sawdust.)
- 2. Stalls must be kept clean.
- 3. Compost must be deposited in designated areas only-take compost <u>ALL THE WAY TO THE</u> <u>PILE</u>.
- 4. <u>One</u> animal per stall but goats are allowed in the upper barn on the south side and in lower barn, if confined to the stall area.
- 5. No dogs in upper barn.
- 6. No <u>studs</u> allowed through two (2) years old only as long as they are manageable but if they are a problem, the Fairgrounds Manager will ask them to leave.
- 7. All damages will be charged to the <u>damager</u>.
- 8. Community activities have **Priority**. (4-H events, sales, etc.)
- 9. No unattended animals on the grounds.
- 10. No livestock in area north of upper barn.
- 11. Fairgrounds Manager or Fair Board to issue all orders.
- 12. No Fair Grounds panels used outside.
- 13. For Barn Activities, contact Fairgrounds Manager. (Phone 406-778-2451)
- 14. Walkers at lower barn only.
- 15. Keep arena(s) clean when no in use (remove barrels, pulls etc.) and please clean alleyway between stalls.
- 16. One person to allocate stalls-Fairgrounds Manager.
- 17. For Safety Reasons (in case of fire) you cannot completely close space between stalls at the lower barn.
- 18. If you turn the side lights on, it is your responsibility to turn them off.
- 19. If you open an overhead door, it is your responsibility to close it.
- 20. **ANYONE** causing **ANY INTENTIONAL DANGER** to another person or animal at the barn will be asked to leave. The person or persons will be written up and **NOT BE ALLOWED TO USE THE BARN PERMANENTLY.**
- 21. <u>To Ride in Arenas & on grounds:</u> You are required to pay \$150 per person, per year, January 1 to December 31 of current year, children 18 and under will have no fee. Also, you must sign the Assumption of Risk Form/Arena User Information form and have on file at the fair office.

ANY EXCEPTION TO THESE RULES MUST MEET THE APPROVAL OF THE FAIRGROUNDS MANAGER AND THE FAIR BOARD. THERE WILL BE TWO WARNINGS AND ON THE THIRD WARNING, YOU WILL BE REQUIRED TO LEAVE.

## **BARN CALENDAR RULES**

Everyone who rides/ropes or works with their horses in the barn, on grounds and outdoor arena must sign an <u>Assumption of Risk/Arena User Form</u>.

To rope/ride in the barn you write your name on the calendar on the West wall in barn. If you are not able to make your time slot, please remove your name so that others may ride during that time.

If you do not mind other ropers in the barn while you just want to ride you do not need to write your name down on the calendar.

But if you want to rope/ride/do barrels or poles then please write your name in the time slot that you want, so others do not bring in their trailers, stock and must wait for you.

Please do not take more than 2.5 hours per day ~ there are a lot of riders in this area, so let us all be *considerate of others*.
