THE FAYETTE COUNTY FAIR ASSOCIATION WILL ACCEPT THE FIRST 10 CONTESTANTS THAT TURN IN THEIR **COMPLETED APPLICATION AND PHOTO** via email. Once the 10 spots for each division have been filled, there will be a waiting list created. You must pay an entry fee of \$20 at the interview to complete your application.

2022 Fayette County Fair Little Miss and Mister Contestant Rules

1. Contestant must reside in Fayette County, Texas, and must have been at birth, identified as a female to enter the Little Miss Contest or a male to enter as the Little Mister Contest; and be classified as a Kindergartener, 1st or 2nd grader in a Fayette County School or be Home Schooled with Fayette County in the 2022/23 school year. Contestant, if chosen as a contestant or member of court must remain enrolled as a student.
2. Contestant must in good standing within the community and school to promote a positive image, be in good health and have moral character.
3. The first 10 contestants in each division completing their form and photo will be accepted as a pageant contestant. All forms and photo must be scanned and submitted electronically to email: fcfqueentx@gmail.com
4. Contestant must return **Information Form and Photo** to be submitted to the newspapers no later than 4:00 pm on Friday, August 12, 2022 or prior to the first 10 spots in each division being filled to be considered as a Contestant. If you are contestant number 11, you will be placed as an alternate if any situation should arise for the first 10 contestants prior to the August 17th announcement.
5. An entry fee of \$20 is due at the personal interview on Sunday, August 28. This payment may be paid by cash, check or money order.
6. Photos to be judged in the "Little Miss and Little Mister Photogenic" contest must be submitted by 5:00 pm on July 25, 2022 (If another photo wishes to be submitted). This photo must be a **submitted to fcfqueentx@gmail.com**
7. Personal interviews will be conducted on Sunday, August 28 at the Fayette Co Ag Building (255 Svoboda Ln La Grange, TX) beginning at 1 pm, your child will be assigned a time via email. We encourage Formal/Semi-formal/Sunday attire dress.
8. **Awards:**
 - Little Miss and Mister Fayette Co-crown, sash, trophy, belt buckle
 - 1st Runner Up Little Miss and Mister -trophy
 - 2nd Runner Up Little Miss and Mister -trophy
 - Little Miss and Mister Photogenic- trophy
 - Little Miss and Mister Personality - trophy
9. Contestants and parents may attend the Fair Appreciation Kick off Dinner at the Fairgrounds on Sunday, August 28 at 6:00 pm. This is an optional event.
10. Pageant rehearsal will be held on Wednesday, August 31 at 6:00 pm.

11. The Fair Pageant will be held the evening of Thursday, September 1, beginning at 7 pm. Contestants will wait for the pageant to begin in an air-conditioned facility. After contestant's arrival, only touch-ups to hair and make-up will be permitted.
12. We understand that the Royalty Court are expected to participate to the fullest extent possible in the parades and public events scheduled for the Fall and Spring, Little Miss and Mister are to participate in the Fayette County events (approximately 7 parades for the year) but welcomed to attend any of the 20 parades throughout the year. In each event, the participant must dress appropriately and wear the proper attire. Should the expected participation be difficult or impossible due to intervening factors, the Pageant Chairperson shall be contacted at the earliest opportunity.
13. If for any reason should the Little Miss or Mister not able to fulfill her/his duties in accordance to these rules and regulations, the 1st Runner Up shall be named winner and duly authorized to perform in this capacity.
14. We understand that the Fayette County Fair Association has no insurance coverage for health care or accidental injury to contestants, volunteers or family; nor liability coverage for any acts of contestants, court, volunteers and family.
15. To the extent provided by law, contestant, court, parent(s), and guardian(s) release, indemnify, and hold harmless the Fayette County Fair Association from any damage or injury to contestant, contestants, court, parent(s), and guardian(s), and volunteers while participating in furtherance of the contestant, court activities, and any damage or injury to others by such activities,
16. We consent to the use of the contest, photo, video, voice and biographic information for any Fair publicity, and the retention as an archive of Fayette County Fair Pageant history.

We and each one of us agree that the terms and requirements stated are fair and reasonable and each of us agree to abide by them.
